Bids will be opened in the County Commission Chambers at the above stated time and date. Time is of the essence in submitting bids and only sealed bids received in the commission office by the time listed above shall be opened and considered. Bidders and other interested individuals are invited to attend the bid opening.

Prospective bidders are instructed to read the General Terms and Conditions and Bid Specifications very carefully. Bid addendums will be provided to all bidders, if necessary. - All bids must be typed or hand-written in ink on the attached Bid Proposal Form. Please place the Bid Proposal Form in front of all other documents included in the bid packet. Bids submitted in pencil and bids not submitted on the Bid Proposal Form will not be considered. All corrections shall be initialed and dated by the bidder representative. Bids that are submitted without being signed will automatically be rejected.
- Bid envelopes must be sealed and must indicate clearly the appropriate bid number, bid item, and bid opening date, as indicated on the cover sheet of the bid packet. Bids by Facsimiles and emails will not be accepted. The County is not responsible for delays occasioned by the U.S. Postal Service, the internal mail delivery system of the County, or any other means of delivery employed by the bidder. Similarly, the County is not responsible for, and will not open, any bid responses which are received later than the date and time indicated above. Late bid responses will be retained in the bid file, unopened.
- The Commission provides equal opportunities for all businesses and does not discriminate against any vendor regardless of race, sex, creed, age, disability, national origin or religion in consideration for an award. Bidders must abide by the provision of the American with Disabilities Act of 1990 and assure that in connection with the performance of work under this agreement that they are an equal opportunity employer and do not discriminate on the basis of race, sex, creed, age, disability, national origin or religion.
- All bidders must comply with applicable sections of the Alabama Competitive Bid Law, Code of Alabama, 1975.
- **All bid amounts shall be submitted on the attached Bid Proposal Form.** Amount quoted shall be delivered prices, exclusive of all federal or state excise, sales, and manufacturer's taxes. The Commission will assume no transportation or handling charges other than specified in the bid.
- **A completed W-9 should be included with your bid package.**
- **A completed affidavit of compliance with E-Verify must be included with your bid package.**
- The Morgan County Commission reserves the right to cancel the contract with a 30-day written notice to the contractor if the performance of the service is unsatisfactory.
- These specifications and acceptance hereof, shall constitute exclusively and entirely the agreement for the service as described within.
- The attached specifications are being provided to potential bidders as guidelines, which describe the type and quality of equipment, supply, and/or service the Commission is seeking to purchase.
- By signing this contract, grant, or other agreement, the contracting parties affirm, for the duration of the agreement, that they will not violate federal immigration law or knowingly employ, hire for employment, or continue to employ an unauthorized alien within the State of Alabama. Furthermore, a contracting party found to be in violation of this provision shall be

deemed in breach of the agreement and shall be responsible for all damages resulting therefrom. Furthermore, this includes a representation that such contractor is not currently engaged in and an agreement that you will not engage in, the boycott of a person or an entity based in or doing business with a jurisdiction with which Alabama can enjoy open trade.

- All bids will be awarded to the lowest responsive and responsible bidder. This determination may involve all or some of the following factors: price, conformity to specifications, previous performance, facilities and equipment, availability of repair parts, experience, delivery promise, terms of payments, compatibility as required, other costs and other objective and accountable factors which are reasonable. The County has established a local preference zone within the boundaries of Morgan County. The County may award the contract to a responsible bidder whose bid is no more than 10% greater than the bid of a foreign entity if the bidder has a place of business within the local preference zone. The Commission reserves the right to accept or reject any or all items covered in the request, or any portion(s) thereof, waive formalities, re-advertise and/or take such other steps deemed necessary and in the best interest of the Commission. Bidders may be disqualified and bid proposals may be rejected for any of (but not limited to) the following causes:
 1. Failure to use the bid forms furnished by the Commission
 2. Lack of signature by an authorized representative on the Bid Proposal Form.
 3. Failure to properly complete the bid form.
 4. Failure to furnish performance bond, when required.

Inspection: Vendor must send representative to the Morgan County Jail to inspect location of equipment and ensure that all pieces will fit through the available doorways when being delivered and that existing electrical service is adequate for equipment being bid. A signed Certificate of Attendance will be provided after the site inspection and must be included with each submitted bid. Bids offered without this signed certificate shall be rejected. It must be indicated in the bid proposal that all equipment will fit through all needed doorways for bid to be accepted. It must be indicated in the bid proposal that existing electrical service is adequate for all equipment being bid for bid to be accepted. Please contact Kim Woodruff (256)616-6021 to schedule location inspection.

Freight: Bid proposal must include all freight charges for delivery to Morgan County Jail. The Morgan County Commission will assume no transportation or handling charges other than what is specified in the bid.

Installation: Bid proposal must include all charges to deliver equipment, uncrate, rig in place, bolt down and level. Vendor will be responsible for the removal and proper disposal of all delivery and packing materials. Vendor will also be responsible for the removal and disposal of the old equipment that is being replaced.

Service Plan: Any available service plans or maintenance plan costs that will enhance the longevity of the equipment needs to be included as an option. It will need to include the name of the Maintenance Vendor that will be doing the work if contracted out from the original Vendor. The plans need to include what services are performed at the time of maintenance and what the expected maintenance schedule be, (i.e., monthly, bi-monthly, quarterly, etc..). Bid may be awarded with or without enrollment in the offered plan.

Purpose of Form
