All bids must be signed by an authorized agent and submitted on the prescribed forms. Submission of bids by telegraph, telephone, or other electronic means is strictly prohibited. Any brand name called for in the bid specifications is provided as a reference only. Alternate brand name items offered for bid must be equivalent as to function, basic design, type and quality of material, method of construction, and any required dimensions. Bidder must attach a letter of exception to specifications.

Marked Units (3 sets)

All equipment listed needs to be compatible with a 2017-2018 Police Interceptor SUV,
unless otherwise specified.

Police Equipment:

All equipment listed below must be “New” equipment. “Refurbished” or “Used” equipment will not be allowed for installation per this equipment specification list.

All Robertson County Sheriff's Office reflective markings to include front hood, driver's side, passenger side and rear of vehicle per attached photos and specifications to fit Utility vehicle. All decals must match enclosed diagrams and photographs. Hood decals shall be centered on the vehicle. Sheriff's stars (hood and each side) should be cut out to show a white border between the star and stripes. The “Sheriff” lettering along the side of the vehicle should be outlined in the same fashion.

Federal Signal Valor Light bar – Model – VALOR SSP 3000, Number 4, 51”. LED Lights are to be Blue and White only, with Blue LED traffic advisor. (No red LED lights).

Smart Siren Package w/ PA System (Model – Platinum 2000) which works directly with Federal Signal Valor Light Bar package listed above, with minimum 100w “Whelen” weather resistant external speaker mounted onto front push bumper (listed below).

Go-Rhino Push Bumper with Blue LED lights installed on push bumper frame and wrap around kit that extends across and around the front of the vehicle, Whelen TIR3 type LEDs. (4 Blue LED lights 2 forward, 1 on each side)

Pro-Guard Cage behind Front Driver and Passenger Seats with 2 pc lower extensions behind driver and passenger seats, roll bar, sliding glass panel with expanded metal mesh insert or partition and Pro-Guard floor pan.

Pro-Guard Outboard Seat Belt set (reverse seatbelts for transportation of prisoners).

Install Pro-Guard rear passenger window interior guard bars on both rear driver's side and passenger side windows.

Pro Guard Plastic Rear Transport Seat with matching Floor pans and Rear partition to fit above listed Pro-Guard Cage. (Rear Partition must separate rear passenger seat compartment from rear cargo area using a poly window rear cargo barrier to prevent access of detainees from being able to reach equipment located in rear cargo area or escape.)

Havis Center Consol with arm-rest 21" with arm rest and cup holders – installed so not to interfere with the insertion or removal of shotgun or patrol rifle in center mounted gun lock (listed below). Must also accommodate all equipment (radio, smart commander center for lights siren).

Pro-Guard tactical vehicle gun mount with locks for Shotgun and Ar-15 style patrol rifle, mounted between front driver's seat and passenger seat behind center Havis consol. Pro-Guard gun mount needs to have "handcuff key" and remote electronic lock push button, which can be activated by officer. Remote electronic button needs to be concealed and not visible by detainees in rear seat.

"Ram Mount" spring adjusted computer mount with floor mounting bracket (passenger side). Ram Mount must include laptop adjustable support arm to secure laptop screen.

Minimum 800watt power inverter directly wired to vehicles battery with Blue Seas 100 AMP Circuit Breaker (Part#7177). (Auxiliary connections will not be accepted and inverter must have 2 standard 110 plugs.)

Additional 3 hole 12v lighter type plug power outlet to accommodate other devices. Outlet must be secured to vehicle or center console.

5.11 Duty Flashlight (Medium Size), complete with charger mounted to vehicle or to center console. (Flashlight model: 5.11 TPT R5)

Driver's side LED spotlight with rotational handle and arm (if not installed at the factory).

Tremco vehicle Anti Theft System installed

Stalker Radar – "dual" model, complete with front and rear antennae and remote

Kenwood Mobile "digital" radio, 35 watts or greater. (Nexedge NX800KPP). Antenna must be mounted in the center of roof, rearward of the lightbar using a small antenna. Radio system must have an external speaker mounted within front passenger compartment with microphone. Radio system should be wired to external PA / Speaker system to allow an officer to monitor the radio from the exterior of his patrol unit.

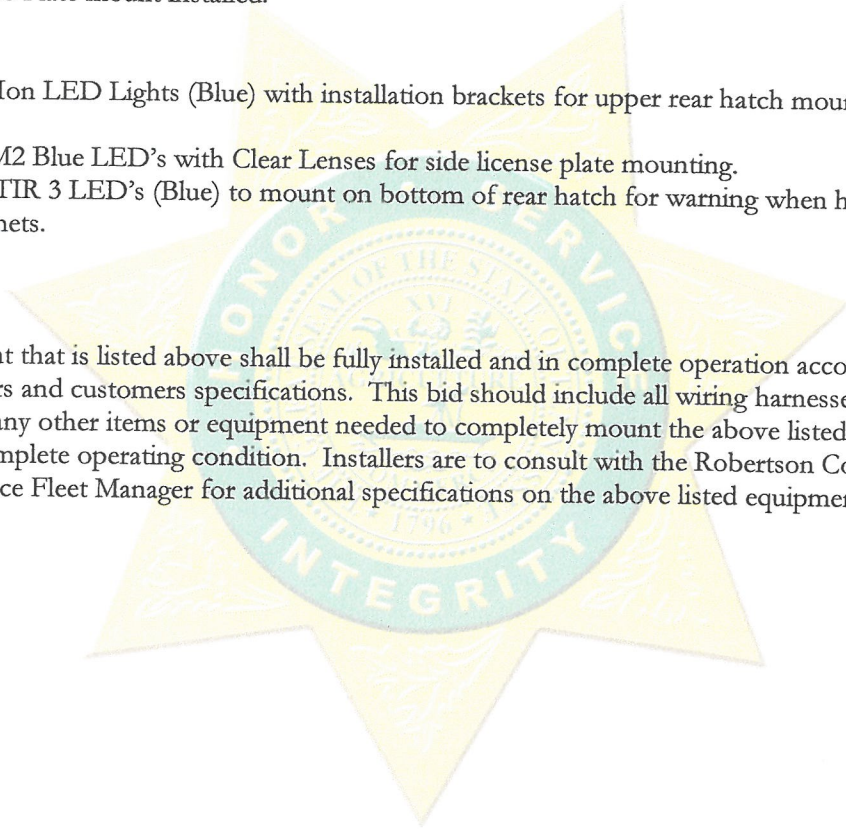
10-8 In-Car Video system, complete with Wireless Microphone, Display Unit, Remote Control and Power Supply/ Hard Drive Unit. Model 10-8 SD2+2 with rear camera and rear audio. Master Toggle Power Switch needs to be added to cut camera on/off manually via installed toggle switch.

Class 4 Receiver hitch assembly, with 4 pin plug. (Hitch system shall be hidden underneath rear bumper cover if applicable, and should include hitch bar with standard ball).

Front License Plate mount installed.

- (6) Whelen Ion LED Lights (Blue) with installation brackets for upper rear hatch mount area under spoiler.
- (2) Whelen M2 Blue LED's with Clear Lenses for side license plate mounting.
- (2) Whelen TIR 3 LED's (Blue) to mount on bottom of rear hatch for warning when hatch is open with grommets.

All equipment that is listed above shall be fully installed and in complete operation according to manufacturers and customers specifications. This bid should include all wiring harnesses, installation charges and any other items or equipment needed to completely mount the above listed equipment in vehicle in complete operating condition.
