**Question 3:** What department(s) (e.g. IT, CTE, etc.) will be responsible for upkeep and maintenance of the solution and has your institution identified potential System Administrators?

- **<u>Response 3</u>**: The winning bidder company will be responsible for upkeep and updates to keep the system current.
- **Question 4:** Is there any internship application process or are students just selecting their interest in internship opportunities via the job board?
- **Response 4:** The application process is separate from this app.
- Question 5: Will the database solution require industry partner management engagement? (e.g., industry partner communications, data, history of engagement, etc.)
