The Jones County Board of Commissioners is accepting bids for the purchase of seven (7) 2021 Dodge Chargers - Pursuit Edition. These vehicles will be used by the Jones County Sheriff's Office.

The vehicles proposed by vendors shall be new and from the most current model year.

In addition to the make and model specified above, vehicle quoted by prospective vendors should meet the following minimum specifications in the bid form.

Vendors should submit complete specifications on the vehicles that are proposed covering both the items on the bid form sheet and any other features that the vehicle may have.

Vendors should also submit detailed warranty information on the vehicle.

As time is of the essence with this solicitation, vendors are also asked to submit the date the vehicles would be available for delivery or pickup.

Vendors must provide affidavit verifying status for County Public Benefits and Contractors E-Verify Affidavit with the submittal of the bid as applicable (see attached).

Terms and Conditions

- The County reserves the right to reject and or all bids or proposals, to waive technicalities, and to make a selection and final award as deemed to be in the best interest of the County.
- Provider selection will be based on the information contained in the bids, and incomplete or inaccurate information may result in disqualification of a proposal or a bidder.
