Specifications for Right-of-Way Maintenance and Bid Sheet For the City of Goodlettsville

Work consists of mowing, trimming, and herbicide application to public rights-of-way and City-maintained property at various locations within the corporate City limits of Goodlettsville.

All bidders must complete a pre-bid field inspection, by appointment only, of all subject areas under the guidance of the Public Works Department by calling (615) 859-2740.

Sealed bids are due Tuesday March 15, 2016, by 2:00 p.m. CST. Delivery address: Purchasing Director, City of Goodlettsville, 105 S. Main St., Goodlettsville, TN 37072.

Mowing is to include the cutting of sidewalk boundaries, shrub bed exteriors, and open grass areas (certain areas to be mowed will be a minimum of fifteen feet (15') from curb*). Trimming is to include edging (weedeating) of sidewalk edges, around utility poles and guy wires, street signs, shrub bed borders, guard rails, street and fence borders. Herbicide applications to include the spraying of concrete sidewalks and medians and guarantee a 95% kill with season-long control.

Vendors bidding for herbicide/pesticide application must be currently licensed and chartered for right-of-way application by the Tennessee Department of Agriculture and shall submit copies of State of Tennessee Category C3, C6, and/or HLT licenses and company charter with bid. No subcontractors are allowed.

Pick-up and removal of litter is required prior to work commencing. Grass clippings must not enter onto roadways or sidewalks.

Vendor must furnish certificates of insurance for General Liability in an amount not less than one million dollars (\$1,000,000.00) per occurrence and Worker's Compensation as required by Tennessee State law.

Vendors must furnish a minimum of three references from similar agencies (two must be from governmental agencies), a list of equipment and materials, staff qualifications and number of staff assigned to each bid unit and the company's estimated workload for 2016.

The frequency schedule may be adjusted due to weather conditions.
