NORMAL HILLS APARTMENTS APPLIANCES SPECIFICATIONS

1.1. The Purpose Alabama A&M University (AAMU) hereby solicits submissions of a competitive bid, from qualified Respondents to provide household kitchen appliances for AAMU the items described herein, all in accordance with the terms and conditions detailed herein.

It's imperative for the bidder to read and understand this entire specifications package prior to submitting a bid. The bidder is required to examine the specifications, instructions, and risk to be covered. Failure to do so will be at the bidder's own risk. No warranty is made or implied as to the information contained herein.

1.2 MINIMUM QUALIFICATIONS

This section identifies the Minimum Qualifications for bidding Vendors and requires specific response and affirmation in the bid. The AAMU requires partnering with a vendor team that has a proven track record through demonstrated experience in providing similar products as listed in the Scope. The Minimum Qualifications of this bid require that the Proposer must:

- A. The bidder, in the capacity of a wholesaler or retailer, must have been in business providing the same or similar products for at least two (2) years.
- B. AAMU require the manufacture of appliances to be provided to be in business manufacturing appliances for not less than ten (10) years and have a readily available supply of parts that can be procured through nationally recognized parts distributors.

1.3 SCOPE

- A. The successful bidder will be required to stock and deliver appliances to multiple areas during construction.
- B. Vendor should provide the appliances shown below or an approved equal. Vendor shall include with bid appliance specifications if different from appliances listed. AAMU reserves the right to reject any bid if it deems necessary whereas the appliance does not accommodate our needs.
 - a. (47) GE 30in, 19.2 cuft top freezer refrigerator in white, model no. GTS19KGNRWW without ice maker
 - b. (60) GE Freestanding 5.0 cuft electric range, white, model no.JBS160DMWW, with 50A-120V/208V-3 pole, 4 or three wire electric cord to fit #14-50R receptacle.

- C. Vendor shall include delivery and set up only. And removal of old appliances.
- D. Vendor shall be expected to deliver appliances after October 1, 2024 and no later than October 15, 2024.
- E. Vendor shall supply all necessary equipment accessories to make the appliance fully operational. i.e. pigtails etc..
- F. Appliance will carry a minimum one-year warranty that will provide a replacement appliance if repeated issues relating to health, safety, or performance occur.
