The scope of work shall consist of two separate operations including but not limited to the following:

This project consists of the installation of Green Infrastructure (GI) practices within the rights-of-way (ROW) of the 3900 block of Sunbeam Avenue from the intersection of Belvoir Avenue northwest to Gardner Street. This will include the demolition/removal of existing roadway and infrastructure followed by installing the following practices; series of infiltration trenches, pocket water quality basins, and a sequence of water quality swales. This water quality GI system will capture and infiltrate the stormwater runoff along with providing overall volume reduction of sediment/pollutants from entering the receiving streams.
