- 1. Construct Fireplace and chimney per drawing
- 2. Apply STUCCO with metal lath on CMU wall types 2A & 3A in lieu of painting wall.
- 3. Install (1) overhead ceiling fan
- 4. Delete construction of new brick/CMU piers from scope of work, including metal coping and flashing at the top of piers.
- C. Project is in flood zone- building is designed with wet flood proofing including: Class 4 & 5 flood resisting material, flood vents in walls at toilet rooms, mechanical and electrical systems are raised above BFE + 2', sanitary line has shutoff valve to prevent backflow.
