## Addendum No.1 Questions and Answers

Whitlock Flexible Learning Center Selective Roof Replacement and Selective Exterior Wall Repairs

1. Question: Are all units to be raised to allow for minimum base flashing height of 8" inches from the finish roof membrane?

Answer: Yes, all units shall be raised to obtain the required flashing height.

2. Question: Is taper insulation required ?

Answer: Secondary taper at crickets and roof drain sumps. At roof area F, full taper insulation system to be provided at 1/8'': 12". See roof plan attached to addendum no.1

3. Question: Are all abandoned curbs to be removed.

Answer: yes, with decking properly repaired.

- Question: What color is to be used for sheet metal?Answer: color shall be chosen by Owner at later date to match existing.
- Question: Are all roof drains (bowls, clamping rings, strainers, bolts, and ferncos to be replaced with new) Answer: Yes, heavy duty multiple tightening bands to be installed.
- Question: If the alternate for PVC is acceptable is Sarnafil S327 acceptable? Answer: Yes.

- 7. Question: Are new wood nailers required throughout?
  - Answer: Yes, at all terminations and penetrations and roof edge to match insulation height and is to be included in the bid provided.
- 8. Question: Is foil-surfaced face base flashing (Veral) to be installed with the modified bitumen roof system installed.


Answer: Yes.

9. Question: Is a licensed electrician and or plumber to be used and coordinated by the Contractor for any HVAC work to raise units and any plumbing work at roof drains?

Answer: Yes.

- 10. Question: How is material cost to be addressed in regard to price escalation?
  - Answer: All Contractors shall prepare bids based on cost increases to date and provide bids based on anticipated cost increases for when material will be delivered to the project site location. The Owner will not be providing an allowance for material cost increase at the time of delivery.
- 11. Question: Is the awarded Contractor required to submit a Certified Pay Roll for Employees?
  - Answer: The awarded Contractor is subject to submit a Certified Pay Roll if requested by the Owner at any time during the course of the project.
