RECEIPT OF PROPOSALS

Sealed Proposals for the construction of the Wastewater Treatment Plant Miscellaneous Improvements will be received at the office of the City of Lebanon Public Services Commissioner, City of Lebanon Administration Building, 200 North Castle Heights Avenue, Suite 300, Lebanon, Tennessee 37087, Attention: Mr. Jeff Baines, on or before 2:30 P.M. local time on Tuesday, May 19, 2020, and immediately thereafter all bids will be publicly opened and read aloud.

The project will include the following described construction:

Miscellaneous Improvements to the Lebanon Wastewater Treatment Plant, including: ultrasonic flow meters for the raw wastewater, return activated sludge, and waste activated sludge lines; furnishing and installation of magnetic flow meters for the effluent force main; rehabilitation and cleaning of two influent gates; removal of two existing and installation of two new raw wastewater pumps to be provided by the Owner; furnishing and installation of a replacement motor for one raw pump; furnishing of a shelf spare sludge thickening pump; replacement of the roof on the existing Lebanon WWTP Administration Building; furnishing and installation of dissolved oxygen (DO) and oxygen reduction potential (ORP) probes; removal of existing casework and the installation of new casework and flooring in the existing Laboratory in the Administration Building; furnishing and installation of a new concrete Dump Pad, including approximately 80 feet of gravity sewer line and related manholes; along with other minor work and incidentals.

A deposit of \$125.00 must be made for each set obtained. The deposits of all bidders, except the successful bidder, will be refunded without any deduction upon return of the Bid Documents (drawings and specifications) to Water Management Services, LLC in good condition and within 15 calendar days subsequent to the opening of bids. Non-bidders and bidders who have taken out additional sets will be refunded \$100.00 under the same conditions of return. No refund will be made for documents received after this fifteen-day period.

A mandatory prebid conference will be held at the Lebanon WWTP on Thursday, May 7, 2020, at 10:00 am CDT. The physical address for the wastewater treatment plant is 321 Hartmann Drive, Lebanon, TN 37087.
