- Perform marketing in the Florence County community through public service announcements, social media, and other outlets. The marketing should detail how, when and where their used cooking oil can be dropped off, as well as educating the public on why it is harmful to the environment and leads to expensive filtration processes when it is disposed of down the drain, in landfills, or other unauthorized locations.
