1.0 PART I: BACKGROUND

1.1 Background

The Broward County Housing Authority ("BCHA"), on behalf of Building Better Communities (BBC), a 501[c][3], is interested in the review and selection of a firm or firms interested in serving as a Co-Developer partner to BBC and requests the submission of qualifications for consideration. The BCHA is a public housing authority ("PHA") created pursuant to Chapter 421.

BBC desires to develop a mixed income community with additional housing opportunities that include low and moderate-income residents of Broward County located in South Florida. It will leverage access to land and proximity to healthcare and highway systems in the Deerfield Beach area of Broward County in a public/private partnership with a qualified Co-Developer.

BBC will consider utilizing multiple debt and equity instruments including tax exempt bonds, low income housing tax credits, mortgage financing, limited partnerships, HOME funds, SHIP funds and public/private collaborations as its principal forms of financing to develop additional affordable housing and also address other income ranges up to 80% of the Area Median Income. A major role of the selected Co-Developer will be to identify adequate development funds from available sources and to provide guarantees during the development period.

The BCHA has procured TAG Associates, Inc. ("TAG") as the Development Advisor to the BCHA and will be assisted by TAG in this procurement for a Co-Developer.

1.1.2 Request for Qualifications

The BCHA is inviting qualifications from experienced developers to participate in the development activities as described herein. The BCHA's development activities may utilize a mixed-finance methodology resulting in a viable mixed income residential community containing affordable housing, which includes elderly and family units.

In keeping with the BCHA's current development plan, the BCHA is considering new construction as the method to provide housing on the sites mentioned in this RFQ.

1.1.3 Tallman 3

Under consideration for this RFQ are the following vacant sites which are encumbered by a HUD declaration of trust and are owned by the BCHA:

Tallman III Site: Two sites – Site 1: Broward County Property Appraiser parcel number is # 4842132000010. Property is cleared.

The BCHA seeks to develop at least 50 elderly units on Site 1, in a single mid-rise building, and at least 50 family units on site 2, of which the overall configuration is still to be determined.

The BCHA wishes to encourage high quality architectural design for all work which will revitalize the area. The developments will provide amenities commensurate with market rate properties in accordance with state and local ordinances and any requirements of applicable funding applications. These amenities may include a clubhouse, pool, business center, laundry facilities, etc.

The BCHA seeks to incorporate Green Building techniques, increase community safety through environmental design, including ample green space and parking in the design.

2.0 PART II: SCOPE OF SERVICES

2.1 Scope of Work

The selected Co-Developer would act in a full-service capacity, advising the BCHA on the redevelopment of the Tallman Pines III site. This will include programs of work involving the development of affordable housing assets designed to provide long lasting affordability at this site and other product mixes that would produce the optimal financial return from operations to sustain the affordability and capital improvements of low or moderate-income housing in perpetuity.

2.1.2 Responsibilities of the Co-Developer will include:

- Identify and apply for project funding, as needed.
- Provide development and operating budgets
- Work with an architect on undertaking and conducting environmental and geotechnical testing and an analysis of the condition of existing utilities at the site.
- Work with an architect on a plan including street layout and common area facilities based on the Master Plan.
- Design and construction of all infrastructure and site improvements.
- Providing opportunities for training and employment of Section 3 individuals wherever possible.
- Providing opportunities for participation by D/M/WBE and Section 3 firms throughout the development by making efforts for the D/M/WBE and Section 3 requirements set forth on Exhibit B to this RFQ are satisfied wherever possible.

- Develop a construction strategy and a development implementation schedule.
- Work with the BCHA and its development & financial consultant ("TAG Associates, Inc.") to create detailed development and operating budgets. The selected Co-Developer will be required to expand and to update the budgets throughout the development process.
- Provide regular monthly reports to the BCHA on the progress, material selections, and means of construction to include all development efforts, and work already completed that reflect associated costs, schedule, and budgetary requirements.
- Work with the BCHA and its legal team to create an ownership structure for the development which will include an affiliate of the BCHA as a general partner or managing member. It is expected the Co-Developer affiliate will exit the GP at the end of the development obligation period.
- Obtain financing, through the use of Low-Income Housing Tax Credits ("LIHTC"), HOME Funds, Community Development Block Grant Funds, State Housing Initiatives Partnership ("SHIP") program funds, State Apartment Incentive Loan ("SAIL") program funds, and other public or private funding sources, to develop the property.
- The Co-Developer shall guarantee to BCHA the lien free completion of construction of the Development in compliance with the Development Schedule and the Development Budget. The Co-Developer, and not BCHA or any BCHA affiliate, shall be responsible to the LIHTC investor for all construction cost overruns, timely completion of construction or the recapture of any LIHTCs.
- The Co-Developer shall provide all guarantees required by the LIHTC investor and any lender.
- The Co-Developer shall be responsible for any adjustment to the equity provided by the LIHTC investor arising out of an adjustment in basis, or timing or delivery of units.
- Oversee the design, construction, and quality control of the development.
- Procure the construction contractor.
- Select subcontractors.
- Provide all required operating and financing guarantees to the BCHA and other lending institutions.
- Obtain all required building permits and zoning approvals.
- Work with the BCHA and its staff, as applicable, to undertake all marketing and lease up efforts.
- Attend meetings with residents, Local Government, and Community.

The selected Co-Developer will cause the formation of a separate owner entity to manage the Development. BBC or an affiliate will be a general partner or non-managing member of such owner entity. BBC will have the option to replace the Co-Developer or its affiliate as the managing general partner or managing member following project stabilization. BBC will also have the option, but not the requirement, to become the management agent for the Development at any time following project stabilization. Such rights shall be set forth in the Partnership Agreement or Operating Agreement of each owner entity.

Additionally, BBC shall have an option and right of first refusal to acquire the Development in the event a bona fide offer to purchase the Development is received by the owner entity or at any time after the expiration of the LIHTC compliance period. Such right and option

shall be for a purchase price equal to the minimum required pursuant to Section 42 of the Internal Revenue Code.

2.1.3 Minimum Qualifications

Co-Developers must have, or within its team provide, the following:

- Experience developing communities that contribute meaningfully to their neighborhoods.
- Experience developing, constructing, and operating affordable housing.
- Experience in Green Building techniques.
- Experience developing housing for families, the elderly, and the disabled.
- Experience in site preparation and infrastructure development.
- Expertise in regulatory compliance issues.
- Expertise with Housing Choice Vouchers, other HUD funding (HOME, CDBG, etc.) and FHFC and County funds including 4% and 9% LIHTC and bonds
- Expertise with local government authorities which regulate the permits and utilities necessary for the Revitalization.

2.1.4 Compensation Qualifications

As a Co-Developer with the selected party, BBC expects to receive a share of all fees including development fee, property management fees, asset management fees, incentive management fees and cash flow. At a minimum, BBC expects at least a 25% share of Developer fee, 50% of all other earnable fees (e.g. asset management, incentive management, construction cost savings, etc.) and 50% of cash flow, unless and until the Co-Developer affiliate exits the project.

3.0 PART III: SUBMISSION

3.1 Response Due Date

Responses must be submitted by **3:00 p.m.** on **February 12th**, **2019** to be eligible for consideration. Respondents should make early submission of the materials to avoid any risk of loss of eligibility brought about by unanticipated delays or other delivery related problems. Facsimile and e-mail responses will not be accepted. Responses received after the deadline for receipt will be deemed unresponsive and will be disqualified.

3.2 Receipt of Responses

An original and five (5) copies of the response to this RFQ shall be submitted in sealed packages and marked "Request for Qualifications for Co-Developer for Redevelopment of Tallman III". Only one set of audited financials per submission is required and should be in a separate envelope contained within the original submission. All material must be submitted in an 8 ½" x 11" format. The BCHA reserves the right to reject any or all responses wherever it is in the best interest of the BCHA.

All RFQ submissions will be opened after 3:00 pm on the 12th of February 2019.

3.3 Master Plan

BBC's s vision for Development is to create a vibrant, attractive, community, where people from a range of economic strata, races and cultures will live, learn, work, and play in close proximity to employment, retail, and cultural opportunities

3.4 Scope of Services

The BCHA's goal is to have the development of Tallman Pines III proceed as expeditiously as possible. Responses that demonstrate an ability to complete Developments on the earliest possible, realistic schedule will be favorably received by the BCHA. The Respondent shall certify its ability to start work immediately, and should propose a staffing plan that describes the existing time commitments of the staff proposed to be assigned to the project and whether any of the staff will be locally based.

This RFQ is intended to procure a Co-Developer for Development. Respondents are encouraged to present to the BCHA a complete team, including the trades, Architectural & Engineering, legal representation, and other team member deemed critical to timely completion and post stabilization transition required for the success of the Development.

3.5 Instructions to Respondents

3.5.1 Submission and Content of Responses

Inquiries: The intent of this RFQ is to establish the general Scope of Services needed and to provide prospective Respondents with sufficient information to enable them to provide an acceptable response to this RFQ. Every effort has been made to outline requirements, and to provide information in a format that is clear and concise. Nevertheless, questions may arise, or additional information may be needed. Site Visit: A site visit to the sites will not be scheduled. The vacant sites may be visited without appointment.

All inquiries must be in writing and received according to the instructions above no later than 4:00 p.m. EST, on January 02, 2019.

Answers will be provided via the BCHA website www.bchafl.org and on Onvia DemandStar website www.demandstar.com. Questions will not be accepted via telephone. Responses to questions shall be made via the form of addenda and/or a Questions and Answers (Q&A) format no later than 5:00 p.m. on January 04, 2019.

3.5.2 Submission Requirements

Responses that do not include all required information will be deemed unresponsive and may be disqualified.

Submissions must comply with the requirements of this RFQ. The completed and signed off checklist attached to this RFQ is a mandatory submission requirement.

No qualifications shall be withdrawn for a minimum period of ninety (90) days following the qualifications deadline without the consent of the BCHA.

Disadvantaged, minority and women-owned businesses are encouraged to respond to this solicitation.

Respondents must address their plan to meet the specific requirements of the Scope of Services by including, at a minimum, the following:

a. Letter of Interest: Respondent's submittals shall be accompanied by a Letter of Interest on the Respondent's letterhead. This letter should include the Respondent's statement of understanding for the scope of work outlined in this RFQ, the commitment to perform the work expeditiously, a brief statement indicating why the Respondent believes itself to be best qualified to perform the engagement, and a statement that the response is firm and irrevocable for ninety (90) days.

b. Respondent's Qualifications:

The Respondent shall submit the following information within the qualifications:

3.5.2.b.7 Financing Experience

Describe new and innovative financing techniques for raising capital that the Respondent has employed. Describe Respondent's approach to managing the financial risk associated with affordable housing development.

In the event tariffs; lower than anticipated equity prices; construction or permanent loan interest rate rises stand to impact design, finishes, amenities, or reasonably anticipated fifteen year operating projections, please indicate those concerns and the ability to cure, preserve quality, and successfully close.

Demonstrate that the Respondent possesses an understanding of state and local requirements and procedures that will enable necessary equity to be raised and the effort to be efficiently completed.

Describe the financing strategy of the Respondent and the proposed methods that will be utilized to identify and obtain the maximum financial funding needed to complete the development effort while minimizing the amount of BCHA funds required to successfully complete the project. Respondent shall provide their approach to the division of work and responsibility between them and the BCHA, as well as their requirements with regard to advance funding, compensation and similar issues. The BCHA is interested in a financial structure that allows it to participate in the financial benefits of the development.

- **c. Proposed Development Methods and Strategy**: Provide a narrative description of the Respondent's methods and strategy for the development of this project. Illustrate this approach with descriptions of up to four such developments, including one well established development and one recently completed development.
- **d. Utilization of Disadvantaged ("DBE"), Minority ("MBE") and Women ("WBE") Business Enterprises**: Describe Respondent's approach and process to promote DBE, MBE, WBE, and Section 3 business participation in the development effort, *wherever possible*. Respondent must show proof of a good faith effort to obtain 20% minority participation in the execution of the development effort. The Respondent must comply with the requirements set forth on Exhibit A. The requirements set forth on Exhibit A must be addressed with the Respondent's responses to this RFQ.
- **e. Understanding Local Requirements**: Demonstrate that the Respondent possesses an understanding of local (County and City) requirements and procedures that will enable the effort to be efficiently completed.
- **f. Project Budget**: Propose a budget for predevelopment and development activities and the source of payment of such fees and sharing of costs.

3.5.3 Evaluation Factors

A committee will evaluate the qualifications received under this solicitation in accordance with the minimum information requirements and the Qualifications Preparation and Submission Outline below. The evaluation process will be based on a weighted point system with the evaluation factor or sub-factor's relative weight listed immediately following each factor/sub-factor. The BCHA urges all interested Respondents to carefully review the requirements of this RFQ.

All submissions will be evaluated by an Evaluation Committee comprised of consultants and staff. Written submissions containing the requested information will serve as the initial basis for the evaluation of responses. Each written qualification has a possible score of one hundred (100) points as set forth in Section 3.5.3.a.

A short list of finalists will be established based upon the written submissions. Interviews may or may not be conducted with the finalists. The interviews of the finalists will be used to further evaluate the respondents and ultimately identify the top-rated Respondent utilizing the same point system as described in Section 3.E.3.a. The finalists may be required to present their qualifications to the BBC Board of Directors and respond to inquiries that may be central to the preparation of a Master Development Agreement.

The initial rankings following the review of written submission will be used to establish finalists for interviews. Following interviews, all finalists shall be fully reviewed, taking into account all information from both the written submissions and interviews. The Evaluation Committee shall then meet and discuss the Respondents and come to a consensus ranking based on the criteria set forth in Section 3.5.3.a.

Following the Evaluation Committee review of written submissions and interviews, if any, the consensus ranking shall be provided as a recommendation to the BBC Board of Directors for approval. Upon BBC Board approval, BCHA will enter contract negotiations with the highest ranked Respondent. If negotiations between the BCHA and the highest ranked Respondent fail to produce a mutually acceptable Master Development Agreement, the BCHA will terminate those negotiations and proceed with contract negotiations with the second highest ranked Respondent. At the BCHA's sole discretion, the BCHA may continue that process until a mutually acceptable agreement is reached between the BCHA and a Respondent.

The BCHA reserves the right to reject any and/or all qualifications.

The BCHA further reserves the right to negotiate with the Respondent selected and to accept the qualifications which is in the best interest of the BCHA as determined by BCHA.

In the event that after selection of a Co-Developer a Master Development Agreement cannot be reached, BCHA reserves the right to move on to negotiations with the next highest rated bidder.

a. Qualifications Preparation and Submission Outline

Firms shall submit qualifications in accordance with the following outline to receive the maximum points (100) under this solicitation. Items which are not addressed within the qualifications will be given a score of zero (0).

1.1	Evidence of the Respondent's ability to perform the work as indicated by profiles of the principles and staff and team members and explanation of their professional, technical competence and relevant experience with projects of similar size and scope. Please identify which team members will be assigned to this project.	20 points
1.2	Qualification of key personnel, location of staff, and resumes, including the firm's capacity as it relates to size and available resources to complete the development.	15 points
1.3	Firm's proposed project approach and demonstrated ability to meet established deadlines.	15 points
1.4	Demonstration of the Respondent's financial capacity and ability to provide guarantees and adequate assurances for completion of the development.	20 points
1.5	Responses to Exhibit B-2 a through e	15 points
1.6	Provide evidence of demonstrated knowledge and familiarity of applicable governmental regulations and codes as required by the U.S. Department of Housing and Urban Development, State of Florida, Broward County and any other agencies having authority or jurisdiction.	5 points

Firms that will be relying on subcontractors to increase their point scores for specific expertise must provide a <u>Profile of Firm form for each subcontractor</u>. It is expected that these subcontractors will be a part of the team for the duration of the contract. This form is not applicable to the overall development team participants which include Property Management Companies, General Contractors, Attorneys, Architects or Engineering Firms

unless that participant has explicit expertise that the respondent is wanting to acknowledge and receive consideration for.

4. <u>Acknowledgement of Amendments</u>

The Respondent shall acknowledge in its response to this Request for Qualifications, receipt of any amendment(s) or FAQs presented on the BCHA website. The Respondent's failure to acknowledge an amendment may result in rejection of the response.

5. Complete and Accurate Submission

A Respondent's failure to provide accurate information in response to this Request for Qualifications may disqualify the Respondent from further participation in the selection process.

Qualifications may be corrected, modified, or withdrawn, provided that the correction, modification, or request for withdrawal is made by the Respondent, in writing, and is received by the Broward County Housing Authority; prior to the date and time designated in the RFQ for final receipt of submissions. After such date and time, the Respondent may not change any provision of its qualifications in a manner prejudicial to the interest of the BCHA and/or fair competition. Respondents are solely responsible for ensuring timely delivery by courier services; The BCHA will not accept any responses to this solicitation, after the final deadline, due to Respondent's misunderstanding of courier service hours and delivery times.

6. Retention

All submissions are the property of the BCHA and shall be retained by the BCHA. Responses will not be returned.

7. Cancellation/Waiver

The BCHA reserves the right to cancel this RFQ or to reject, in whole or in part, any and all submissions received in response to this RFQ upon its determination that such cancellation or rejection is in the best interest of the BCHA. The BCHA further reserves the right to waive any minor informality in any submissions received, if it is in the public interest to do so. The decision as to who shall receive a contract award, or whether or not an award shall be made as a result of this RFQ, shall be at the absolute sole discretion of the BCHA. In addition, multiple awards may be made.

8. Key Personnel

The key personnel specified by the successful Respondent will be considered essential to the work to be performed by the successful Respondent. Prior to diverting any of the key personnel for any reason(s), the contractor shall notify the

BCHA in writing, at least thirty (30) calendar days in advance, and shall submit justification (including proposed substitutions) in sufficient detail to permit evaluation of the impact on the contract. The firm shall not change key personnel or hours to be devoted, before or after contract award, without written permission from the BCHA.

9. Part of Contract

The contents of the documents submitted by the successful Respondent may become part of any contract award at the sole discretion of the BCHA.

10. No Compensation for Response

Respondent will not be compensated for work or costs related to preparation and submission of this qualification. Respondents selected for further interviews and negotiations will be responsible for all expenses incurred during these processes.

11. Compliance with Law

Use of Disadvantaged Business Enterprises (DBEs), Minority Business Enterprises (MBEs), and Women's Business Enterprises (WBEs)

A. REQUIRED EFFORTS

- 1. Consistent with Presidential Executive Order 11625, 12138, and 12432, and Section 3 of the HUD Act of 1968, the BCHA shall make efforts to ensure that small and minority-owned businesses, women's business enterprises, disadvantaged business enterprises, labor surplus area businesses, and individuals or firms located in or owned in substantial part by persons residing in the area of an BCHA project are used when possible. Such efforts shall include, but shall not be limited to:
 - a. Including such firms, when qualified, on solicitation mailing lists;
 - b. Encouraging their participation through direct solicitation of bids or qualifications whenever they are potential sources;
 - c. Dividing total requirements, when economically feasible, into smaller tasks or quantities to permit maximum participation by such firms;

B. DEFINITIONS

1. A small business concern is defined as a business which is independently owned and operated, not dominant in the field of operation in which it is bidding on government contracts, and qualified as a small business under the criteria and size standards in 13 CFR Part 121.

A minority-owned business is defined as a business which is at least 51% owned by one (1) or more minority group members; or, in the case of a publicly-owned business, one (1) in which at least 51% of its voting stock is owned by one (1) or more minority group members, and whose management and daily business operations are controlled by one (1) or more such individuals. - 3. A women's business enterprise is defined as a business that's at least 51% owned by a woman or women who are U.S. citizens and who also control or operate the business.
- 4. A labor surplus area business is defined as a business which, together with its immediate subcontractors, will incur more than 50% of the cost of performing the contract in an area of concentrated unemployment or underemployment, as defined by the U. S. Department of Labor in 20 CFR 654, Subpart A, and in lists of labor surplus areas published by the Employment and Training Administration.
- 5. A Section 3 Business concern is defined as one (a) that is 51% or more owned by Section 3 Residents; or (b) whose permanent, full-time employees include persons, at least 30% of whom are currently Section 3 Residents, or within three (3) years of the date of first employment with the business concern were Section 3 Residents; or (c) that provides evidence of a commitment to subcontract in excess of 25% of the dollar award of all subcontracts to be awarded to business concerns that meet the qualifications set forth in paragraphs (a) or (b) in this definition of "Section 3 business concern."
- 6. "Socially and Economically Disadvantaged individuals" means those individuals who are citizens or lawfully admitted permanent residents of the United States and who are minorities or individuals found by the Small Business Administration pursuant to Section 8(a) of the Small Business Act to be disadvantaged.

C. SECTION 3 REQUIREMENTS

Instructions to Offerors Non-Construction

1. Preparation of Offers

- (a) Offerors are expected to examine the statement of work, the proposed contract terms and conditions, and all instructions. Failure to do so will be at the offeror's risk.
- (b) Each offeror shall furnish the information required by the solicitation. The offeror shall sign the offer and print or type its name on the cover sheet and each continuation sheet on which it makes an entry. Erasures or other changes must be initialed by the person signing the offer. Offers signed by an agent shall be accompanied by evidence of that agent's authority, unless that evidence has been previously furnished to the HA.
- (c) Offers for services other than those specified will not be considered.

2. Submission of Offers

- (a) Offers and modifications thereof shall be submitted in sealed envelopes or packages (1) addressed to the office specified in the solicitation, and (2) showing the time specified for receipt, the solicitation number, and the name and address of the offeror.
- (b) Telegraphic offers will not be considered unless authorized by the solicitation; however, offers may be modified by written or telegraphic notice.
- (c) Facsimile offers, modifications or withdrawals will not be considered unless authorized by the solicitation.

3. Amendments to Solicitations

- (a) If this solicitation is amended, then all terms and conditions which are not modified remain unchanged.

5. Responsibility of Prospective Contractor

- (a) The HA shall award a contract only to a responsible prospective contractor who is able to perform successfully under the terms and conditions of the proposed contract. To be determined responsible, a prospective contractor must -

2. Changes

- (a) The HA may at any time, by written order, and without notice to the sureties, if any, make changes within the general scope of this contract in the services to be performed or supplies to be delivered.
- (b) If any such change causes an increase or decrease in the hourly rate, the not-to-exceed amount of the contract, or the time required for performance of any part of the work under this contract, whether or not changed by the order, or otherwise affects the conditions of this contract, the HA shall make an equitable adjustment in the not-to-exceed amount, the hourly rate, the delivery schedule, or other affected terms, and shall modify the contract accordingly.
- (c) The Contractor must assert its right to an equitable adjustment under this clause within 30 days from the date of receipt of the written order. However, if the HA decides that the facts justify it, the HA may receive and act upon a

7. Disputes

- (a) All disputes arising under or relating to this contract, except for disputes arising under clauses contained in Section III, Labor Standards Provisions, including any claims for damages for the alleged breach there of which are not disposed of by agreement, shall be resolved under this clause.
- (b) All claims by the Contractor shall be made in writing and submitted to the HA. A claim by the HA against the Contractor shall be subject to a written decision by the HA.
- (c) The HA shall, with reasonable promptness, but in no event in no more than 60 days, render a decision concerning any claim hereunder. - (b) The Contractor agrees that if after award it discovers an organizational conflict of interest with respect to this contract or any task/delivery order under the contract, he or she shall make an immediate and full disclosure in writing to the Contracting Officer which shall include a description of the action which the Contractor has taken or intends to take to eliminate or neutralize the conflict. The HA may, however, terminate the contract or task/delivery order for the convenience of the HA if it would be in the best interest of the HA.
- (c) In the event the Contractor was aware of an organizational conflict of interest before the award of this contract and intentionally did not disclose the conflict to the Contracting Officer, the HA may terminate the contract for default.
- (d) The terms of this clause shall be included in all subcontracts and consulting agreements wherein the work to be performed is similar to the service provided by the prime Contractor. The Contractor shall include in such subcontracts and consulting agreements any necessary provisions to eliminate or neutralize conflicts of interest.

12. Inspection and Acceptance

(a) The HA has the right to review, require correction, if necessary, and accept the work products produced by the Contractor. Such review(s) shall be carried out within 30 days so as to not impede the work of the Contractor. Any

- product of work shall be deemed accepted as submitted if the HA does not issue written comments and/or required corrections within 30 days from the date of receipt of such product from the Contractor.
- (b) The Contractor shall make any required corrections promptly at no additional charge and return a revised copy of the product to the HA within 7 days of notification or a later date if extended by the HA.
- (c) Failure by the Contractor to proceed with reasonable promptness to make necessary corrections shall be a default. If the Contractor's submission of corrected work remains unacceptable, the HA may terminate this contract (or the task order involved) or reduce the contract price or cost to reflect the reduced value of services received.

13. Interest of Members of Congress

No member of or delegate to the Congress of the United States of America or Resident Commissioner shall be admitted to any share or part of this contract or to any benefit to arise there from, but this provision shall not be construed to extend to this contract if made with a corporation for its general benefit.

Interest of Members, Officers, or Employees and Former Members, Officers, or Employees

No member, officer, or employee of the HA, no member of the governing body of the locality in which the project is situated, no member of the governing body in which the HA was activated, and no other pubic official of such locality or localities who exercises any functions or responsibilities with respect to the project, shall, during his or her tenure, or for one year thereafter, have any interest, direct or indirect, in this contract or the proceeds thereof.

15. Limitation on Payments to Influence Certain Federal Transactions

(a) Definitions. As used in this clause:

"Agency", as defined in 5 U.S.C. 552(f), includes Federal executive departments and agencies as well as independent regulatory commissions and Government corporations, as defined in 31 U.S.C. 9101(1).

"Covered Federal Action" means any of the following Federal actions:

- (i) The awarding of any Federal contract;
- (ii) The making of any Federal grant;
- (iii) The making of any Federal loan;
- (iv) The entering into of any cooperative agreement; and,
- (v) The extension, continuation, renewal, amendment, or modification of any Federal contract, grant, loan, or cooperative agreement.

Covered Federal action does not include receiving from an agency a commitment providing for the United States to insure or guarantee a loan.

"Indian tribe" and "tribal organization" have the meaning provided in section 4 of the Indian Self-Determination and Education Assistance Act (25 U.S.C. 450B). Alaskan Natives are included under the definitions of Indian tribes in that Act.

"Influencing or attempting to influence" means making, with the intent to influence, any communication to or appearance before an officer or employee of any agency, a Member of Congress, an officer or employee of Congress, or an employee of a Member of Congress in connection with any covered Federal action.

"Local government" means a unit of government in a State and, if chartered, established, or otherwise recognized by a State for the performance of a governmental duty, including a local public authority, a special district, an intrastate district, a council of governments, a sponsor group representative organization, and any other instrumentality of a local government.

"Officer or employee of an agency" includes the following individuals who are employed by an agency:

- An individual who is appointed to a position in the Government under title 5, U.S.C., including a position under a temporary appointment;
- (ii) A member of the uniformed services as defined in section 202, title 18, U.S.C.;
- (iii) A special Government employee as defined in section 202, title 18, U.S.C.; and,
- (iv) An individual who is a member of a Federal advisory committee, as defined by the Federal Advisory Committee Act, title 5, appendix 2.

"Person" means an individual, corporation, company, association, authority, firm, partnership, society, State, and local government, regardless of whether such entity is operated for profit or not for profit. This term excludes an Indian tribe, tribal organization, or other Indian organization with respect to expenditures specifically permitted by other Federal law.

"Recipient" includes all contractors, subcontractors at any tier, and subgrantees at any tier of the recipient of funds received in connection with a Federal contract, grant, loan, or cooperative agreement. The term excludes an Indian tribe, tribal organization, or any other Indian organization with respect to expenditures specifically permitted by other Federal law.

"Regularly employed means, with respect to an officer or employee of a person requesting or receiving a Federal contract, grant, loan, or cooperative agreement, an officer or employee who is employed by such person for at least 130 working days within one year immediately preceding the date of the submission that initiates agency consideration of such person for receipt of such contract, grant, loan, or cooperative agreement. An officer or employee who is employed by such person for less than 130 working days within one year immediately preceding the date of submission that initiates agency consideration of such person shall be considered to be regularly employed as soon as he or she is employed by such person for 130 working days.

"State" means a State of the United States, the District of Columbia, the Commonwealth of Puerto Rico, a territory or possession of the United States, an agency or instrumentality of a State, and a multi-State, regional, or interstate entity having governmental duties and powers.

- (b) Prohibition.
 - (i) Section 1352 of title 31, U.S.C. provides in part that no appropriated funds may be expended by the recipient of a Federal contract, grant, loan, or cooperative agreement to pay any person for influencing or attempting to influence an officer or employee of any agency, a Member of Congress, an officer or employee of Congress, or an employee of a Member of Congress in connection with any of the following covered Federal actions: the awarding of any Federal contract, the making of any Federal grant, the making of any Federal loan, the entering into of any cooperative agreement, and the extension, continuation, renewal, amendment, or modification of any Federal contract, grant, loan, or cooperative agreement.
 - (ii) The prohibition does not apply as follows:

- Agency and legislative liaison by Own Employees.
 - (a) The prohibition on the use of appropriated funds, in paragraph (i) of this section, does not apply in the case of a payment of reasonable compensation made to an officer or employee of a person requesting or receiving a Federal contract, grant, loan, or cooperative agreement, if the payment is for agency and legislative activities not directly related to a covered Federal action
 - (b) For purposes of paragraph (b)(i)(1)(a) of this clause, providing any information specifically requested by an agency or Congress is permitted at any time.
 - (c) The following agency and legislative liaison activities are permitted at any time only where they are not related to a specific solicitation for any covered Federal action:
 - (1) Discussing with an agency (including individual demonstrations) the qualities and characteristics of the person's products or services, conditions or terms of sale, and service capabilities; and,
 - (2) Technical discussions and other activities regarding the application or adaptation of the person's products or services for an agency's use.
 - (d) The following agency and legislative liaison activities are permitted where they are prior to formal solicitation of any covered Federal action:
 - (1) Providing any information not specifically requested but necessary for an agency to make an informed decision about initiation of a covered Federal action;
 - (2) Technical discussions regarding the preparation of an unsolicited proposal prior to its official submission; and
 - (3) Capability presentations by persons seeking awards from an agency pursuant to the provisions of the Small Business Act, as amended by Public Law 95-507 and other subsequent amendments.
 - (e) Only those activities expressly authorized by subdivision (b)(ii)(1)(a) of this clause are permitted under this clause.
- (2) Professional and technical services.
 - (a) The prohibition on the use of appropriated funds, in subparagraph (b)(i) of this clause, does not apply in the case of-
 - (i) A payment of reasonable compensation made to an officer or employee of a person requesting or receiving a covered Federal action or an extension, continuation, renewal, amendment, or modification of a covered Federal action, if payment is for professional or technical services rendered directly in the preparation, submission, or negotiation of any bid, proposal, or application for that Federal action or for meeting requirements imposed by or pursuant to law as a condition for receiving that Federal action.
 - (ii) Any reasonable payment to a person, other than an officer or employee of a

- person requesting or receiving a covered Federal action or an extension, continuation, renewal, amendment, or modification of a covered Federal action if the payment is for professional or technical services rendered directly in the preparation, submission, or negotiation of any bid, proposal, or application for that Federal action or for meeting requirements imposed by or pursuant to law as a condition for receiving that Federal action. Persons other than officers or employees of a person requesting or receiving a covered Federal action include consultants and trade associations.
- (b) For purposes of subdivision (b)(ii)(2)(a) of clause, "professional and technical services" shall be limited to advice and analysis directly applying any professional or technical discipline.
- (c) Requirements imposed by or pursuant to law as a condition for receiving a covered Federal award include those required by law or regulation, or reasonably expected to be required by law or regulation, and any other requirements in the actual award documents.
- (d) Only those services expressly authorized by subdivisions (b)(ii)(2)(a)(i) and (ii) of this section are permitted under this clause.
- (iii) Selling activities by independent sales representatives.
- (c) The prohibition on the use of appropriated funds, in subparagraph (b)(i) of this clause, does not apply to the following selling activities before an agency by independent sales representatives, provided such activities are prior to formal solicitation by an agency and are specifically limited to the merits of the matter:
 - Discussing with an agency (including individual demonstration) the qualities and characteristics of the person's products or services, conditions or terms of sale, and service capabilities; and
 - (ii) Technical discussions and other activities regarding the application or adaptation of the person's products or services for an agency's use.
- (d) Agreement. In accepting any contract, grant, cooperative agreement, or loan resulting from this solicitation, the person submitting the offer agrees not to make any payment prohibited by this clause.
- (e) Penalties. Any person who makes an expenditure prohibited under paragraph (b) of this clause shall be subject to civil penalties as provided for by 31 U.S.C. 1352. An imposition of a civil penalty does not prevent the Government from seeking any other remedy that may be applicable.
- (f) Cost Allowability. Nothing in this clause is to be interpreted to make allowable or reasonable any costs which would be unallowable or unreasonable in accordance with Part 31 of the Federal Acquisition Regulation (FAR), or OMB Circulars dealing with cost allowability for recipients of assistance agreements. Conversely, costs made specifically unallowable by the requirements in this clause will not be made allowable under any of the provisions of FAR Part 31 or the relevant OMB Circulars.

16. Equal Employment Opportunity

During the performance of this contract, the Contractor agrees as follows:

- (a) The Contractor shall not discriminate against any employee or applicant for employment because of race, color, religion, sex, or national origin.
- (b) The Contractor shall take affirmative action to ensure that applicants are employed, and that employees are treated during employment without regard to their race, color, religion, sex, or national origin. Such action shall include, but not be limited to (1) employment; (2) upgrading; (3) demotion; (4) transfer; (5) recruitment or recruitment advertising; (6) layoff or termination; (7) rates of pay or other forms of compensation; and (8) selection for training, including apprenticeship.
- (c) The Contractor shall post in conspicuous places available to employees and applicants for employment the notices to be provided by the Contracting Officer that explain this clause.
- (d) The Contractor shall, in all solicitations or advertisements for employees placed by or on behalf of the Contractor, state that all qualified applicants will receive consideration for employment without regard to race, color, religion, sex, or national origin.
- (e) The Contractor shall send, to each labor union or representative of workers with which it has a collective bargaining agreement or other contract or understanding, the notice to be provided by the Contracting Officer advising the labor union or workers' representative of the Contractor's commitments under this clause, and post copies of the notice in conspicuous places available to employees and applicants for employment.
- (f) The Contractor shall comply with Executive Order 11246, as amended, and the rules, regulations, and orders of the Secretary of Labor.
- (g) The Contractor shall furnish all information and reports required by Executive Order 11246, as amended and by rules, regulations, and orders of the Secretary of Labor, or pursuant thereto. The Contractor shall permit access to its books, records, and accounts by the Secretary of Labor for purposes of investigation to ascertain compliance with such rules, regulations, and orders.
- (h) In the event of a determination that the Contractor is not in compliance with this clause or any rule, regulation, or order of the Secretary of Labor, this contract may be canceled, terminated, or suspended in whole or in part, and the Contractor may be declared ineligible for further Government contracts, or federally assisted construction contracts under the procedures authorized in Executive Order 11246, as amended. In addition, sanctions may be imposed and remedies invoked against the Contractor as provided in Executive Order 11246, as amended, the rules, regulations, and orders of the Secretary of Labor, or as otherwise provided by law.
- (i) The Contractor shall include the terms and conditions of this clause in every subcontract or purchase order unless exempted by the rules, regulations, or orders of the Secretary of Labor issued under Executive Order 11246, as amended, so that these terms and conditions will be binding upon each subcontractor or vendor. The Contractor shall take such action with respect to any subcontractor or purchase order as the Secretary of Housing and Urban Development or the Secretary of Labor may direct as a means of enforcing such provisions, including sanctions for noncompliance; provided that if the

Contractor becomes involved in, or is threatened with, litigation with a subcontractor or vendor as a result of such direction, the Contractor may request the United States to enter into the litigation to protect the interests of the United States

17. Dissemination or Disclosure of Information

No information or material shall be disseminated or disclosed to the general public, the news media, or any person or organization without prior express written approval by the HA.

18. Contractor's Status

It is understood that the Contractor is an independent contractor and is not to be considered an employee of the HA, or assume any right, privilege or duties of an employee, and shall save harmless the HA and its employees from claims suits, actions and costs of every description resulting from the Contractor's activities on behalf of the HA in connection with this Agreement.

19. Other Contractors

HA may undertake or award other contracts for additional work at or near the site(s) of the work under this contract. The contractor shall fully cooperate with the other contractors and with HA and HUD employees and shall carefully adapt scheduling and performing the work under this contract to accommodate the additional work, heeding any direction that may be provided by the Contracting Officer. The contractor shall not commit or permit any act that will interfere with the performance of work by any other contractor or HA employee.

20. Liens

The Contractor is prohibited from placing a lien on HA's property. This prohibition shall apply to all subcontractors.

- 21. Training and Employment Opportunities for Residents in the Project Area (Section 3, HUD Act of 1968; 24 CFR 135)
- (a) The work to be performed under this contract is subject to the requirements of section 3 of the Housing and Urban Development Act of 1968, as amended, 12 U.S.C. 1701u (section 3). The purpose of section 3 is to ensure that employment and other economic opportunities generated by HUD assistance or HUD-assisted projects covered by section 3, shall, to the greatest extent feasible, be directed to low- and very low-income persons, particularly persons who are recipients of HUD assistance for housing.
- (b) The parties to this contract agree to comply with HUD's regulations in 24 CFR Part 135, which implement section 3. As evidenced by their execution of this contract, the parties to this contract certify that they are under no contractual or other impediment that would prevent them from complying with the Part 135 regulations.
- (c) The contractor agrees to send to each labor organization or representative of workers with which the contractor has a collective bargaining agreement or other understanding, if any, a notice advising the labor organization or workers' representative of the contractor's commitments under this section 3 clause, and will post copies of the notice in conspicuous places at the work site where both employees and applicants for training and employment positions can see the notice. The notice shall describe the section 3 preference, shall set forth minimum number and job titles subject to hire, availability of

- apprenticeship and training positions, the qualifications for each; and the name and location of the person(s) taking applications for each of the positions; and the anticipated date the work shall begin.
- (d) The contractor agrees to include this section 3 clause in every subcontract subject to compliance with regulations in 24 CFR Part 135, and agrees to take appropriate action, as provided in an applicable provision of the subcontract or in this section 3 clause, upon a finding that the subcontractor is in violation of the regulations in 24 CFR Part 135. The contractor will not subcontract with any subcontractor where the contractor has notice or knowledge that the subcontractor has been found in violation of the regulations in 24 CFR Part 135.
- (e) The contractor will certify that any vacant employment positions, including training positions, that are filled (1) after the contractor is selected but before the contract is executed, and (2) with persons other than those to whom the regulations of 24 CFR Part 135 require employment opportunities to be directed, were not filled to circumvent the contractor's obligations under 24 CFR Part 135.
- (f) Noncompliance with HUD's regulations in 24 CFR Part 135 may result in sanctions, termination of this contract for default, and debarment or suspension from future HUD assisted contracts.

22. Procurement of Recovered Materials

- (a) In accordance with Section 6002 of the Solid Waste Disposal Act, as amended by the Resource Conservation and Recovery Act, the Contractor shall procure items designated in guidelines of the Environmental Protection Agency (EPA) at 40 CFR Part 247 that contain the highest percentage of recovered materials practicable, consistent with maintaining a satisfactory level of competition. The Contractor shall procure items designated in the EPA guidelines that contain the highest percentage of recovered materials practicable unless the Contractor determines that such items: (1) are not reasonably available in a reasonable period of time; (2) fail to meet reasonable performance standards, which shall be determined on the basis of the guidelines of the National Institute of Standards and Technology, if applicable to the item; or (3) are only available at an unreasonable price.
- (b) Paragraph (a) of this clause shall apply to items purchased under this contract where: (1) the Contractor purchases in excess of \$10,000 of the item under this contract; or (2) during the preceding Federal fiscal year, the Contractor: (i) purchased any amount of the items for use under a contract that was funded with Federal appropriations and was with a Federal agency or a State agency or agency of a political subdivision of a State; and (ii) purchased a total of in excess of \$10,000 of the item both under and outside that contract.
