




Photo 10. Oil/Water Separator in northwest section of the Maintenance Building. Outlet is unknown. Site A.




Photo 12. Hydraulic air compressor located on the northside of the Maintenance Building. Potential for PCBs. Site A




Photo 13. Overhead natural gas heaters in the Maintenance Building. Wall is for the refrigerated rooms. Potential ACM in walls. Site A.
