Bids are opened and read aloud to the public at the Robertson County Finance Office, 523 S. Brown Street, Springfield, TN 37172 immediately after the bid receipt deadline. Each vendor may submit more than one bid provided each bid meets the stated specifications. Each bid must be submitted in a separate sealed envelope with the appropriate notation on the outside. All bids must be signed by an authorized agent and submitted on the prescribed forms. Submission of bids by telegraph, telephone, or other electronic means is strictly prohibited. Any brand name called for the bid specifications is provided as a reference only. Alternate brand name items offered for bid must be equivalent as to function, basic design, type and quality of material, method of construction, and any required dimensions. Bidder must attach a letter of exception to specifications.

2014 and 2015 Dodge Charger AWD S.R.O. vehicle equipment package

Our agency has obtained used Dodge Charger AWD vehicles. These vehicles are (3) 2014 year models and (7) 2015 year models. We would like to bid the following equipment package. Please note that these vehicles will not have an exterior main light bar (Slick top). Additionally, only (8) "eight" of these vehicles need to have the below listed vehicle graphics. The (2) two remaining vehicles will eventually be wrapped from another vendor.

1) Front and Rear interior visor lightbars (all Blue LEDS, unless takedown spotlights).

Front light-bar: Dodge Charger, 2011-2019, Ten 3-LED Lamps, Upper Front Two Piece Unit, Individual Driver and Passenger Side Units, with Two LED Flashing/Take-Downs

Rear light-bar:

8 Lamp Tray, Low Current, 8 SOLO Light heads and Vehicle Specific Housing and Mount

- 2) Corner LED lights, 4 total, all Blue. Omni Directional Light head, Blue LEDs, 9' Cable. Corner LED lights shall be installed on 4 corners of the vehicle.
- 3) Single Unit Siren with 9-Switch Light Control and Standard Switching, with Park Kill & Timed Out Relay with 17 Scan-LockTM Siren Tones.
- 4) Speaker, Nylon Composite, with mounting bracket behind front grill area
- 5) Transport partition screen with recessed panels, lower extension pieces, and a center sliding window. This will be a partition only and will not include a transport seat.
- 6) Dual Weapon (Rifle and Shotgun) mount compatible with above transport system mounted between front Driver's and Passenger seats.
- 7) Center Console for 2014/2015 Dodge Chargers complete with internal cup holders, and a hinged arm rest.
- 8) Robertson County Sheriff's Office Fleet Vehicle Graphics according to the attached images for (8) eight of the ten total vehicles. All Robertson County Sheriff's Office reflective markings to include front hood, driver's side, passenger side and rear of vehicle per attached photos and specifications to fit Utility vehicle. All decals must match enclosed diagrams and photographs. Hood decals shall be centered on the vehicle. Sheriff's stars (hood and each side) should be cut out to show a white border between the star and stripes. The "Sheriff' lettering along the side of the vehicle should be outlined in the same fashion.
- 9) All equipment must be mounted and installed. Bids must include any additional charges for necessary accessories and installation charges.
