#### **QUESTION/ANSWER**

1. **QUESTION:** Is there a detail and location for the infiltration trenches?

ANSWER: The quantity for infiltration trenches has been removed from the project. Addendum 5 revised schedule of values bid form is provided as part of this addendum at <a href="https://vrapp.vendorregistry.com/Bids/View/Bid/9c64af19-cfde-4359-a749-">https://vrapp.vendorregistry.com/Bids/View/Bid/9c64af19-cfde-4359-a749-</a>
De84a7d27f31?isBuyerAction=True. The cost of all items associated with weir/swale outlet control structures as shown on 38-100 in the revised plan set shall be included in the price bid for Class AAI CONC. INCL. REINF. MATL. (DRAINAGE WIER STRUCTURES).

2. **QUESTION:** Existing Service Point, PSCNE2H calls as 480/277v. A 120/240v Milbank was installed at the Montgomery tie in. Should a step-up transformer be installed at this location?

**ANSWER:** Please disregard the reference to 480/277v panels. All six panels on the project shall be 12/240v panels.



3. **QUESTION:** Wire sizing appears to be sized for a 480V 277V service point at PSCNE2H location. If the existing voltage of 120/240v is to be used should the wire size be sized for the 120/240V service?

**ANSWER:** No. The lighting circuits are to operate at 240 volts.

4. **QUESTION:** Note 2 on 25-103 states: Install MDF Cabinet at STA 96+00. Run fiber optic cable to cabinet. Equipment for terminations and terminations to be by others. Are splicing and terminations to be completed by others?

**ANSWER:** Splicing and terminations are to be completed under this contract.

5. **QUESTION:** If terminations of fiber optic are to be completed by contractor, can a pay item for splicing and underground enclosures be added? Can this inner duct be a fabric innerduct?

<u>ANSWER:</u> Terminations and splicing are included in the MDF cabinet installation. See Addendum 5 revised construction plans- Sheet 25-101 within this link <a href="https://vrapp.vendorregistry.com/Bids/View/Bid/9c64af19-cfde-4359-a749-0e84a7d27f31?isBuyerAction=True">https://vrapp.vendorregistry.com/Bids/View/Bid/9c64af19-cfde-4359-a749-0e84a7d27f31?isBuyerAction=True</a>. Fabric innerduct cannot be used.

6. **QUESTION:** Detail 1/25-103 calls for a 4" PVC conduit to poles and wall mounted lighting. Can this be changed to a 2" conduit?

ANSWER: Contractor shall bid this item as a 2" conduit.

7. **QUESTION:** Plans show that an innerduct be installed in the 2" conduit from the handhole to the camera locations. How many cells are needed?

**ANSWER:** 2 cells are needed.
