Introduction

The City of Foley is seeking proposals from firms to provide on call disaster recovery consulting services should the need arise. There are no current projects requiring these services at this time. Services could include but are not limited to technical, administrative and training support to assist with damage assessment, disaster recovery, project estimation, FEMA force account and small and large project document assembly, and Federal procurement requirements review, grant procurement and administration, etc. Work will include working with federal agencies, state agencies, and local governments.

It is imperative that consultants examine and become familiar with the grant programs established by the Federal Emergency Management Agency (FEMA). Funding for these services will be made possible through strict conformance to the guidelines set forth by Alabama Emergency Management Agency (AEMA) and FEMA. Respondents will comply with the Federal Aid Contract Requirements shown at Appendix B.

Special Conditions

- 1. The selection of a consultant will not guarantee any minimum amount of services under the contract.
- 2. The selection of a Consultant by the City does not guarantee the Consultant a contract.
- 3. The City reserves the right to reject any or all proposals; to negotiate any elements of a proposal; to conduct interviews at its sole discretion; and to solicit and/or select consultants outside of the scope of this RFP. The City may award one contract or multiple on-demand contracts in an effort to obtain the best match and availability of the consultant(s) for actual disasters that occur.
- 4. The City assumes no responsibility or liability for costs incurred by respondents to this request, including any requests for additional information, interviews or negotiations.
- 5. All applicable State of Alabama and Federal rules and regulations must be adhered to by the consultant.

Detailed Scope of Work

The successful proposer will assume responsibility as an independent contractor for the development and submission of FEMA grant applications and the management of all such disaster-related grants. The awarded consultant(s) will be required to follow the code of Federal Regulations, as it relates to procurement and scope of services as amended and updated.

This will include working with federal agencies, state agencies, and several departments within the City of Foley. Some of the services the successful proposers may be asked to perform include, but are not limited to the following:

1. Provide grant management advice to the City related to FEMA, Federal, or State agency passthrough grants. The successful proposer will review the City's current record-keeping strategy for documentation. Proposer will assist the affected departments and City members to develop a standard guideline as part of their emergency plans on how reimbursement expenditures are recorded, what type of documentation should be maintained, and provide any other associated



services that may be directly related to support recovery costs and reimbursement from appropriate agencies.

- 2. File the initial Request for Public Assistance (RPA) after the initial disaster (event) within the deadline time period. Meet all stated deadlines to meet FEMA and the State's required timelines to recover full reimbursement.
- 3. Meet with FEMA Representative and the State Public Assistance Coordinator for the Initial Kickoff Meeting to discuss what the City's initial disaster related damages and expenditures appear to be. Review the procedures and follow-up processes required to support full reimbursement and or grant funding.
- 4. Review contracts, advise the City on the establishment of contracts for contingency services and supplies and advise on the scope of work development for said contracts, and purchasing documentation.
- 5. Prepare any required supporting documentation that must accompany the Project Worksheets, including working with the City to gather details related to employee fringe benefits, overtime, etc. for labor rates to provide to FEMA.
- 6. Work with appropriate City staff to assist the FEMA, Federal or State Agency in providing the necessary information, e.g. insurance policies, personnel policies, as requested by those or other agencies to complete necessary documentation for reimbursement and or grant application. Research as necessary to complete all forms.
- 7. Assist the City in compiling their initial damage assessments, if requested, for all expenditures, both in force account and permanent damages, including labor, equipment, materials, contract, rental equipment and all FEMA reimbursement categories and so on.
- 8. Assist the City in completing the appropriate documentation required for federal and state reimbursement, and the submittal of all eligible expenditures for small and large projects to the appropriate agencies, and within the required deadline.
- 9. Provide assistance to determine if any eligible damages or expenses have not been quantified and presented for reimbursement.
- 10. Assist in tracking all project documentation submitted and following any outstanding expenditure(s) to ensure that all eligible expenditures are credited through submitted reimbursements. Ensure that the City understands why certain expenditures were de-obligated, if any. Track all expenditures and reimbursements to maintain high quality reconciliations of monies expended by the City and submitted for reimbursements versus those actually received.
- 11. Provide copies of all documentation transacted for reimbursement on behalf of the City. Offer the City any project management design and/or coordination ideas that may result in cost savings, efficiencies, or increased reimbursement.
- 12. Assist the City, to provide all necessary backup documentation, e.g. invoices equipment usage documents, etc. that will garner full reimbursement or grant eligibility. The documentation submitted for reimbursement must withstand a FEMA or Federal or State audit and State Emergency Management audit, and the successful proposer will have to support the work for which they are assisting the City.
- 13. Assist with any special documentation and requirements to receive reimbursement under the FHWA program working with the Alabama Department of Transportation (ALDOT) and the City.
- 14. Assist any specialized FEMA teams as they become necessary in the process.
- 15. Maintain records of all the documentation provided by the City to be submitted to any outside agency for reimbursement and provide the City with said copies upon request at any point in the process.
- 16. Once all projects are complete and reimbursement has been drawn down for eligible costs, the successful proposer would assist with final preparations with the State of Alabama and FEMA or federal agencies for final inspections and the closeout process for large and small projects. The successful proposer would participate in the exit conferences with the City, County, State, and FEMA agencies.



- 17. The successful proposer must be available to assist with any requests for audit information by any source.
- 18. If any disputes arise between the City and FEMA and/or the State, the successful proposer will assist the City in strategizing and writing the appeals.
- 19. The successful proposer must be able to have a team available from the start of the disaster reimbursement process to the closeout process for the City. This includes any time accounted for if an appeal is requested by the City.
- 20. Provide miscellaneous services not otherwise described, but which the City may require during the course of the Agreement, or any other tasks associated with FEMA and FHWA grant management or documentation reimbursement process as requested by the City.
- 21. The successful proposer will also provide the City with a final report that will summarize the total reimbursement requested, total expenditures by Project Worksheet, and any special circumstances. Additionally, reporting requirements include FHWA reimbursement, total number of Project Worksheets, total reimbursement requested by Category type, total reimbursement requested by small or large project, and any other relevant data.
- 22. Provide assistance with Alabama Emergency Management Agency (AEMA) Public Assistance document coordination, meetings and project worksheet amendments.

Basis of Award

The contract will be awarded to the responsive, responsible consultant who ranks highest in the evaluation process based on the criteria specified in the Request for Proposals instructions.

Tie Proposals

Should a tie occur, an alternate committee member will be asked to evaluate the firms based on the submitted proposals this alternate score will be the tie-breaker.

Right to Reject

The City of Foley reserves the right to:

- a. reject any or all proposals received;
- b. select and award any portion of any or all proposal items;
- c. waive minor informalities and irregularities in the consultant's proposal.

A proposal may be rejected if it is non-responsive or does not conform to the requirements and instructions in this RFP. A proposal may be non-responsive by reasons, including, but not limited to, failure to utilize or complete prescribed forms, conditional proposals, incomplete proposals, indefinite or ambiguous proposals, failure to meet deadlines and improper and/or undated signatures. Other conditions which may cause rejection of proposals include evidence of collusion, obvious lack of experience or expertise to perform the required work, submission of more than one proposal for the same work from an individual, consultant or corporation under the same or a different name, failure to perform or meet financial obligations on previous contracts. Proposals may be rejected if not delivered on or before the date and time specified as the due date for submission of the proposal.

Execution of Agreement

The successful consulting firm shall, within 10 days after receipt of the Notice of Award and the contract forms or documents, sign and deliver to the Purchasing Agent. The awarded firm shall also deliver the policies of insurance or insurance certificate as required. All insurance documents shall be approved before the successful firm may proceed with the work.

The contract term is intended to be for a one (1) year initial term with two one (1) year renewal options. Prices shall remain firm for the initial term of the contract. Surcharges will not be accepted in conjunction with this contract, and such charges should be incorporated into the pricing structure.

Termination Clause

The City reserves the right to terminate with or without cause any contract resulting from this RFP with (10) ten calendar days written notice to the Consultant.

<u>Licenses</u>

Consultant shall be properly licensed for the appropriate work specified in this Request for Proposals. All consultants are requested to submit any required license(s) with their qualifications. License(s) must be effective as of the opening date and must be maintained throughout the contract period. Failure to be properly licensed as stated above may result in the rejection of the proposal as nonresponsive.

Subcontractors

The consultant will be the prime service provider and shall be responsible for all work performed and contract deliverables. Proposed use of subcontracts should be included in the proposer's response. Requests for use of subcontractors received subsequent to the solicitation process are subject to review and approval by the City.

The City reserves the right to request and review information in conjunction with its determination regarding a subcontract request. All subcontractors are subject to the same requirements of this solicitation as the awarded contractor.

Insurance

Consultants shall furnish insurance certificates indicating satisfactory insurance coverage at its sole cost and expense, maintain in full force and effect during the term of the agreement, policies of insurance of the type and in the minimum amounts stated below. Consultants, as part of their proposal, shall confirm that they possess the amounts and types of insurance which are described herein.

Such policy(s) will contain appropriate cross liability clauses, be primary and noncontributory, provide a waiver of subrogation in favor of the City and will provide that the City will be given 30 days advance written notice in the event of cancellation, termination or modification which materially restricts the coverage thereof.

Prior to the execution of this agreement, Consultant will provide the City with a certificate of insurance and a copy of the policy endorsements naming the City of Foley, its employees, directors, officers, agents, independent contractors, successors and assigns, and other authorized representatives as additional insured to the extent of the contractual obligation assumed by the consultant on all insurance policies reflected below with the exception of the workers compensation and professional liability policies. The certificate shall show a waiver of subrogation and hold harmless agreement in favor of the City of Foley, its employees, directors, officers, agents, independent contractors, successors and assigns, and other authorized representatives on all policies reflected below.

 Comprehensive General Liability Insurance - Each Occurrence Limit of \$1,000,000 for Bodily Injury and Property Damage and \$2,000,000 general aggregate for Products/Completed Operations, Comprehensive General Liability insurance shall include coverage for property damage; personal injury; contractual liability; products & completed operations; and independent contractor's coverage. Consultant must provide a copy of the Declaration of Coverage Pages containing the policy forms and exclusions on their General Liability, Auto Liability, Workers Compensation policies. Certificates of Insurance, Additional Insured, Primary and NonContributory and Waiver of Subrogation endorsements or policy forms reflecting these terms must be submitted to risk for review and approval.

- 2. Workers' Compensation Insurance The Consultant shall purchase and maintain workers' compensation insurance for all worker's compensation obligations imposed by state law and employer's liability limits.
- 3. Employers Liability Insurance \$100,000 Bodily Injury by Accident each employee; \$100,000 Bodily Injury by Disease each employee; \$500,000 Bodily Injury by Disease policy limit.
- 4. Comprehensive Automobile Liability Insurance \$1,000,000 combined single limit of insurance per occurrence for Bodily Injury and Property Damage; \$1,000,000 Hired & Non Owned Auto Liability.
- 5. Professional Liability \$1,000,000 If the Professional Liability is written on a claims made form, the retro date will need to be reflected on the certificate of insurance.

The successful Consultant must submit, prior to commencement of any work, a Certificate of Insurance showing the City of Foley as additional named insured on each of the policies referenced above.

The Consultant shall either require of its Subconsultant's to procure and to maintain Subconsultant's Comprehensive General Insurance and Automobile Liability Insurance of the type and in the same amounts specified above or insure the activities of its Subconsultant's in the Consultant's own policies.

Hold Harmless and Indemnification

- 1. The consultant shall indemnify and hold harmless the City, and its officers and employees, from liabilities, damages, losses, and costs, including, but not limited to, reasonable attorneys' fees, to the extent caused by the negligence, recklessness, or intentionally wrongful conduct of the consultant and other persons employed or utilized by the consultant in the performance of the contract.
- 2. The parties understand and agree that such indemnification by the consultant relating to any matter which is the subject of this Contract shall extend throughout the term of this Contract and any statutes of limitations thereafter.
- 3. The consultant's obligation shall not be limited by or in any way to any insurance coverage or by any provision in or exclusion or omission from any policy of insurance.

Duty to Pay Defense Costs and Expenses

- 1. The consultant agrees to reimburse and pay on behalf of the City the cost of the City's legal defense, through and including all appeals, and to include all attorneys' fees, costs, and expenses of any kind for any and all 1) claims described in the Hold Harmless and Indemnification paragraph or 2) other claims arising out of the consultant's performance of the contract and in which the City has prevailed.
- 2. The City shall choose its legal defense team, experts, and consultants and invoice the consultant accordingly for all fees, costs and expenses upon the conclusion of the claim.
- 3. Such payment on the behalf of the City shall be in addition to any and all other legal remedies available to the City and shall not be considered to be the City's exclusive remedy.

Contract Price

Contract prices shall be all inclusive and include all charges for completing the work such as layout, insurance, taxes, field office and supervision, overhead and profit, bonds and miscellaneous items.



Requirements

The awarded company will be required to provide a certificate of insurance with the City of Foley listed as an additional insured and a City of Foley business license prior to the Notice to Proceed being issued.

Additional Information

If the Bidder employs persons in the State of Alabama, the bidder must comply with Section 31-13-9, Code of Alabama 1975, and shall provide proof of enrollment in the E-Verify program with their bid. A copy of the signed Memorandum of Understanding (MOU) generated upon completion of enrollment in the E-Verify program is acceptable. (See General Conditions, Item 1.17 for more information.)

All questions related to this proposal must be documented through email and should be sent to Logan Eberly at leberly@cityoffoley.org no later than 72 hours prior to the scheduled proposal opening. No questions will be addressed by any means other than email. Answers will be emailed to all companies in the event that clarification is required. If further clarification is needed about a change within the proposal, an Addendum will be emailed stating the change. All addendums must be acknowledged in the "Addendum Acknowledgment" section located on page 3 of this request for proposal.

Instructions to Companies

To be eligible for consideration, proposals must include forms found in the Request for Proposal package. <u>The entire proposal and all executed forms must be submitted in a sealed envelope, clearly marked, identifying the project name, date and time of the bid opening, the company name and address</u>. It shall be the sole responsibility of the company to assure receipt of the proposal at the Foley City Hall prior to the published time for the proposal opening. If hand delivering, the proposal envelope must be "Date and Time" stamped at the receptionist's desk when the proposal package is turned in.

Proposal Requirements

Each firm's proposal shall include sufficient information to enable the City to evaluate the capability of the firm to provide the desired services. The data shall be significant to the project and discussions of past performances on other projects shall be minimized except as they relate to the proposed work.

Consultants should submit one (1) original clearly labeled "Original", two (2) copies clearly labeled "Copy" and one (1) electronic version of the package. The electronic version should be in pdf format on a USB drive. Electronic versions submitted via e-mail will not be accepted. If the proposal contains confidential information, such information shall be in a separate pdf document. Proposals shall be valid for a period of 180 days after the opening.

Emphasis in each proposal must be on completeness and clarity of content.

In order to expedite the evaluation of proposals, it is essential that consultant follow the format and instructions contained in the RFP.



The following information is the minimum content required for the proposal and will be used to compare and evaluate the firms:

Tab I: Cover Letter / Management Summary

Provide a cover letter, signed by an authorized officer of the firm, indicating the underlying philosophy of the firm in providing the services stated herein. Include the name(s), telephone number(s) and email(s) of the authorized contact person(s) concerning proposal. Submission of a signed proposal is the Consultant's certification that the Consultant will accept any awards as a result of this RFP.

Tab II: Firms Qualifications (30 points/5 Page Limit)

In this tab, provide the following:

- Provide an overview of the Firm's history, capability and business ability relative to the City's requirements.
- Describe your firm's qualifications in providing disaster recovery and specifically FEMA reimbursement services. Include information on organizational structure. Include any special expertise which your firm has in working with FEMA regarding debris reimbursement and monitoring contracts. Provide your firm's experience working with programs for road reimbursement. Provide specific information on your experience working on disaster recovery reimbursement projects in Alabama.
- Provide a complete list of all government agencies for which you are currently providing, or have provided in the past, disaster recovery FEMA reimbursement services since 2018, and FHWA services. Indicate the dates (length) of service for the listed clients and specify the name, title, addresses and telephone number of individuals. The City may contact those clients for whom you have provided disaster recovery FEMA reimbursement services for further information concerning the services provided.
- For large disasters, including hurricanes, that you are currently managing, have managed, or assisted in managing the FEMA reimbursement for, provide information on the number of Project Worksheets handled, the number of employees put within the organization to complete the work, what pre-work was done to assist in completing the Project Worksheets, any special reimbursement issues resolved with FEMA, amount de-obligated with the State and FEMA and why, the amount of dollars recovered for the organization, success in any FEMA or State appeals, and experience with any FEMA and State audits.
- Provide information on grants procured with dollar amount of awards and project description.
- Provide information related to your experience with any FEMA or State appeals. Provide the details as to the outcome, the duration of the appeal and any other related data.
- Provide information related to your experience with FEMA and State audits. Provide the number of audits your firm has been involved with, the number of findings against the organization that the auditors identified; if the findings were significant and overall what they found and the duration of the audits.
- Describe contacts and relationships with your other clients and interaction with FEMA and State Agencies.

Tab III: Specialized Expertise of Team Members (25 points\5 Page Limit, excluding resumes)

 Provide a list of individuals who will be assigned (on site/remote) to the disaster recovery reimbursement service engagement with the City and their specific roles. Include summary resumes of the individual to reflect their experience and education, particularly as they relate to the firm's engagements since 2018. Identify the primary contact who will be actively engaged in



serving the account and identify the current client workload of this individual by counties, cities, special districts, and other as may apply.

- If lead project staff members are to be changed, request must be made in writing and preapproved by the City.
- Provide the number of employees who serve in Alabama who would be available during normal business times versus during time of emergency or disaster. Describe the experience that these types of employees have in working with FEMA and the State in handling the documentation required for receiving reimbursement, e.g. Project Worksheets, in resolving reimbursement issues, and dealing with FEMA and State appeals, and audits.
- Describe the training that your employees have had regarding FEMA and FHWA grant rules and guidelines, State pass-through grant rules for reimbursement, debris recovery reimbursement, and any further training for reimbursement.
- Describe if your employees are full time employees or contracted employees.

Tab IV: Technical Approach (20 points/5 Page Limit)

- Provide a description of the firm's general approach to the proposed scope of services to include team organization, staff assignments, schedules, quality assurance and accountability.
- Provide relevant availability guidelines and/or the average time between request for meetings and actual attendance for current clients. Discuss the availability of the primary contact relative to current and future client workload. Include for each individual the estimated number of hours that will be contributed to this project and in what capacity they would serve on this project. Include information on supervisory personnel.
- Describe the amount of time and ability that your firm would be able to devote to individual City members to research the current process of how organizations are seeking federal reimbursement and how that process could be streamlined, as well as how members can better prepare before a loss to document a claim.
- Provide website and/or portal with details for status to worksheets.

Tab V: Cost of Services to the City (15 points/5 Page Limit)

- The cost of the proposal shall reflect an hourly rate for pre-disaster assistance and an hourly rate for all post-disaster assistance. The proposed hourly rates are inclusive of all costs associated with the disaster recovery assistance provided to the City members.
- Submit a fee schedule showing hourly rates for consultant services and hourly rates for education services and an itemized list of all direct and indirect costs associated with the performance of this contract.
- Provide examples (if any) where you have recovered all or part of your fees from FEMA.
- Provide costs specific to how grants are procured and grant administration.

Tab VI: References (10 points)

In order for the consultant to be awarded any points for this tab, the City requests that the consultant submits three (3) references from clients whose projects are of a similar nature to this solicitation. Information provided for each client shall include the following:

- Client name, address and email address and telephone number.
- Description of services provided.
- Time period of the project or contract; briefly describe if project met or exceeded the schedule outlined
- Client's contact reference name, email and current telephone number.
- Dollar value of project; briefly describe if the completed project met, or came under budget.



Tab VII: Acceptance of Conditions

Exceptions taken by a consultant may result in evaluation point deduction(s) and/or exclusion of proposal for Selection Committee consideration, depending on the extent of the exception(s). Such determination shall be at the sole discretion of the City and Selection Committee.

Evaluation Process and Criteria

Representatives from the City will review the submittals for completeness. Those submittals deemed complete and responsive will be forwarded to the Evaluation Committee.

- A. Evaluation of Proposals. Only written responses of statements of qualifications, performance data, and other data received in the purchasing office by the publicized submission time and date shall be evaluated.
- B. The initial ranking of proposals is based upon the points given in the scoring sheet utilizing the evaluation criteria in the RFP.
- C. Shortlisting. The best-qualified respondents shall be based upon the Evaluation Committee's ability to differentiate qualifications applicable to the scope and nature of the services to be performed as indicated by the ratings on the scoring sheet. Typically, the top three rated firms, if there are at least three responsive respondents, will be considered as the shortlisted firms, after input and discussion.
- D. Presentations/Interviews. The Evaluation Committee may choose to conduct formal presentations/interviews with shortlisted firms prior to final ranking.
- E. Final Ranking. The Evaluation Committee shall use the ordinal process to rank the firms. The respondents shall be listed in order of preference. The list of best-qualified persons shall be approved by the City Council, as appropriate, prior to beginning contract negotiations.

The City will make the selections primarily on the basis of the response to this RFP and any further information received from respondents if interviewed. Although information additional to that requested in this RFP may be provided by respondents, any consideration of this information shall be at the discretion of the City.

APPENDIX B

FEDERAL REGULATIONS CONTRACT REQUIREMENTS

FEDERAL EMERGENCY MANAGEMENT AGENCY

The supplemental conditions contained in this section are intended to cooperate with, to supplement, and to modify the general conditions and other specifications. In cases of disagreement with any other section of this contract, the Supplemental Conditions shall govern.

Contractor means an entity that receives a contract.

The services performed by the awarded Contractor shall be in compliance with all applicable grantor regulations/requirements, and additional requirements specified in this document. It shall be the awarded Contractor's responsibility to acquire and utilize the necessary manuals and guidelines that apply to the work required to complete this project. In general,

1)The contractor (including all subcontractors) must insert these contract provisions in each lower tier contracts (e.g. subcontract or sub-agreement);

2)The contractor (or subcontractor) must incorporate the applicable requirements of these contract provisions by reference for work done under any purchase orders, rental agreements and other agreements for supplies or services;

3)The prime contractor is responsible for compliance with these contract provisions by any subcontractor, lower-tier subcontractor or service provider.

FEDERAL CONTRACT PROVISIONS

- 1. Remedies Contracts for more than the simplified acquisition threshold, currently set at \$250,000, must address administrative, contractual, or legal remedies in instances where contractors violate or breach contract terms, and provide for such sanctions and penalties as appropriate. See 2 C.F.R. Part 200, Appendix II(A). This requirement applies to all FEMA grant and cooperative agreement programs.
- 2. Conflict of Interest This Contract/Work Order is subject to chapter 112, F.S. Employment, upgrading, demotion, or transfer; recruitment or recruitment advertising; layoff or termination; rates of pay or other forms of compensation; and selection for training, including apprenticeship. The contractor agrees to post in conspicuous places, available to employees and applicants for employment, notices to be provided setting forth the provisions of this nondiscrimination clause.

2. The contractor will, in all solicitations or advertisements for employees placed by or on behalf of the contractor, state that all qualified applicants will receive consideration for employment without regard to race, color, religion, sex, sexual orientation, gender identity, or national origin.



- 3. - 4. The contractor will send to each labor union or representative of workers with which he has a collective bargaining agreement or other contract or understanding, a notice to be provided advising the said labor union or workers' representatives of the contractor's commitments under this section, and shall post copies of the notice in conspicuous places available to employees and applicants for employment.

In the event of the contractor's noncompliance with the nondiscrimination clauses of this contract or with any of the said rules, regulations, or orders, this contract may be canceled, terminated, or suspended in whole or in part and the contractor may be declared ineligible for further Government contracts or federally assisted construction contracts in accordance with procedure sauthorized in Executive Order 11246 of September 24, 1965, and such other sanctions may be imposed and remedies invoked as provided in Executive Order 11246 of September 24, 1965, or by rule, regulation, or order of the Secretary of Labor, or as otherwise provided by law.
- 8. The contractor will include the portion of the sentence immediately preceding paragraph (1) and the provisions of paragraphs (1) through (8) in every subcontract or purchase order unless exempted by rules, regulations, or orders of the Secretary of Labor issued pursuant to section 204 of Executive Order 11246 of September 24, 1965, so that such provisions will be binding upon each subcontractor or vendor. The contractor will take such action with respect to any subcontract or purchase order as the administering agency may direct as a means of enforcing such provisions, including sanctions for noncompliance:

Provided, however, that in the event a contractor becomes involved in, or is threatened with, litigation with a subcontractor or vendor as a result of such direction by the administering agency, the contractor may request the United States to enter into such litigation to protect the interests of the United States.

Award of this contract will be conditioned upon satisfying the requirements of this bid specification. These requirements apply to all bidders/offerors, including those who qualify as a Minority Business vendor. A list of minority owned firms that could be offered subcontracting opportunities may be obtained by contacting the Office of Supplier Diversity at (850) 487-0915.
- 7. Applicable Laws The contractor shall comply with all applicable federal, state and local rules and regulations in providing services to the City. The contractor acknowledges that this requirement includes, but is not limited to, compliance with all applicable federal, state and local health and safety rules and regulations and that FEMA financial assistance may be used to fund the contract. As such, the contractor will comply will all applicable federal law, regulations, executive orders, FEMA policies, procedures, and directives.
- 8. Administrative, Contractual, or Legal Remedies Unless otherwise provided in this contract, all claims, counterclaims, disputes and other matters in question between the local government and the contractor, arising out of or relating to this contract, or the breach of it, will be decided by arbitration, if the parties mutually agree, or in an Alabama court of competent jurisdiction.
- **9.** Termination for Cause and for Convenience This contract may be terminated in whole or in part in writing by either party in the event of substantial failure by the other party to fulfill its obligations under this contract through no fault of the terminating party, provided that no termination may be effected unless the other party is given: (a) Not less than ten (10) calendar days written notice (delivered by certified mail, return receipt requested) of intent to terminate; and (b) An opportunity for consultation with the terminating party prior to termination.



This contract may be terminated in whole or in part in writing by the local government for its convenience, provided that the other party is afforded the same notice and consultation opportunity specified in I (a) above. If termination for default is effected by the local government, an equitable adjustment in the price for this contract shall be made, but no amount shall be allowed for anticipated profit on unperformed services or other work, and any payment due to the contractor at the time of termination may be adjusted to cover any additional costs to the local government because of the contractor's default.

If termination for convenience is effected by the local government, the equitable adjustment shall include a reasonable profit for services or other work performed for which profit has not already been included in an invoice. In addition, such contractor and subcontractor shall be liable to the United States (in the case of work done under contract for the District of Columbia or a territory, to such District or to such territory), for liquidated damages. Such liquidated damages shall be computed with respect to each individual laborer or mechanic, including watchmen and guards, employed in violation of the clause set forth in paragraph (1) of this section, in the sum of \$10 for each calendar day on which such individual was required or permitted to work in excess of the standard workweek of forty hours without payment of the overtime wages required by the clause set forth in paragraph (1) of this section.



(3) Withholding for unpaid wages and liquidated damages. The City shall upon its own action or upon written request of an authorized representative of the Department of Labor withhold or cause to be withheld, from any moneys payable on account of work performed by the contractor or subcontractor under any such contract or any other Federal contract with the same prime contractor, or any other federally-assisted contract subject to the Contract Work Hours and Safety Standards Act, which is held by the same prime contractor, such sums as may be determined to be necessary to satisfy any liabilities of such contractor or subcontractor for unpaid wages and liquidated damages as provided in the clause set forth in paragraph (2) of this section.

(4) Subcontracts. The contractor or subcontractor shall insert in any subcontracts the clauses set forth in paragraph (b)(1) through (4) of this section and also a clause requiring the subcontractors to include these clauses in any lower tier subcontracts. The prime contractor shall be responsible for compliance by any subcontractor or lower tier subcontractor with the clauses set forth in paragraphs (b)(1) through (4) of this section.

27. Rights To Inventions Made Under A Contract Or Agreement

If the Federal award meets the definition of "funding agreement" under 37 CFR § 401.2 (a) and the recipient or subrecipient wishes to enter into a contract with a small business firm or nonprofit organization regarding the substitution of parties, assignment or performance of experimental, developmental, or research work under that "funding agreement," the recipient or subrecipient must comply with the requirements of 37 CFR Part 401, "Rights to Inventions Made by Nonprofit Organizations and Small Business Firms Under Government Grants, Contracts and Cooperative Agreements," and any implementing regulations issued by FEMA. See 2 C.F.R. Part 200, Appendix II(F).

28. Byrd Anti-Lobbying Amendment 31 U.S.C. § 1352 (As Amended)

Byrd Anti-Lobbying Amendment, 31 U.S.C. § 1352 (as amended). Contractors who apply or bid for an award of \$100,000 or more shall file the required certification. Each tier certifies to the tier above that it will not and has not used Federal appropriated funds to pay any person or organization for influencing or attempting to influence an officer or employee of any agency, a member of Congress, officer or employee of Congress, or an employee of a member of Congress in connection with obtaining any Federal contract, grant, or any other award covered by 31 U.S.C. § 1352. Each tier shall also disclose any lobbying with non-Federal funds that takes place in connection with obtaining any Federal award. . Such disclosures are forwarded from tier to tier up to the recipient who in turn will forward the certification(s) to the awarding agency.
