- 1.2 **Classification**: The successful bidder will deliver F.O.B. destination, freight prepaid and allowed to the City of Canton, Ohio Engineering Department Traffic Signal and Traffic Sign Poles, Attachments and Accessories on an as needed basis per the specifications included in this Invitation to Bid.

## **3.0 REQUIREMENTS**

<u>ARTICLE 1</u>: The descriptions, manufacturer's name, and brand names used in these specifications are for the sole purpose of showing the quality and type of article expected. These are the acceptable minimums. All bids must be on materials, supplies or equipment which equals or exceeds all phases of these standards, as determined by the Board of Control. Any bidder bidding material, supplies or equipment different from those used in the specifications shall furnish with their bid, evidence that the item bid is of at least equivalent quality and type as those specified in the specifications. All exceptions to these specifications shall be so noted in the proposal.

#### **ITEMS 21A – 47A**

#### NOSTALGIA TRAFFIC SIGNAL AND LIGHTING POLES ATTACHMENT AND ACCESSORIES

This item shall be steel type signal poles of the anchor base variety. Poles shall maintain a 16flute cross-section and arms shall maintain an octaflute shape. It shall include all gauges and diameters of poles, including mast arms and their required fittings. The pole shaft shall be fabricated from a minimum of 11 gauge (.1196) hot rolled commercial steel. The shaft shall have only one (1) longitudinal, automatically, electrically welded joint, and shall have no intermediate horizontal joints nor welds. Only one (1) length of steel sheet shall be used, which shall be formed into a continuously tapered shaft, having a taper of .14" per foot.

After forming and welding, the tapered shaft shall be longitudinally cold rolled over a hardened steel mandrel under sufficient hydraulic pressure to flatten the weld and increase the physical characteristics of the shaft. The shaft shall meet the chemical and physical properties of ASTM-A595 grade A, having a minimum yield strength of 55,000 P.S.I. The cold rolling process shall also form a 16 flute cross section. The fluted shaft shall have sixteen (16) equally spaced Doric flutes, sharp and clear-cut throughout the entire length of the shaft. The radius of the flutes crest shall not exceed the thickness of the metal in the shaft. All steel items must be hot-dipped galvanized to AST A-123 and A-153 specifications, and the steel for the poles and arms shall originate in the United States. All manufacturing shall be completed in a plant certified to the American Institute of Steel Construction (AISC), Category 1. This certification must be presented with the bid submittal.

## INDIVIDUALLY ROLLED FLUTES OR ROUND POLES WITH A SEPARATE FLUTED SHEATHING WILL NOT BE ACCEPTABLE.

A. The steel base plate shall conform to ASTM-A36. It shall telescope the shaft and be attached by the means of two continuous welds, one on the inside of the base plate at the end of the shaft, and the other on the outside at the top of the base plate. The base plate shall accept four (4) <u>designed</u> anchor bolts on a <u>designed</u> inch bolt circle.

- **B.** The pole shaft shall be furnished with a 3" x 5" reinforcing handhole frame and a  $\frac{1}{2}$ " 13 UNC grounding provision.
- **C.** A steel fabricated tenon shall be welded to the top of the applicable lighting pole shaft and sized to accept the luminaire or crossarm as required.
- **D.** Welds: All welds shall meet the requirements of AW S D1.1.
- **E.** The anchor bolts shall have a minimum yield strength of 55,000 P.S.I. and meet the requirements of ASTM-A36M55. The threaded portion shall be galvanized and include two (2) galvanized hex nuts and washers per bolt.

Sections 153.001 and 153.99 of the Ohio Revised Code have been amended to provide enforcement of, and civil penalties for the violation of, statutory requirements that <u>domestic</u> <u>steel be used in all public improvements supported in whole or in part by state capital</u> <u>funds, which includes funding from the state capital improvements program and the local</u> <u>transportation improvements program.</u>

Poles and arms to be heavy duty galvanized and finish painted as per City Specification (Section VI Item Specifications).

A permanent legible marking indication shall be included on each pole and arm ordered. For a pole, the information shall include the following: Month/date of fabrication, pole gauge, bottom diameter, pole height, bolt circle, anchor bolt diameter, flange bolt diameter if mast arm pole, intersection and quadrant. The marking on the pole shall be near the handhole. For an arm, the information shall include the following: Month/date of fabrication, arm gauge, arm diameter, arm length, and connecting flange bolt diameter, intersection and quadrant. The marking on the arm shall be installed adjacent to the butt plate. Failure to provide this item, which must be easily legible, will result in rejecting shipment to successful bidder at their expense.

- **B. Design:** The entire assembly shall be designed to meet the requirements of the American Association of State Highway and Transportation Officials (AASHTO). Supporting calculations are required to meet <u>ODOT</u> wind zone requirements.
- **C. Warranty:** Material shall be warranted by the manufacturer for one year after delivery against defects resulting from faulty materials and workmanship.

#### Pole

A. The pole shaft shall be fabricated from a minimum of 11 gauge (.1196) hot rolled commercial steel. The shaft shall have only one (1) longitudinal, automatically, electrically welded joint, and shall have no intermediate horizontal joints nor welds. Only one (1) length of steel sheet shall be used, which shall be formed into a continuously tapered shaft, having a taper of .14" per foot.

After forming and welding, the tapered shaft shall be longitudinally cold rolled over a hardened steel mandrel under sufficient hydraulic pressure to flatten the weld and increase the physical characteristics of the shaft. The shaft shall meet the chemical and physical properties of ASTM-A595 grade A, having a minimum yield strength of 55,000 psi. The fold rolling process shall also form a 16 flute cross section. - **B.** The shaft shall include a fabricated or cast steel anchor plate from material having a 36,000 psi minimum yield strength. The plate shall be welded either to the inside of the shaft near the bottom or continuously welded to the outside end of the shaft. It shall include three (3) tapped holes on a 4" bolt circle to accept <sup>1</sup>/<sub>2</sub>" 13" connecting bolts for attachment to the ornamental base.
