#### **TECHNICAL SPECIFICATIONS:**

This Agreement is for furnishing and/or application of asphalt materials. Curry County requires an asphalt distributor and operator for all purchases made throughout this agreement. #### Sampling and Testing

When supplying asphalt products to the County, the selected bidder/provider shall abide by the following in addition to Section 402.2.1.5 Sampling and Testing:

 The selected provider will send certificates of compliance with each load of asphalt product delivered to the jobsite. The certifications of compliance will be given to the County Road Superintendent or Designee at the jobsite. All tankers shall be sealed when they arrive to the jobsite.

Each week in which the provider is shipping asphalt products, the County Road Superintendent or Designee will provide the selected provider a report of the following information:

- a. Project Scope
- b. Type of Material
- c. Amount of Material needed
- d. Date and time material is needed.

#### **Materials**

The selected provider will provide to the County Road Department proof that the asphalt materials provided have met the following specifications:

- High Float Emulsions Section 402 of the New Mexico State Department of Transportation Standard Specifications for Highway and Bridge Construction, special provisions and supplemental specifications (current editions).
- 2. Polymer Modified High Float Emulsions Section 402 of the New Mexico State Department of Transportation Standard Specifications for Highway and Bridge Construction, special provisions and supplemental specifications (current editions).
- 3. Asphalt Emulsified Prime Section 408 of the New Mexico State Department of Transportation Standard Specifications for Highway and Bridge Construction, special provisions and supplemental specifications (current editions).
- 4. Penetrating Emulsified Prime Section 408 of the New Mexico State Department of Transportation Standard Specifications for Highway and Bridge Construction, special provisions and supplemental specifications.

### **Project Delivery Requirements**

The selected provider is required to meet the project schedule, ensuring that materials and equipment (tanker and distributors) are at the job site as scheduled, ensuring that samplers, supplied by the selected provider, are available to sample when requested and within the required time limits and ensure that all material delivered to the project meet or exceed specifications. The selected provider will be responsible for all costs incurred, by the provider, which the County determines as not being applicable to the project.

#### **Demurrage**

Demurrage may be charged by the selected provider in the event a loaded tanker truck is on-site at the specified time, but is unable to unload asphaltic materials due to delay caused by the County. In the event demurrage charges are required by the selected provider, demurrage charges shall begin two (2) hours after the tanker truck arrives on site at the specified time and end once the tanker truck begins to unload. A two (2) hour unloading allotment time shall be provided by the selected provider at no charge.

#### **Freight for Returns**

Freight for returns may be charged by the selected provider in the event a fully or partially loaded tanker is returned to the supplier's plant by the County Road Superintendent or his written designee. Freight for returns can only be charged if the loaded tanker arrived on-site at the specified time, with the specified load, but was unable to be utilized on the project due to circumstances beyond the selected provider's control. Freight for returns applies to costs incurred by the selected provider and shall be quantified and paid by the number of tons returned. Pump and hose charges associated with return shall be inclusive of the selected providers bid for the item freight for return.

### **Method of Measurement and Payment:**

All quantities are to be measured by the Road Superintendent or designee and shall be considered final and all payments for the same will be made on this basis.

#### **CONTRACT**

The anticipated term of a contract awarded as a result of this BID shall be from March 28, 2023 for one (1) year. The contract may be renewed according to the terms stated herein for three (3) additional one (1) year periods, not to exceed a maximum of four (4) years. All prices, costs and conditions submitted in response to this Invitation to Bid shall remain fixed and valid after the closing date for this bid submission and throughout the term of the agreement. The County shall have the option of renewing the existing contract, by mutual agreement, with approval by the Board of Commissioners, or requesting new Bids for services. The rates may be negotiated for each renewal year of the contract. A breach of any terms of the contract shall be grounds for immediate termination of the contract. Either party may terminate the contract for any reason upon written notice to the other party, made at least ninety (90) days in advance of the termination date.

#### RESERVATIONS

The Curry County Commission reserves the right to reject any or all bids, to waive any technicalities, to accept in whole or in part such bid or bids as may be deemed in the best interest of the County.

#### **SAFETY REQUIREMENTS**

It shall be the contractor's responsibility to provide for the safety of its workers and the public in compliance with the requirements of insurance and public health and safety standards.

#### **AWARD**

The award may be made to the bidder providing a responsive, responsible bid which results in the lowest overall cost to the County. #### **GENERAL CONDITIONS**

- 1. Bid Forms: All pages included in this Invitation to Bid that are marked "BID FORM" must be completed and returned as part of the bid document. All bids must be completed and securely sealed prior to submitting to the purchasing office. No unsealed, faxed or e-mailed bids are acceptable.
- 2. Bids Binding Ninety (90) days: Unless otherwise specified all formal bids submitted shall be binding for ninety (90) calendar days following bid opening date, unless the bidder(s), upon request of the County Manager, agrees to an extension.
- 3. Payment Terms: For all services provided by Contractor, payment shall be made net thirty (30) days from invoice date after receipt of goods/services unless otherwise specified on bid form or as otherwise agreed by both parties. All invoices shall be submitted directly to the Curry County Finance Department at 417 Gidding, Suite 100, Clovis, NM 88101. The successful bidder must have submitted a completed W9 form on file with the County prior to any payments being issued.
  - For all services paid by Credit Card, standard payments are usually made within 3-5 business days. All services made by credit card require a receipt. Invoices shall not be submitted separately if payment is made with credit card. Curry County shall not pay any fees when utilizing a credit card for payment.
- 4. Equivalency: The County hereby reserves the right to approve as equivalent, or to reject as not being equivalent, any item the bidder proposes to furnish which contains variations from specification requirements but may comply substantially therewith. Such decisions are strictly at the discretion of the County.

- 5. If there is any clarification, problem, ambiguity, or question regarding this bid, you must contact the Purchasing Agent or designee prior to the bid opening. Clarifications and addenda will be considered prior to the bid opening. Answers provided regarding the bid specifications or bid package MUST be answered by the Purchasing Agent or designee. Questions answered by any other person or County official shall not be considered applicable to the legal provisions of this bid, except as specifically authorized by the Purchasing Agent.
- 6. Restrictive Specifications: It is the responsibility of the prospective bidder to review the entire Invitation to Bid (ITB) packet and to notify the purchasing department if the specifications are formulated in a manner which would unnecessarily restrict competition. Any such protest or question regarding the specifications or bidding procedures must be received in the purchasing department not less than seventy-two (72) hours prior to the time set for bid opening.
- 7. An in-state resident or resident veteran preference will be given to all resident New Mexico businesses that have been issued certification by the State of New Mexico. To qualify for the preference, the bidder must list a valid resident business certificate number and shall submit a copy of the certificate with the bid. If you have a question regarding a Resident Business (or Resident Veteran Business) Certification, or wish to be given a number, you may contact the New Mexico State Department of Taxation and Revenue at 505-827-0951. This number is valuable to have as it allows the county to consider your bid at five (5) to ten (10) percent less than the amount submitted, and could mean a difference in award. Please note that this number is NOT your State CRS Number (i.e. 01-503047-004). In addition, any preference numbers issued by the NM State Purchasing Office were valid only through December 31, 2011 and must be re-issued through the Taxation and Revenue Department.
- 8. Bidders shall list on a separate sheet of paper any variations from or exceptions to the conditions and specifications of this bid. <u>This sheet shall be labeled</u> <u>"Exception(s) to Bid Conditions" and shall be included with bid.</u>
- 9. Non-collusion: Bidders, by submitting a signed bid, certify that the accompanying bid or proposal is not the result of, or affected by, any unlawful act of collusion with any other person or company engaged in the same line of business or commerce, or any other fraudulent act punishable under New Mexico or United States law.
- 10. Non-discrimination Statement: Curry County in accordance with the provisions of Title VI of the Civil Rights Act of 1964 (78 Stat. 252, 42 U.S.C. §§ 2000d to 2000d-4) and the Regulations, hereby notifies all bidders that it will affirmatively ensure that any contract entered into pursuant to this advertisement, disadvantaged business enterprises will be afforded full and fair opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, or national origin in

- 11. Qualifications of Bidders: The County Purchasing Officer may make such investigations as he/she deems necessary to determine the ability of the bidder to perform the work, and the bidder shall furnish to the County all such information and data for this purpose as the County may request. The County reserves the right to reject any bid if the evidence submitted by, or investigation of, such bidder fails to satisfy the County that such bidder is properly qualified to carry out the obligations of the contract and to complete the work contemplated therein.
- 12. The State of New Mexico's Procurement Code, Section 13-1-28 through Section 13-1-199 NMSA 1978, imposes civil and criminal penalties for its violations. In addition, the New Mexico Criminal Statutes impose felony penalties for illegal bribes, gratuities and kickbacks.
- 13. Curry County reserves the right to reject any bid from a bidder who previously failed to perform properly, or complete on time, contracts of a similar nature, or to reject the bid of a bidder who is not in a position to perform such a contract satisfactorily. Such is at the discretion of the County.
- 14. The successful bidder agrees to protect, defend and save the County, its elected and appointed officials, agents, and employees, while acting within the scope of their duties as such, harmless from and against all claims, demands, causes of action of any kind or character, including the cost of defense thereof, arising in favor of the contractor's employees or third parties on account of bodily or personal injuries, death, or damage to property arising out of services performed or omissions of services or in any way resulting from the acts or omissions of the contractor and/or its agents, employees, representatives, assigns, subcontractors, except the sole negligence of the County under this agreement.
- 15. If a bidder to whom a bid is awarded refuses to accept the award or, fails to deliver in accordance with the contract terms and conditions, the County may, in its discretion, suspend the bidder/contractor for a period of time from entering into any contracts with Curry County.
- 16. This solicitation is governed by the laws of the State of New Mexico. By signing and submitting a bid, the parties agree that any litigation concerning this bid, request for proposal, limited solicitation, or subsequent contract or purchase order, must be brought in the Ninth Judicial District in and for Curry County, State of New Mexico, and each party shall pay its own costs and attorney fees.
- 17. Successful bidder must, in performance of work, agree to fully comply with all applicable federal, state and local laws, rules and regulations. The provider will be required to carry the following minimum insurance coverage with Curry County named as additional insured on all policies:

The County guarantees that any addenda issued will be distributed and available to every party on the Distribution List for this solicitation. The County will not accept responsibility for addenda not being obtained and will not guarantee that addenda will be forwarded or available if the original packet was not obtained as directed.
- 19. The successful bidder shall not subcontract any portion of this Agreement without the prior written approval of the County. No such subcontracting shall relieve the Bidder from its obligations and liabilities under this Agreement, nor shall any subcontracting obligate payment from the County.

# BID FORM 3 CAMPAIGN CONTRIBUTION DISCLOSURE FORM

Pursuant to the Procurement Code, Sections 13-1-28, et seg., NMSA 1978 and NMSA 1978, § 13-1-191.1 (2006), as amended by Laws of 2007, Chapter 234, any prospective contractor seeking to enter into a contract with any state agency or local public body for professional services, a design and build project delivery system, or the design and installation of measures the primary purpose of which is to conserve natural resources must file this form with that state agency or local public body. The state agency or local public body that procures the services or items of tangible personal property shall indicate on the form the name or names of every applicable public official, if any, for which disclosure is required by a prospective contractor.

THIS FORM MUST BE INCLUDED IN THE REQUEST FOR PROPOSALS AND MUST BE FILED BY ANY PROSPECTIVE CONTRACTOR WHETHER OR NOT THEY, THEIR FAMILY MEMBER, OR THEIR REPRESENTATIVE HAS MADE ANY CONTRIBUTIONS SUBJECT TO DISCLOSURE.

The following definitions apply:

"Applicable public official" means a person elected to an office or a person appointed to complete a term of an elected office, who has the authority to award or influence the award of the contract for which the prospective contractor is submitting a competitive sealed proposal or who has the

- "Campaign Contribution" means a gift, subscription, loan, advance or deposit of money or other thing of value, including the estimated value of an in-kind contribution, that is made to or received by an applicable public official or any person authorized to raise, collect or expend contributions on that official's behalf for the purpose of electing the official to statewide or local office. "Campaign Contribution" includes the payment of a debt incurred in an election campaign, but does not include the value of services provided without compensation or unreimbursed travel or other personal expenses of individuals who volunteer a portion or all of their time on behalf of a candidate or political committee, nor does it include the administrative or solicitation expenses of a political committee that are paid by an organization that sponsors the committee.
