### **CONDITIONS:**

Awards will be made to the lowest responsible bidder. The awarded contract shall be for a One (1) year time frame. The Community Development Department reserves the right to extend this contract for a period of three (3) years, if no changes to terms and requirements of this contract are made. The Community Development Department reserves the right to terminate the contact at any time if the terms, requirements, and/or quality of workmanship are not to the satisfaction of the Codes Administrator. The successful bidder shall have email abilities and communications between the Code Administrator and the awarded contractor shall be through this manner.

The City of Springfield reserves the right to reject any or all quotes, to waive any informality in the bids, to accept in whole or in part such bid or bids as may be deemed in the best interest of the City of Springfield.

The successful bidder will be required to provide traffic control per the MUTCD manual for those areas involving traffic flow. Quality of the materials to be supplied and the ability to meet the required specifications will be reviewed.

Contractor agrees to protect, indemnify and hold the City of Springfield harmless from any and all damage, loss, claims, judgments or expenses, including but not limited to reasonable attorney's fees which the City of Springfield may suffer or be subjected to by the performance of the work, and including but not without limitation to injury or death of any person whomever and destruction or damage to any property whatsoever.

The successful bidder shall maintain insurance and provide the City of Springfield with a *Certificate of Insurance naming the City as an additional insured* including the following:

- a. General Liability – minimum \$1,000,00,000
- b. Workman's Compensation – if required by law
- c. Vehicle Liability

### **Contract Mowing & Clearing Rubbish for the Community Development (Codes) Department:**

Bidder shall provide pricing for mowing various lots in the city. The mowing shall be done at the request of the Community Development Department within one week (7 days) from the time of notification from the Community Development Department. The lots will be in violation of the City's high grass and weed ordinance.

Bidder requested to provide pricing on individual cases to clear and remove rubbish of every kind and character from various lots within the city. Every kind and character shall include down trees, overgrown shrubs, trees, vines, wild brush, and landscaping. The maximum pricing not to exceed \$1500.00.

The ordinance requires that weeds and vegetation on lots in the City not exceed one foot (12 inches) in height. The owners of lots in violations are given 10 days to mow. If the lots are not mowed within that time, the Community Development Department will contact the successful bidder to mow the property.

Bids should be submitted on a price per the first one-half (1/2) acre increment and a price per any additional one-half ½ acre increments of the lot or property to be mowed. Some lots may have to be mowed with a Bush Hog or similar device.

The mowed lots will need to be free of all litter **before and after** mowing and the lots need to be trimmed as necessary.
