Asphalt Paving and Patching Specifications

The City of Etowah is seeking a per square foot cost for patching and paving roads and select overlay sites throughout the City boundaries. The City of Etowah will provide lists of patching/paving/overlay periodically throughout the year for work to be scheduled.

- Per square Foot Cost July 1, 2022 - June 30, 2023
- Minimum patching depth will be 4"
- Minimum overlay will be 2"
- Cost should also reflect aggregate removal from cut before asphalt is placed.
- The City of Etowah will NO LONGER provide a dump site for the removed aggregate.
- Proof of Insurance will be required to be submitted with bid packet for workers comp and liability
