2. UTILITIES SHOWN ON THE PLANS ARE FOR REFERENCE ONLY AND MAY NOT BE COMPLETE. THE CONTRACTOR SHALL LOCATE ALL ABOVE GROUND AND SUBSURFACE UTILITIES WITHIN THE PROJECT LIMITS AND, IF NECESSARY, PHYSICALLY EXPOSE UTILITY FACILITIES THAT MAY BE AFFECTED PRIOR TO INSTALLATION OF ANY PLANT MATERIAL.
3. THERE WILL BE NO SEPARATE COMPENSATION FOR PERFORMING THIS UTILITY LOCATE WORK. ALL COSTS SHALL BE INCLUDED IN THE UNIT COST FOR PLANT MATERIAL.

PERMITS:

1. THE CONTRACTOR SHALL BE RESPONSIBLE FOR OBTAINING, INCLUDING ALL COSTS ASSOCIATED WITH OBTAINING, ANY AND ALL PERMITS REQUIRED FOR THE PROJECT.

TEMPORARY TRAFFIC CONTROL NOTES:

1. DURING CONSTRUCTION, THE REGULATED SPEED LIMITS ON SR5A (NOVA RD.) OF 45 MPH AND 50 MPH SHALL REMAIN IN EFFECT.
2. PRIOR TO BEGINNING WORK THE CONTRACTOR SHALL SUBMIT TO THE CITY TRAFFIC OPERATIONS MANAGER A TRAFFIC CONTROL PLAN FOR REVIEW AND APPROVAL. LANE CLOSURES AND CONSTRUCTION ACTIVITIES MUST COMPLY WITH PROVISIONS AS OUTLINED IN FDOT LANE CLOSURE POLICY AND PROCEDURE. COORDINATE ALL LANE CLOSURES REQUESTS WITH THE CITY TRAFFIC OPERATIONS MANAGER, THE VOLUSIA COUNTY TRAFFIC ENGINEER AND THE FDOT PROJECT MANAGER. REQUESTS ARE TO BE SUBMITTED TWO (2) WEEKS IN ADVANCE OF ANY REQUIRED LANE CLOSURES.
3. ALL HAULING OPERATIONS THAT UTILIZE THE FDOT ROADWAY SHALL BE PROHIBITED FROM 5:00 AM TO 10:00 AM AND FROM 3:00 PM TO 8:00 PM DURING ALL WEEKDAYS TO MINIMIZE IMPACT TO TRAFFIC FLOW. HOURS MAY VARY ONLY WITH APPROVAL BY THE CITY TRAFFIC OPERATIONS MANAGER AND FDOT.
4. NO LANE CLOSURES SHALL BE ALLOWED WITHIN 600 FT. OF SIGNALIZED INTERSECTION FROM 7:00 AM TO 8:00 PM Daily". ONLY ONE LANE MAY BE CLOSED IN EACH DIRECTION

SIGNS:

EXISTING SIGN POST LOCATIONS HAVE NOT BEEN SHOWN IN THESE PLANS. ALL PRESENT TRAFFIC SIGNS AND DELINEATOR POSTS INCLUDING TEMPORARILY ONE ARE TO REMAIN IN PLACE

LANDSCAPE NOTES:

1. DELINEATE ALL PROPOSED BED AREAS AND FLAG ALL TREE AND PALM LOCATIONS PRIOR TO INSTALLATION. ALL PLANTING LOCATIONS MUST BE APPROVED BY, AND MAY BE ADJUSTED BY, THE LANDSCAPE ARCHITECT OR CITY PROJECT MANAGER.
2. CONTRACTOR IS RESPONSIBLE FOR THEIR OWN PLANT QUANTITY TAKE-OFF AND SHALL PROVIDE ALL PLANT MATERIAL REQUIRED AS SHOWN ON LANDSCAPE PLANS.
3. MULCH BEDS AND TREE RINGS WITH A 3" WETTED LAYER OF PINE STRAW MULCH.
4. CONTRACTOR SHALL GUARANTEE ALL INSTALLED PLANT MATERIAL FOR 1 CALENDAR YEAR FROM THE DATE OF ACCEPTANCE BY THE CITY AND FDOT. ANY SICK OR DEAD MATERIAL SHALL BE REPLACED IMMEDIATELY UPON NOTIFICATION BY THE CITY.
5. FERTILIZER SHALL BE APPLIED TO ALL PLANTING AREAS AT THE RATE OF 1½ LBS. OF ACTUAL NITROGEN, 1½ LBS. OF ACTUAL PHOSPHORUS, AND 1½ LBS. OF ACTUAL POTASH PER 1000 SQUARE FEET OF PLANTING AREA.
6. LANDSCAPE MATERIAL SHALL BE ADJUSTED IN THE FIELD TO AVOID CONFLICTS WITH ANY UTILITY STRUCTURES, DRAINAGE STRUCTURES, DITCHES, UNDERDRAINS, DITCH BLOCK, STORMWATER MANAGEMENT FACILITIES, DRAINAGE DISCHARGE PATHS, TRAFFIC SIGNAGE, ITS CAMERAS, LIGHTING AND THEIR APPURTENANCES. IF A CONFLICT EXISTS, THE CONTRACTOR SHALL NOTIFY THE LANDSCAPE ARCHITECT OR CITY PROJECT MANAGER PRIOR TO THE COMMENCEMENT OF ANY ACTIVITY. THE CONTRACTOR SHALL NOT KNOWINGLY PLACE PLANTS WHERE SUCH A CONFLICT EXISTS. ANY COSTS TO REMOVE AND/OR REPAIR WORK PLACED THAT HAS NOT BEEN APPROVED BY THE LANDSCAPE ARCHITECT OR CITY PROJECT MANAGER SHALL BE AT THE CONTRACTORS EXPENSE.

7. ALL EXISTING SIGNS ARE TO REMAIN, VERIFY ALL SIGN LOCATIONS TO ENSURE PROPOSED LANDSCAPING WILL NOT CONFLICT WITH CLEAR SIGHT TO ALL SIGNS. ANY SIGNS DAMAGED BY THE CONTRACTOR DURING CONSTRUCTION SHALL BE REPLACED AT NO ADDITIONAL COST. NOTIFY THE LANDSCAPE ARCHITECT OR CITY PROJECT MANAGER OF ANY POTENTIAL CONFLICTS WITH THE PROPOSED LANDSCAPE IMPROVEMENTS.
8. THERE IS EXISTING IRRIGATION IN THE MEDIANS FROM BEVILLE ROAD TO BELLEVUE AVE. THE CONTRACTOR IS RESPONSIBLE FOR REPAIRING ANY DAMAGE TO THIS SYSTEM CAUSED BY HIS OPERATIONS AND TO MAKE NECESSARY ADJUSTMENT TO ACCOMMODATE NEW PLANTINGS. THIS WORK IS TO INCLUDE ALL LABOR AND PLANT MATERIALS NECESSARY TO PROVIDE 100% COVERAGE OF ALL NEW PLANTINGS AND TO ENSURE THAT SPRAY PATTERNS DO NOT ENCROACH INTO EXISTING DRIVE LANES AND REMAIN WITHIN LANDSCAPE MEDIANS. THE COST OF THIS WORK WILL BE INCLUDED IN THE UNIT COST FOR PLANT MATERIALS. THE COST OF ANY SUCH REPAIRS SHALL BE CONSIDERED PART OF THE UNIT PLANT COSTS.

1. THE PLANS AND DRAWINGS ARE DIAGRAMMATIC OF THE WORK TO BE PERFORMED. SOME COMPONENTS MAY BE SHOWN OUTSIDE THE WORK AREA FOR CLARITY. THE WORK SHALL BE EXECUTED IN A MANNER TO AVOID CONFLICTS WITH UTILITIES AND OTHER ELEMENTS OF CONSTRUCTION, INCLUDING LANDSCAPE MATERIALS. ALL DEVIATIONS FROM THE PLANS SHALL BE APPROVED BY THE OWNER'S REPRESENTATIVE BEFORE BEING INSTALLED. THE CONTRACTOR SHALL NOT WILLFULLY INSTALL ANY ASPECT OF THE IRRIGATION SYSTEM AS SHOWN ON THE PLANS AND DRAWINGS, WHEN IT IS OBVIOUS IN THE FIELD THAT OBSTRUCTIONS, GRADE DIFFERENCES, OR DISCREPANCIES EXIST THAT MIGHT NOT HAVE BEEN KNOWN DURING THE DESIGN OF THE IRRIGATION SYSTEM. IN THE EVENT THAT NOTIFICATION OF THE CONFLICT IS NOT APPROVED BY THE OWNER'S REPRESENTATIVE, THE CONTRACTOR WILL ASSUME FULL RESPONSIBILITY FOR ALL REVISIONS.
2. THE IRRIGATION SYSTEM SHALL BE INSTALLED IN ACCORDANCE WITH THE PLANS, IRRIGATION SYSTEM SPECIFICATIONS AND ALL CONTRACT DOCUMENTS. THE CONTRACTOR SHALL COMPLY WITH ALL PREVAILING LOCAL CODES, ORDINANCES, AND REGULATIONS.
3. CONTRACTOR SHALL VERIFY ALL SITE CONDITIONS, INCLUDING UTILITY LOCATIONS, BEFORE INSTALLATION OF THE IRRIGATION SYSTEM. ALL UTILITIES AND STRUCTURES MAY NOT BE SHOWN ON THE PLANS - CONTRACTOR TO VERIFY. COORDINATE ALL IRRIGATION SYSTEM CONSTRUCTION WITH EXISTING AND NEW PLANTINGS TO AVOID CONFLICT OR INTERFERENCE WITH LOCATION OF PIPING, SLEEVING, CABLES, AND SERVICE UTILITIES. THE CONTRACTOR IS RESPONSIBLE FOR COORDINATING INSTALLATION WITH ALL OTHER CONSTRUCTION ON SITE, ESPECIALLY LANDSCAPE INSTALLATION. IRRIGATION SYSTEM SHALL BE RELOCATED AT NO ADDITIONAL COST FOR ANY CONFLICT WITH LANDSCAPE INSTALLATION OR ANY OTHER SITE CONSTRUCTION OR EXISTING CONDITIONS. ALL COMPONENTS THAT ARE NOT CONTAINED WITHIN THE SPECIFIC AREAS SHOWN OR CALLED OUT ON THE DRAWINGS WILL NOT BE ACCEPTED. ALL PIPING AND OTHER COMPONENTS ARE TO REMAIN WITHIN THE PROPERTY OF THE OWNER.
4. WHERE EXISTING OR NEW TREES, LIGHT STANDARDS, SIGNS, ELECTRONIC CONTROLLERS AND/OR OTHER OBJECTS ARE AN OBSTRUCTION TO AN IRRIGATION SPRINKLER'S PATTERN, THE COMPONENT AND PIPING SHALL BE RELOCATED AS NECESSARY TO OBTAIN PROPER COVERAGE OF AN IRRIGATION SPRINKLER'S PATTERN, THE COMPONENT AND PIPING SHALL BE RELOCATED AS NECESSARY TO OBTAIN THE PROPER COVERAGE WITHOUT DAMAGING THE OBSTRUCTION. OWNER'S REPRESENTATIVE SHALL DETERMINE WHETHER AN OBSTRUCTION OCCURS OR NOT.
5. COMPONENT SPACINGS ARE MAXIMUM. DO NOT EXCEED SPACINGS SHOWN OR NOTED ON THE PLANS. 8. IRRIGATION CONTRACTOR SHALL ADJUST ALL SPRINKLERS, CONTROLLER AND OTHER DEVICES TO OBTAIN SPECIFIED OPERATING PARAMETERS, INCLUDING COVERAGE, OPERATING PRESSURE, FLOW RATES AND OPERATION TIME, AS INDICATED ON THE DRAWINGS AND IN THE IRRIGATION SYSTEM SPECIFICATIONS.
9. CONTRACTOR TO PROVIDE INSTALLATION SHOP DRAWINGS AND MANUFACTURER PRODUCT INFORMATION FOR ALL IRRIGATION COMPONENTS. ALL INSTALLATIONS SHALL BE AS RECOMMENDED BY MANUFACTURERS. THE QUANTITIES SHOWN IN THE LEGENDS AND SYMBOL SHEETS SHALL NOT BE USED FOR BIDDING PURPOSES. THE CONTRACTOR WILL BE RESPONSIBLE FOR CONDUCTING A COMPREHENSIVE MATERIALS TAKEOFF TO DETERMINE THE ACTUAL QUANTITIES OF MATERIAL NECESSARY TO EXECUTE THE WORK DESCRIBED IN THE DOCUMENTS.


VALVE BOX DETAIL




TRENCH, PIPE, AND WIRE DETAIL


IRRIGATION HEAD INSTALLATION NEXT TO ROADWAY
