

SPECIFICATIONS FOR ANNUAL CONTRACT TO SUPPLY

PAINTING AND RELATED SURFACE PREPARATION SERVICES FOR THE WASTE RESOURCES DIVISION CITY OF CHATTANOOGA, TENNESSEE May 2017

1.0 GENERAL

1.1 SCOPE OF SERVICES

The Scope of Services included in these Specifications shall be for all labor, benefits, equipment, fuel, and any other related expenses necessary to provide painting and related surface preparation services for the WASTE RESOURCES DIVISION including the Moccasin Bend Wastewater Treatment Plant (MBWWTP), 455 Moccasin Bend Road, Chattanooga, Tennessee 37405; pump stations throughout the Interceptor Sewer System.

It is the responsibility of each bidder to visit both the Moccasin Bend Wastewater Treatment Plant and other locations within the WASTE RESOURCES DIVISION to determine the types, sizes, and quantities of required painting and related surface preparation services and any peculiar circumstances which may be associated with the painting and related surface preparation services.

Any questions or comments related to the services described in these Specifications may be directed to the Plant Maintenance Manager at Moccasin Bend Wastewater Treatment Plant, 455 Moccasin Bend Road, Chattanooga, Tennessee 37405 (423) 757-5026.

1.2 BASIS OF BIDDING

The Contractor shall submit one (1) bid on the City's Standard Bid Form. The Bid shall include the cost per hour for labor and equipment and percent markup on materials and specialized outside services not normally performed by the Vendor

The cost per hour shall include any and all, costs for wages, benefits, indirect costs, overhead and profit, insurance, and any other related direct or indirect cost. The cost per hour shall be for the services of one (1) senior worker and one (1) worker/labor and any and all equipment necessary to perform the work described herein.

Specialty equipment, materials and services required for the work but not described herein will be invoiced by the Vendor at cost plus a percent markup.

The Vendor shall also provide hourly rates for overtime and holiday work for the various work described herein.

Cost of these services shall be subject to all of the requirements of the Specifications.

The bid shall be awarded on the basis of the unit cost per hour to provide painting and related surface preparation services for the Waste Resources Division as well as an evaluation of the Vendor's qualifications, experience, capabilities and other factors specified in the City Code.

The City of Chattanooga reserves the right to reject any and/or all bids, to waive any information in Bids received, and to accept any Bid which in its opinion may be in the best interest of the city.

1.3 SUBMITTALS

1.3.1 Bid Bond

1.3.2 Performance Bond

1.3.3 References, Vendor-owned Equipment, and Experience

A. References

The Vendor shall submit a minimum list of five (5) customers for whom the Vendor has performed painting and related surface preparation services during the past three- (3) years and provided labor and equipment and materials to perform similar services.

There shall be at least one (1) customer where the work was performed in confined spaces. There shall be at least one (1) customer where the work was performed in excess of 30 feet above surrounding services.

The list shall include names, addresses, telephone numbers, and contact person who is knowledgeable of services provided.

B. Vendor Owned Equipment

The Vendor shall provide with the Bid a list of Vendor-owned equipment.

The Vendor shall provide the minimum equipment listed below necessary to perform the service requirements described herein requirements. Vendor-owned equipment shall include the at least the following equal or better:

- 1. 1 ea 600 pound Sandblaster, equipment, hoses, safety gear
- 2. 2 ea 185 PSI Air Compressors
- 3. 2 ea Professional Airless Paint Sprayers (Must be able to spray Epoxies)
- 4. 1 ea 130 foot sky climber
- 5. 65 ft breakable scaffolding

C. Experience

The Vendor shall have a minimum of 15 years experience providing all of painting and related surface preparation services described herein. This work experience shall include work in confined spaces and elevated work in excess of 30 feet above surrounding surfaces.

The Vendor shall certify that he/she is proficient in the operation of special equipment, including but not limited to, hydraulic lifts, sand blasters, water blasters, bucket trucks, and airless sprayers.

D. Workers Qualifications

Resumes including a description of their related experience of key employees that will be performing the painting and related surface preparation services shall be provided with the Bid.

E. Failure to provide these submittals at the time of the Bid may result in the Vendor's bid being disqualified.

1.4 GENERAL CONDITIONS AND INSTRUCTIONS TO BIDDERS

The Vendor shall comply with rules and conditions found in the City of Chattanooga's Standard Terms and Conditions (http://www.chattanooga.gov/purchasing/standard-terms-and-conditions).

1.5 LENGTH OF CONTRACT

The Contract for services described herein shall be for a period of one (1) year beginning the effective date of the award of the Contract. The Vendor shall provide a firm hourly rate for the first year of the Contract.

The City shall have the option of extending the Contract for Two (2) additional one (1) year periods at the Vendor's hourly rate.

1.6 INSURANCE

The Vendor shall, proper to the award of the Contract, furnish proof and maintain in force the following types of insurance at the minimum limits specified below:

Copies of the current insurance certificate(s) shall be provided to the City prior to any work being performed. Insurance shall be kept in force during the entire length of the contract.

1.7 WARRANTY

The Vendor shall warrant and guarantee the work performed for a period of ninety (90) days following delivery of the work to the City. The work shall be guaranteed and warranted against defective workmanship and materials.

2.0 SERVICES AND OTHER REQUIREMENTS

2.1 GENERAL

2.1.1 Sole Vendor

The Vendor shall not subcontract the services or assign the contract to others without the written consent of the City.

2.1.2 Compliance with Applicable Regulations

All of the services provided by the Vendor shall be completed in a good and workmanlike manner. All services provided shall be in compliance with all applicable statues, rules, ordinances and regulations of, but not limited to, the USEPA, TDOT, OHSA, and any similar federal, state, and local laws or regulations applicable to the Vendor or to the services described herein.

The Vendor's personnel shall comply with all City, Waste Resources Division, and Moccasin Bend WWTP work rules and regulations when on site.

The Vendor shall submit a written safety plan to MBWWTP Occupational Safety Specialist prior to beginning the contract work.

If requested the Vendors personnel shall clock in and out daily using the provided City time clock system. This will be used to track what personnel are onsite and not for pay purposes.

2.1.3 Inspection

The services furnished by the Vendor shall be subject to inspection and approval by the City's designated representative, but the manner and method of providing the services shall be the responsibility of the Vendor.

2.1.4 Failure to Provide Services and Termination of Contract

In the event the Vendor:

- a. Fails to initiate services on the date specified or otherwise agreed to;
- b. Fails to provide all of the required documentation for his personnel, insurance, and any other documentation required by these Specifications at the specified times:
- c. After having begun services, abandons them for any reason;
- d. Suspends or refuses to continue services; or
- e. Defaults in any manner in the performance under the terms of the Contract for a period of two (2) consecutive working days (unless the Vendor is prevented from continuing for reasons beyond its control);

The City of Chattanooga shall have the right to terminate the Contract immediately upon the written notification by the City for the reasons listed above and the City shall complete the Contract or have the services completed by another vendor in any reasonable manner at the Vendor's expense.

The City shall have the right to terminate the Contract after giving a thirty-day (30) written notice to the Vendor.

2.2 DESCRIPTION OF CONTRACTED SERVICES

2.2.1 General

A. The Vendor shall provide all labor, benefits, equipment, fuel, materials and any other related expenses necessary provide painting and related surface preparation services described herein for the WASTE RESOURCES DIVISION.

- B. The Vendor shall provide the services on an "as needed" basis as requested by the City. The City will attempt to schedule the work to optimize the use of the Vendor's workers and equipment when it is needed.
- C. The Vendor shall perform work on straight time, i.e., non-emergency, unless otherwise noted. Overtime, weekend, or holiday work shall only be performed at the City's direction.
- D. The Vendor shall provide the equipment specified and expendable materials required for performing the scope of services. The equipment purchase, maintenance, and operational charges will be included in the fully burden labor rates listed on the **Bid Form**. No additional charges for the use of this list of equipment shall be billed.
- E. The Vendor shall supply all incidentals such as nozzles, gas, tips, brushes, rollers, plastic and fabric cover cloths, rags, sand paper, steel wool, etc. The cost for provision of these items shall be included in the labor rates given on the **Bid Form**.
- F. The Vendor shall provide restoration maintenance support of the City waste water facilities and other systems of similar architecture, to include sand blasting, paint removal, hot and cold water blasting, applications of various types of painting products to include epoxies, urethanes, latex enamels, oil based paints, and lacquer based paints.

2.2.2 Vendor Services

- A. The Vendor shall be prepared to perform the following:
 - 1. Sand Blasting
 - 2. Hot/Cold Water Pressure Water Blasting/Cleaning
 - 3. Airless and Air Spray Painting
 - 4. Brush/Roller Painting
 - 5. Elevated work greater that 30'
 - 6. Confined Space work (Inside tanks, sewers, pump stations, etc...)
 - 7. Protection of City property from paint overspray
 - 8. Protection of Personnel property from paint overspray
- B. The Vendor shall provide the labor and equipment necessary to perform the requested restoration/cleaning by means of sand blasting to include brush blasting, near white blasting, white blasting, and other levels of surface preparation that might be required by sand blasting. This also includes work in areas where nuts shells are to be used in the place of sand.
- C. The Vendor shall provide the labor and equipment necessary to perform the requested restoration/cleaning by means of high pressure water blasting to include hot and cold water systems. This work shall include cleaning pump station wet wells, exteriors and interiors of concrete, steel, and fiberglass

- tanks, CSO facilities, and other areas that may needed cleaning by this method.
- D. The Vendor shall provide the labor and equipment necessary to perform the requested airless and air spray paint and coating applications at specified thicknesses. These applications shall include the application of oil based enamels and primers, latex based enamels and primers, epoxies and primers, urethanes and primers, lacquer and primers, and other protective coating materials.
- E. The Vendor shall provide the labor and equipment necessary to perform the requested roller and brush paint applications. These applications shall include the application of oil based enamels and primers, latex based enamels and primers, epoxies and primers, urethanes and primers, lacquer and primers, and other protective coating materials.
- F. The Vendor shall provide the labor and equipment for providing specified painting and related surface preparation services at elevations in excess of 30 feet above the surrounding area. The Vendor and his/her shall be well trained in the safety and use of equipment to work at these elevations. No work shall be performed at these elevations by untrained or unqualified workers.
- G. The Vendor shall provide the labor and equipment for providing specified painting and related surface preparation services at in confined spaces. The Vendor and his/her shall be well trained in the safety and use of equipment to work in confined spaces. No work shall be performed in confined spaces by untrained or unqualified workers.
- The Vendor shall coordinate all proposed painting and related surface preparation services with the City prior to execution to ensure all personal property and City facilities are thoroughly protected from paint overspray. Every effort will be made to move personal property from the potential fallout area. When personal or city property cannot be moved out ofthe potential area, the contractor shall properly cover all areas at risk of overspray.

2.2.3 City Supplied Services

- A. The City will provide the following services:
 - 1. The City shall provide the facilities, special equipment and supplies as specified in each individual task orders.
 - 2. No alterations to the City facilities shall be made without specific written permission from the City. These facilities shall only be used in performance of this contract.
 - 3. The City will provide associated materials associated with the work paints, thinners, solvents, cleaning agents (soaps, degreasers, and disinfections agents), and blasting sand
 - 4. The City will provide all electricity, water, and wastewater at City

facilities.

- 5. The City will attempt, when available, to provide reasonable storage space for spare parts and working space including heat, light, ventilation, electric current and outlets for the use of Vendor maintenance personnel. The City will not be responsible for any Vendor equipment left at or stored at any City facilities.
- 6. The City will provide facilities and/or equipment for the destruction of hazardous waste that may have been uncovered or generated as apart of the performance of these services
- 7. The City will provide and maintain its normal fire detection equipment, fire alarms, and extinguishers and provide periodic inspection service in workspace assigned.

3.0 EXECUTION

3.1 CONTRACT STARTING DATE

The Contract for the full services shall begin immediately on the effective date of the award of the Contract.

3.2 PAYMENT OF SERVICES

- a. Items being billed on Markup line must have corresponding source Invoice, and that total and The City will make payment to the Vendor according to the City's normal policies and procedures.
- b. Before an order can be placed for routine transactions, City will request a Quote from Vendor with detailed breakdown. City may require breakdown on its own form. Once City has approved the quoted price and submits Requisition for same, it will advise Vendor of the Release Number in order to place the order. Invoices that do not reference the Release Number will not be onsidered complete or valid.
- c. Vendor's Invoice must list a valid E-Mail Address for billing questions and inquiries.
- d. Invoice Date is critical and Invoices must be sent to the City on the Invoice Date in order for the City's tracking system to accurately effect the record. The Invoice Date must not precede the Ship Date or Service Date.
- e. Invoice descriptions on transaction lines must match the wording of the Purchase Order transaction lines, and reference the corresponding transaction line number of the Purchase Order. The Vendor shall not invoice the City for any item that does not correspond to a line on the Purchase Order.
- f. Markup breakdown must be reflected on Vendor's Invoice to the City. The Markup for items purchased on the percent Markup line, is for markup of items

only. No Markup is allowed for taxes or freight charges. The taxes and freight charges will be a straight reimbursement, with no Markup.

- g. Markup will be calculated as the following example:
 - i. If the part costs vendor \$100.00,
 - ii. and the Markup on contract is 10%,
 - iii. City will reimburse Vendor \$110.00.
- h. Vendor will be responsible for collecting signature and legible name of City employee when delivering goods and/or services and must be able to produce said Proof of Delivery ("POD") upon request. The POD must contain an itemized list of goods and/or services. The POD must accompany each Department's payment packet before presenting the Invoice with all necessary backup to City's Accounts Payable Division. Including copy of POD with Invoice is encouraged and speeds payment processing time.
- i. Vendor's Invoices that are billed inaccurately, incompletely, or otherwise unprocessable are not considered valid.
- j. When sending City a Revised Invoice, it must be clearly marked "Revised." When sending City a replacement Invoice, it must reference the Invoice Number it is replacing.
- k. Invoices to the City shall reference the City Department, Release Number, Work Order Number, and the first and last name of the City employee placing the order.

The Contractor will send to each labor union or representative of workers with which he/she has a collective bargaining agreement or other contract or understanding, a notice advising said labor union or workers' representatives of the Contractor's commitments under this section, and shall post copies of the notice in conspicuous places available to employees and applicants for employment.
- 4. During the term of all construction contracts or subcontracts in excess of \$10,000 to be performed for the City of Chattanooga, the following non-discriminatory hiring practices shall be employed to provide employment opportunities for minorities and women:
 - a. All help wanted ads placed in newspapers or other publications shall contain the phrase "Equal Employment Opportunity Employer".
 - b. Seek and maintain contracts with minority groups and human relations organizations as available.
 - c. Encourage present employees to refer qualified minority group and female applicants for employment opportunities.
 - d. Use only recruitment sources which state in writing that they practice equal opportunity. Advise all recruitment sources that qualified minority group members and women will be sought for consideration for all positions when vacancies occur.
