#### **PURPOSE AND BACKGROUND:**

The purpose and intent of this request for bid is to secure choral masks, instrument masks, and instrument bell covers for middle school and high school students in the Portage Public School System (PPS).

#### **SCOPE OF WORK:**

1. Vendors may provide a quote for any or all items listed below.

2. Vendors must provide pricing utilizing the template included below. However, additional pricing sheets may be included.

3. Vendors should indicate any price breaks offered at various order quantities.

4. Bell covers must meet a specification of 80 denier fabric or above.

## 5. Vendors must submit one sample of each item proposed (any sir or color is acceptable),

along with specifications of the items. Samples will not be returned to the vendor. Quotes submitted without the proper documentation or samples, will not be considered.

6. Proposals should include available size and color options.

7. Pricing to be held firm through June 30, 2021. Additional purchases to be made as needed throughout the school year.

8. Quantities shown are rough estimates only. Final quantities subject to change prior to issuance of the purchase order.

9. Delivery is requested in late October to early November, if possible. Vendors should not in their proposals the estimated delivery window or lead time upon receipt of the purchase order, including any expedited shipping options and additional costs. The cost of shipping must be included.
