






Should a solicitation, procurement, or request for bids be made by Dorchester County for goods, supplies, or construction services, which by state or federal guidelines prohibit or restrict the type of preference created in this Article, this Article granting such preference shall not apply to such solicitation, procurement, or request for bids. Likewise, should any solicitation, procurement, or request for bids by Dorchester County for goods, supplies, or construction services be funded in whole or in part with state or federal monies, the receipt of which by Dorchester County prohibits or restricts the use of the type of preference created in this Article, this Article granting such preference shall not apply to such solicitation, procurement, or request for bids. For example, 45 C.F.R. Section 92.36 (Code of Federal Regulations) generally requires that grantees and subgrantees of federal funds conduct procurements in a manner that prohibits the use of statutorily or administratively imposed geological preferences in the evaluation of bids or proposals. Thus, in such circumstances, this Article granting the preference will not apply.

Except as amended hereby, the Dorchester County Centralized Procurement Ordinance Number 83-05, as previously amended, shall continue in full force and effect.
