The City of Waycross will be accepting sealed bids from Lawn Care Contractors for the mowing of 3 city owned cemeteries and as an option our city parks on an as needed basis. Bids will be accepted until, 10:00 a.m., Monday, November 11, 2019. Envelope must be sealed and marked Bid # FY20-09 Mowing .Proposals may be mailed to the City of Waycross Purchasing Department, PO Drawer 99 Waycross, GA 31502 or hand delivered to City of Waycross, Purchasing Department, 417 Pendleton Street. The City of Waycross does not accept late, faxed or emailed bids.

There will be a pre-bid meeting at Oakland Cemetery Offices located off Alice Street at 9:00 a.m., Thursday, October 31, 2019 to familiarize yourself with the scope of work to be completed. While this meeting is not mandatory, you must familiarize yourself with each location you are bidding.

Contractor may bid each location individually or all locations as a lump sum. Bids will be review by each location and may be awarded individually if it is more advantageous to the City.

SCOPE OF WORK TO BE DONE AT EACH LOCATION

Oakland Cemetery - Plant Avenue
