Dispensers and other equipment may be picked up by the vendor **after the bids have been awarded, if it is requested in writing with the samples**; however, we will not be responsible for shipping or delivery of items back to the vendor. Please call to set up a convenient time to pick items up after the bids have been awarded, if you need them back and have made such a request in writing. **Vendor must attend the pre-bid meeting with the products requested below to be able to submit a bid. Bids will be awarded on a per item basis. Please feel free to bid on any or all items.**

Please let us know in writing with your bid packet if you want to pick up your samples. You may pick up samples by appointment only after bid has been awarded.
