The Governing Board of the St. Johns River Water Management District (the "District"), requests that interested parties respond to the solicitation below by 2:00 p.m., March 14, 2019. Responses will be opened at the Palm Bay Service Center, 525 Community College Parkway, Palm Bay Florida 32909.

The Contractor shall provide all labor, materials and equipment necessary for the fabrication and installation of walkways at S252B and S252C Indian River County, FL. Generally, the scope shall include removal and disposal of existing wooden handrails, deck boards, stringers and pilings, fabrication and installation of new aluminum walkway including pilings, stringers, grating and handrails.

The engineer's construction estimate for the project is \$95,000..
