

INVITATION TO BIDDERS

The City of Gatlinburg is accepting sealed bids for a twenty-four (24) month Pest Control Services Agreement. The City reserves the right to extend this agreement for an additional twenty-four (24) month period.

These bids will be received at the Purchasing office, Gatlinburg City Hall, 1230 Parkway East, Suite 2, P.O. Box 5, Gatlinburg, Tennessee 37738, until <u>2:30</u> p.m., November 10, 2016 at which time they will be publicly opened and read aloud and the contract awarded as soon thereafter as practicable. Please indicate on your bid to be submitted "Bid on Pest Control Services."

Bid specifications will also be available on the City of Gatlinburg website at www.gatlinburgtn.gov under "Out for Bids" tab. This bid tab is located under Gatlinburg Government, and then Purchasing. Bid results are posted in the same area as shortly after bid opening as possible.

No bidder will be permitted to withdraw their bid for a period of thirty (30) days following the date of the bid opening.

The City of Gatlinburg reserves the right to waive any informalities in or to reject any or all bids and to accept the bid deemed favorable to the interest of the City of Gatlinburg.

GENERAL PROVISIONS

Prices quoted shall not include Federal or State taxes, if any are applicable. The successful bidder shall furnish tax exemption forms, if required, with their invoices.

The prices quoted are that for which the materials or services will be delivered F.O.B. Gatlinburg, Tennessee.

Any additions, deletions, or variations from the following specifications must be noted.

Inspection of the materials or equipment will be made by an agent of the City of Gatlinburg, and if found defective or fails in any way to meet the terms of this agreement, it will be rejected. Rejected materials or equipment will be replaced at the expense of the bidder.

All technical specifications must accompany bid.

The City of Gatlinburg reserves the right to purchase additional units or services under the same terms and conditions for a period of twenty-four (24) months.

The City of Gatlinburg reserves the right to extend this agreement for an additional twenty-four (24) month period after the completion of the first year agreement if mutually agreeable.

The City of Gatlinburg reserves the right to defer payment for thirty (30) days after delivery. The City of Gatlinburg also reserves the right to reject any and/or all bids.

The bidder agrees to indemnify the City of Gatlinburg from any and all liability, loss or damage the City may suffer as a result of claims, demands, costs, or judgments against it arising from any and all work under this agreement.

The bidder agrees to notify the City, in writing, within thirty (30) days, by registered mail, at the City's address as stated in this agreement, of any claim against the bidder on the obligations indemnified against.

The intent of these specifications is to set forth and convey to prospective bidders the general type, character and quality of the pest control services as desired by The City of Gatlinburg.

The City of Gatlinburg reserves the right to reject all bids. The City of Gatlinburg reserves the right to waive informalities in bids.

It is the policy of the City of Gatlinburg not to discriminate on the basis of race, color, national origin, age, sex, or disability in its hiring and employment practices, or in admission to, access to, or operation of its programs, services and activities. With regard to all aspects of this contract, contractor certifies and warrants it will comply with this policy.

No part of this agreement is to be sub-contracted without the prior consent of the City of Gatlinburg.

The successful bidder's personnel must be readily identifiable when in City of Gatlinburg facilities. This may be satisfied by uniforms, name tags, etc.

If the successful bidder fails to comply with these specifications, thirty days written notice may be given to the successful bidder. Upon the expiration of this period, if service has not reached the specifications, the agreement may be terminated.

SPECIAL TERMS AND CONDITIONS

INSURANCE: The successful bidder shall possess and maintain a policy or policies of insurance providing coverage for bodily injury and property damage liability arising out of the operation including the completed operations of the insured, the ownership, maintenance or use of automobiles, with limits not less than \$1,000,000 each person, \$1,000,000 each accident for bodily injury and \$1,000,000 per accident for property damage.

A copy of the successful bidder's Insurance Certificate must be on file with the City of Gatlinburg before work commences.

SITE EXAMINATION: Each bidder shall thoroughly familiarize themselves with each site listed herein. Personnel at each location will show the bidder the areas to be treated. IT IS THE BIDDER'S RESPONSIBILITY TO FULLY UNDERSTAND THE SIZE AND NATURE OF THE AREAS TO BE SERVICED. A site visit will not be necessary if bidder is already familiar with facilities.

All work shall be executed in a manner and in a time-frame that will cause the least practical disturbance to the occupants of the building. Before any work is commenced, a plan of operation shall be presented to and approved by the City of Gatlinburg.

FIRE HAZARD: The successful bidder shall conform to all fire prevention regulations and shall exercise every precaution in the storage of flammable material in the use of fire. Smoking is not allowed except as permitted under City of Gatlinburg regulations.

Materials used in performance of work are to be carried in and out of City buildings and never left on the premises where occupants might come in contact with portions of it.

The successful bidder should be licensed with the Tennessee Department of Agriculture.

All materials used by the pest control company shall conform to State and local laws or ordinances and shall be judged acceptable by the City of Gatlinburg. Special care shall be exercised in the using of liquid insecticides

in areas having asphaltic, mastic, or linoleum floor surfaces. The successful bidder must provide the City of Gatlinburg with:

A list of the materials and/or chemicals to be used must be provided.

A *Material Data Safety Sheet* for each chemical which will be used. (Additional copies of the material data safety sheets must be provided to the personnel at each location).

Any other relevant technical information such as rate of dilution, dispersal amount, etc., shall be made available.

Any building damaged or otherwise affected by the operations of the successful bidder shall be restored to a condition as good as existed before work commenced without cost to the City of Gatlinburg.

All using departments shall extend cooperation to insure effective pest control results. The City of Gatlinburg will provide outlets for water and electricity when required by the vendor. Whenever conditions conducive to the breeding or harborage of pests or insects dangerous to health are reported in writing (by the successful bidder) to the City of Gatlinburg, the City staff shall, within practical limits, take the necessary steps to assist the successful bidder in controlling such conditions.

The City of Gatlinburg reserves the right to have the successful bidder's chemicals, sprays, and any other materials tested to ascertain if the actual chemical being sprayed is the one specified by the successful bidder to the City of Gatlinburg.

SCOPE OF WORK

These specifications require the successful bidder to include the furnishing of all professional services, skilled services, labor, materials, insecticides, tools, equipment, insurance, permits and fees, necessary to accomplish insect and rodent control hereinafter described.

Services shall include but not be limited to the control of roaches, ants, silverfish, rats and mice. This contract does not include termite control services.

The areas specified in this agreement shall be inspected and serviced at least once a month-unless otherwise specified. The successful bidder and the City of Gatlinburg shall determine the date service is to be provided.

The successful bidder will provide one call back service per month at no additional charge to the City of Gatlinburg. Call back service will be upon request by the City of Gatlinburg when previous treatment fails to control the pests specified herein.
