## ADDITIONS, MODIFICATIONS AND/OR CLARIFICATIONS TO THE PLANS AND SPECIFICATIONS

#### I. INSTRUCTIONS:

- 1. This Addendum shall be included as part of the original Contract Documents and the work required therein.
- 2. All work performed under this addendum shall be subject to the requirements of the Specifications and the Drawings for the work of this Project.
- 3. Submit written acknowledgement of receipt, understanding, and incorporation of all items of this addendum into the bid price along with the bid. <u>Bids submitted without this written acknowledgement</u> statement will be considered incomplete and disqualified.

#### **Architect/ Pre-Bid Meeting Questions:**

1. Please clarify where temporary fencing is required?

TEMPORARY FENCING IS THE RESPONSIBILITY OF THE CONTRACTOR AS A "WAYS AND MEANS" OF CONSTRUCTION. THE CONTRACTOR WILL BE RESPONSIBLE TO SEPARATE THE CONSTRUCTION FROM THE DINING AREA DURING CONSTRUCTION. THE CONTRACTOR WILL BE REQUIRED TO STAGE THE WORK AROUND THE 6 AM TO 2 PM CAFÉ SCHEDULE, THE WORK WILL NEED TO BE COORDINATED WITH THE OWNER'S REPRESENTATIVE.

- 2. What can be done to secure the large window opening during construction?

  THE CONTRACTOR CAN USE THE OWNER SUPPLIED WINDOW SHUTTER SYSTEM AS
  A WAY TO SECURE THE FACILITY WHILE THE NEW GLASS IS WAITING TO BE
  INSTALLED. THE CONTRACTOR WILL BE REQUIRED TO MAKE THIS SYSTEM "AIR-TIGHT".
- 3. Will a new ceramic floor be installed in the outside Dining area that is to be enclosed?

  A NEW CERAMIC TILE FLOOR WILL BE INSTALLED IN THE NEW ENCLOSED DINING AREA. THE CONTRACTOR WILL REMOVE THE EXISTING MORTAR BED AND MATERIAL DOWN TO CONCRETE BASE. (SEE ATTACHED PARTIAL DETAIL SK-4)
- 4. Will Drywall be installed at the new perimeter walls or match the bead board up to the ceiling?

  DRYWALL TO BE INSTALLED AT THE NEW PERIMETER WALLS UP TO THE CEILING.
- 5. Does the roof color have to match the existing metal roof?

  THE METAL ROOF COLOR SHALL MATCH AS CLOSE AS POSSIBLE TO THE EXISTING ROOF.

- 1. The model numbers for the Trane units are obsolete. The minimum is 14 SEER in the state of FL? **REFER TO REVISED MECHANICAL EQUIPMENT SCHEDULE ATTACHED.**
- System 1 is calling for 1800 CFM. Its capacity is capable of 2200 CFM which would require a duct detector please advise?
   NO DUCT DETECTOR REQUIRED.

3. Will a test and balance be required?

YES, TESTING AND BALANCING CONTRACTOR SHALL PROVIDE EQUIPMENT AND PERSONNEL WHICH SPECIALIZE IN THE BALANCING AND TESTING OF HEATING, VENTILATING, AND AIR CONDITIONING SYSTEMS. THEY SHALL BALANCE AND ADJUST AIR MOVING EQUIPMENT AND AIR DISTRIBUTION AND EXHAUST SYSTEMS TO THE FLOW RATES INDICATED ON THE HVAC SCHEDULES AND PLANS.

4. Will there be any new landscape/sod/irrigation for this project?

SOD, YES CONTRACTOR TO REPLACE WITH NEW BAHAI SOD WHERE EXISTING AREA HAVE BEEN AFFECTED BY CONSTRUCTION.

6. Can the Architect provide the length of sidewalk going towards the parking lot at the new addition see sheet A-2?

THERE IS APPROXIMATELY +/-42' OF SIDEWALK, SIDEWALK TO END AT THE PARKING LOT WITH A DETECTABLE WARNING STRIP BY "ULTRATECH ADA SURFACE MOUNT ADA PAD".

- 7. The need for a temporary opening in the ceiling to remove the HVAC equipment and ductwork. That opening will need to be patched and painted. Will the entire ceiling be painted in this project?

  CONTRACTOR TO PAINT ALL INTERIOR CEILINGS IN THE FOOD PREP/STORAGE AREAS AND ALL DINING AREAS.
- 8. There is no mention of painting the existing exterior of the building. Will this be required?
  NO, ONLY THE WALLS AND AREAS AFFECTED BY THE NEW CONSTRUCTION. PAINT TO MATCH EXISTING. THE OWNER WILL SUPPLY THE CONTRACTOR WITH THE PAINT INFORMATION FOR THE EXISTING PAINT.
- 9. Is PGT Aluminum Storefront System "SS-3500" and "SE-3550" be allowed as a substitute for the window wall system?

YES, PGT WILL BE AN ACCEPTABLE SUBSTITUTE, "ALL PROJECT SPECIFICATIONS MUST BE MET UPON SHOP DRAWING SUBMITTAL".

**10.** My question is <u>if the contract sum is under \$100K</u>, do they still want P/P bonds or they just don't have to be on Standard Form 25.

If the Contract Sum is more than \$100,000, the Contractor shall furnish a Performance Bond on Standard Form 25 in an amount equal to one hundred percent (100%) of the Contract Sum as security for the faithful performance of this Contract. If the Contract amount is increased, the Owner may require a corresponding increase in the amount of the bond. The Owner may also secure additional protection by directing the Contractor to add a penal amount to the existing bond or to obtain an additional bond. The Contractor shall furnish a Payment Bond on Standard Form 25-A in amount equal to one hundred percent (100%) of the Contract sum.


