#### I. SCOPE OF SOLICITATION

**ACQUIRE SERVICES**: The purpose of this solicitation is to acquire services complying with the enclosed description and/or specifications and conditions. [01-1010-1]

**SCOPE**: The purpose of this solicitation is to seek qualified Contractors to provide refuse, trash collection and disposal at various locations throughout Horry County Schools. The services to be provided include furnishing the receptacles/containers, supplier, refuse, trash collection, disposal services and landfill fees. The work required includes the furnishing of all labor, transportation, equipment, supplies and materials necessary to provide the required level of services. The list of facilities is located in attachment A.

MAXIMUM CONTRACT PERIOD – (ESTIMATED): Start date: 07/01/2022 End date: 06/30/2027. Dates provided are estimates only. Any resulting contract will begin on the date specified in the notice of award. See clause entitled "Term of Contract – Effective Date/Initial Contract Period". [01-1040-1] Dates provided are estimates only. The contract resulting from this solicitation will be a one (1) year contract with four (4) additional one year renewal options. The maximum potential contract life is five years.

AMENDMENT means a document issued to supplement the original solicitation document.

BOARD means the Horry County Schools Board of Education or its successor in interest.

BUSINESS means any corporation, partnership, individual, sole proprietorship, joint stock company, joint venture, or any other legal entity

BUYER means the Procurement Officer/Specialist.

CHANGE ORDER means any written alteration in specifications, delivery point, rate of delivery, period of performance, price, quantity, or other provisions of any contract accomplished by mutual agreement of the parties to the contract.

CONTRACT means all types of Horry County Schools agreements, regardless of what they may be called, for the procurement or disposal of supplies, services, equipment, or construction.

PROCUREMENT OFFICER means any person acting within the scope of his/her authority and duly authorized by Horry County Schools to enter into and administer contracts and make written determinations and findings with respect thereto, as identified as such on either the Cover Page, an amendment, or an award notice.

SOLICITATION means this document, including all its parts, attachments, and any Amendments.

SUBCONTRACTOR means any person you contract with to perform or provide any part of the Work.

DISCLOSURE OF CONFLICTS OF INTEREST OR UNFAIR COMPETITIVE ADVANTAGE: You warrant and represent that your offer identifies and explains any unfair competitive advantage you may have in competing for the proposed contract and any actual or potential conflicts of interest that may arise from your participation in this competition or your receipt of an award. #### III. SCOPE OF WORK / SPECIFICATIONS:

#### 3.1 INTRODUCTION:

Horry County Schools (HCS) is the third largest school district among the 85 school districts in the State of South Carolina and is coterminous with Horry County's land area of approximately 1,152 square miles. The present boundaries of the District were established in 1952 as a result of the consolidation of all existing school Districts in the county. Horry County Schools has more than 45,000 students The district is made up 52 schools and four additional program schools within nine attendance areas: Aynor, Carolina Forest, Conway, Green Sea Floyds, Loris, Myrtle Beach, North Myrtle Beach, Socastee, and St. James

The District is governed by a board of trustees, the Horry County Board of Education, consisting of a 12-member Board of Education, elected from single-member Districts with the Board Chairman elected at-large. The Horry County Board of Education members have decision-making authority, the power to designate management, the ability to significantly influence operations, and have primary accountability for fiscal matters.

#### 3.2 SCOPE OF WORK:

This specification covers refuse, trash collection and disposal services to include containers, compactors and landfill fees services for the HCS District in accordance with all requirements stated herein. The work required includes the furnishing of all labor, transportation, equipment, tools and materials necessary to provide the required level of services, in accordance with requirements and specifications identified herein. (See Attachment A-Bidding Schedule for specifications and a list of service locations.)

The District is currently in contract for a total of ninety-two (92) 8-yard containers, two (2) six-yard, one (1) four-yard and two (2) 30-yard compactors. Sixteen (16) 8-yard containers listed in the total amount of ninety-two (92) will be for container rent only, as refuse is currently collected by the city of Conway.

Refuse and trash are defined as all discarded and unwanted putrescible and non-putrescible waste, including, but not limited to: restaurant-type kitchen wastes, food residues, and materials necessarily used for packaging, storing, preparing, and consuming same, usually defined as "garbage", all combustible and non-combustible waste materials resulting from housekeeping; ashes; fixtures and other bulk items; plastic containers, plate glass, light bulbs, etc.; minor amounts of construction and demolition debris; textiles; rags, cartons, crates, worn out articles of equipment, furniture, food, mattresses, construction projects, renovations, etc.

Fuel surcharge, administration fees, dump fees, landfill disposal fee or any other fees/charges that are not identified will be included in the bid receptacle/container unit price regardless of the solid waste receptacle size.

The contractor will be responsible for the removal and disposal of the contents from each container. Each container will be emptied, returned to its original position and lid replaced. Garbage and refuse spilled by collectors will be swept up and removed during the current pickup. Contractor will not be responsible for hazardous waste disposal.

#### 3.3 CONTAINERS

Contractor will have a sufficient inventory of standard sizes and styles of containers, new and used, to accommodate
orders for new and replacement containers within the time specified for requests by this Contract.

- Container details and quantities are included in Attachment A.
- Contractor will provide 20-yard and 30-yard construction "roll off" models on an as needed basis as requested for solid waste disposal service.
- The 8 yd containers must be the slanted top type for easier loading.
- All containers will comply with all applicable codes
- Containers will be properly maintained so that doors, latches, covers, etc. function in the proper manner. All
  opening/securing devices must be always in proper working order.
- All containers shall be equipped with suitable covers to prevent blowing or scattering of waste and shall have leak proof bodies of a type specifically designed for this service.
- All 2, 4, 6 and 8 cubic yard containers must have intact lids and plugs. Any container that is damaged, rusted, has
  holes or damaged lids must be repaired or replaced upon notification. Equipment shall be properly maintained so
  that doors, latch, covers, etc., function in the proper manner. Container labels or markings shall be limited to any
  labeling required by law or contractor identification. Any other labels or markings on the containers shall be approved
  by the District.
- Containers will be clean, free of rust, free of odor and interior debris, minimal denting, freshly painted, properly welded seams and joints, properly operating and fitting lids or side doors, and equipped with plugs for all drains. Exterior of containers shall be painted, and the painted surfaces kept up so that a presentable appearance is maintained during the term of the contract.
- The outside of the container may have its company logo/emblem; however, the outside of the container must be rust free and graffiti free. Exterior of containers will be painted, and the painted surfaces kept up so that a presentable appearance is maintained.
- The contractor must at a minimum, inspect and perform preventive maintenance quarterly. Containers that do not function as per designed must be pulled out of service and replaced with like equipment that function within 24 hours.
- All containers must be delivered within 24 hours of on-call request.
- All containers must be emptied within 24 hours of on-call request.
- Replacement containers must be provided while the permanent container is being cleaned and disinfected.
- Any container, which in the opinion of the District is unsightly or unsanitary, must be replaced or the unacceptable condition corrected within 24 hours after notification.
- All containers used in providing services in accordance with this specification will be periodically cleaned and sprayed (at least once per month) with an insecticide to maintain them in a sanitary condition and to eliminate breeding of vermin, insects, objectionable odors and unsightly outward appearance. Special attention in cleaning will be given to seams and rolled edges of container and covers. The cleaning and disinfection of containers will be subject to approval of the SC Department of Health and Environmental Control, other applicable governing agencies, and the using District.
- If it becomes necessary, the contractor will be required to take a container(s) off site to be cleaned and disinfected. The contractor will then either provide a replacement container equal to the container removed or provide a suitable container temporarily while the permanent container is being cleaned and disinfected.

- All containers must be continuously maintained in a presentable condition. The HCS District reserves the right to determine when maintenance or cleaning is required.
- Usage will vary from year to year depending on renovations, facility upgrades, pickup frequency, and quantity of materials.
- Collection at schools must not occur sixty minutes prior to or following arrival and dismissal times to avoid traffic
  congestion. Arrival and dismissal times will be provided Monday through Friday except upon special request by the
  HCS Representative or designee. The times suggested assist with avoiding school traffic with student drop offs and
  pickups. HCS prefers to schedule an established set time, such as AM or PM for service. Regular Administrative
  business hours are from 8:00 am to 5:00 pm. Monday through Friday, excluding holidays.
- Collection at Administrative Facilities and Offices may occur during regular business hours.
- Work extending beyond regular business hours must be approved by the HCS Representative or designee. All work must be scheduled a minimum of 24 hours in advance.

#### 3.4 COMPACTORS:

The HCS District currently has compactors at the locations specified on the FACILITY BIDDING SCHEDULE. The Contractor will provide equivalent equipment at these locations, utilizing the current power sources as able. Any modification to existing power sources will be specified in writing and approved by the HCS District, installed by the HCS District and paid for by the HCS District. The HCS District requests the right to order compactors to be installed at existing locations as needed. Over the life of the contract, the HCS District will consider removal of compactors at some, or all locations listed on the FACILITY BIDDING SCHEDULE.

As the HCS District builds new or renovates large schools and as funding allows at existing large campuses, the following specifications will provide for the use of solid waste compactors:

- Power source: a 3-phase, 220/240 or 460 volt and (I) 30 amp disconnect.
- 225 breakway.
- The HCS District will provide a concrete pad within 15 feet of the power source and with the following dimensions: 15' W x 56 'L and 10" thick, steel reinforced to 3000 PSI.
- The HCS District will provide an appropriate enclosure and gate to surround the compactor.
- Compactors offered in the bid will generally accommodate a 30-35 or 40-yard size compactor, although equivalent models may be offered.
- All compactors will comply with all applicable codes.
- All compactors must be continuously maintained in a presentable condition. Damaged and unsightly compactors
  must be replaced at the request of the HCS Representative or Designee, within the specified time bid or a maximum
  of fourteen (14) calendar days from date of the request. The HCS District reserves the right to determine when
  maintenance or cleaning is required.
- Usage will vary considerably from year to year depending on renovations, facility upgrades, pickup frequency, and quantity of materials.
- Collection at schools must not occur sixty minutes prior to or following arrival and dismissal times to avoid traffic congestion. Arrival and dismissal times will be provided Monday through Friday except upon special request by the HCS Representative or designee. The times suggested assist with avoiding school traffic with student drop offs and pickups. HCS prefers to schedule an established set time, such as AM or PM for service. Regular Administrative business hours are from 8:00 am to 5:00 pm. Monday through Friday, excluding holidays.
- Collection at Administrative Facilities may occur during regular hours. Work extending beyond regular business hours
  must be approved by the HCS Representative or designee. All work must be scheduled a minimum of 24 hours in
  advance.

#### 3.5 CONTRACTOR REQUIREMENTS AND RESPONSIBILITIES:

Contractor will be responsible for waste collection throughout HCS District sites. These sites will be at schools and/or offices within the borders of HCS District. A listing of locations and the bell schedule can be viewed online at <a href="https://www.horrycountyschools.net/Page/644">https://www.horrycountyschools.net/Page/644</a>

Contractor will provide trucks and vehicles licensed for use on public street. Vehicles will have identification to include company's name and/or logo so that it is apparent to the nature of business of the occupant of the vehicle.

Contractor will be responsible for the removal and disposal of the contents from each container. All refuse and trash shall be removed and disposed of away from the District. Dispose of all refuse and trash in accordance with the rules and regulations of the State of South Carolina Department of Health and Environmental Control (SCDHEC), and any other governing agencies in accordance with all state, local, and Federal laws, regulations, and ordinances. Disposal will take place at a designated and authorized refuse collection site.

Each container shall be emptied, returned to its original position and lid replaced. Contractor shall properly maintain areas adjacent to the containers. Vehicles utilized to remove container contents shall be fully enclosed, leak-proof, and operated in such a way that no refuse leaks, spills or blows off of a vehicle, due to the vehicle operator's failure to properly monitor the load or to close openings, or due to failure of any mechanism. Garbage and refuse spilled by collectors shall be swept up and removed during the current pick-up. No regular pick-ups shall be made on State holidays.

Contractor will dispose of waste within the county in compliance with Chapter 1.5 Ordinance 78-13 Article 2 Code of Ordinance and flow control act.

The Contractor will notify the HCS Representative identified in the purchase order of any chemicals and otherwise hazardous chemicals found improperly disposed of in containers. Resolution will be handled on a case-by-case basis, depending upon the chemical/material in question.

Contractor will document the number or volume of materials being collection from each location at the time of performance. HCS Representative or designee will sign these documents to verify accuracy of services provided.

Contractor will report within one business day to the HCS Representative or Designee any observed dumping or significant accumulations of waste and trash outside of the containers, at any scheduled location, which are not caused by the Contractor's operations.

Contractor must provide an annual summer schedule for cleaning and disinfecting of each container and each compactor at no additional charge. Repainting and repairs will also be completed as needed during the summer. These maintenance tasks will begin after June 1 of each contract year and must be completed by August 1 each year.

The quantity of refuse container herein is an estimate for the purpose of bidding. The HCS District reserves the right to adjust the size, number of containers, frequency of pick-ups, number of locations and the right to modify or adjust services as may be deemed necessary during the contract period. The unit cost per container will be used when changes, cancellations, modification, or increase of service are required. The HCS District will use the unit price in the bid schedule when adding on to an existing location, or new location, to include weekly pick-up, and on call pick-ups.

Occasionally, additional 20 or 30 containers may be ordered on an as-needed basis. These containers must be delivered within five (5) days of the request. The Contractor will be notified when the container needs to be emptied. For roll-off containers not permanently located at one of the facilities, a separate purchase order may be issued or a line item added to the current open purchase order.

Contractor will have adequate service organization with local service representative for the geographical area for which the bid is applicable.

Contractor will provide and maintain a telephone answering system or service, which can contact and dispatch service personnel five (5) days a week, 8 hours during normal business hours of 8:00 am –5:00 pm EST.

Upon arrival at HCS to perform services, if work requires to be done inside the building, contractor's employees will check in with building services staff and front desk.

Contractor will furnish, install, and maintain all signage, warning devices, barricades, cones, etc., as required to adequately protect the public, HCS staff and others during the performance of this CONTRACT safeguarding surrounding property, vehicles and public.

All vehicles used in conjunction with this contract must be equipped with a warning device, which automatically sounds when the vehicle is in reverse gear.

Contractor's employees will exercise safety measures and caution while performing all duties associated with the collection and disposal services performed under this contract.

The Contractor must pick-up, sweep, and clean up any refuse, debris, or trash that is spilled during collection and return the container back to its original location.

Contractor's employees will wear nametags with employee's name while on HCS District property. Nametags must be in plain view at all times while performing the work of the contract. Contractor's employees will wear appropriate clothing for their protection.

Contractor must use skilled, competent, trained, licensed or certified personnel to properly and safely perform the contracted services. Contractor's personnel will be qualified and trained in the proper collection and management of all types of waste products.

The contractor warrants to the District that all work performed as a result of this solicitation will be performed in a professional manner consistent with industry practices.

Horry County Schools will not pay any fuel surcharges, mileage, lodging, permit fees, licenses, etc.

With the various schools and buildings, some locations will not have loading docks available, so trucks with lift gates or forklifts may be required at the collection sites.

The contractor must furnish two names as a primary and alternate liaison from the contractor's personnel with complete authority to act on behalf of the contractor in any situation to this contract. The names must be provided to the HCS Representative or Designee and will be the main contact person on all issues that will arise. The liaisons must be authorized to resolve financial and customer service issues.

The contractor must provide the following information on the primary and alternate liaisons:

- Name
- > Telephone number
- > Fax number
- Email address
- Business cell phone number
- Normal working hours of the liaisons

The Contractor's liaisons will coordinate with HCS Representative or Designee prior to collection to confirm the location, loading, and packing options at time of request or prior to collection.

The Contractor's liaisons must maintain the following to respond to work orders through the HCS District SchoolDude software:

- Must provide internet access thorough a computer, tablet, or smart phone.
- Must provide the name, email address and cell phone number of the Contractor's liaisons to the HCS Representative or Designee.
- ➤ Liaisons must attend a 2–3-hour training session with HCS Representative or Designee on SchoolDude application/software. Each school and facility will request service from contractor via the SchoolDude software, by email or by phone.

There will be no cost incurred by contractor for access to the SchoolDude application/software through HCS District.

The contractor must prepare individual invoices for each of the locations herein and submit them to the Horry County Schools for payment on a monthly basis. The invoice must include the address, equipment/container size, and pick-up frequency. All invoices shall include the: PO number, Name of the location and type of container, description of service, date of service, cost of service and month total cost. Invoices must be accompanied with a copy of the designated facilities disposal receipt to allow the HCS District an avenue to determine the yardage/tonnage per the locations herein. Advanced billing will not be accepted.

All 20-yard and 30-yard roll-off containers shall be invoiced as a separate payment. The contractor will include a copy of documentation from the landfill for each roll top that is emptied. This invoice will state the tonnage of each haul.

On all new and additional rentals of containers and compactors, the contractor will write/print on the invoice the name of the District person, phone number and address the container/compactor was delivered to.

There will be no additional haul charges added to the invoice for any dumpsters turned away at facilities if the contractor cannot provide evidence that the driver actually was turned away from the facility. Disposal charges for recyclables must show up as a separate line item on an invoice and must be accompanied by the designated facilities receipt.

**DELIVERY AND PAYMENT:** Payment for services rendered will be made monthly based upon valid and approved invoices submitted to the HCS District. All invoices will be itemized indicating the number and cost for each container location. Advance billing will not be accepted.

**DELIVERY DATE – Purchase Order:** All items will be delivered within seven days after receipt of purchase order. Delivery will be coordinated with Facilities Management Office. The initial containers must be delivered and set in place for collection services on or before August 1, 2022.

**DELIVERY / PERFORMANCE LOCATION – PURCHASE ORDER:** After award, all deliveries will be made and all services provided to the location specified by the HCS school/location in its purchase order. Refer to attachment for a list of all locations for the purpose of providing geographic information.

**GUARANTEES:** The Contractor guarantees to the Using Agencies that all work performed as a result of this bid and specifications will be performed in a professional manner consistent with industry practice.

**HOLIDAY SCHEDULE:** Arrangements around holidays must be pre-arranged with the HCS Facilities for either picking up the containers on the day before, the next day after, or other agreed upon arrangement to cover the holiday period.

INSPECTION/ACCEPTANCE OF SERVICES: The services provided will be subject to inspection by the District. All work not in accordance with this Scope of Work will be corrected within 4 hours after notification of deficiency. The District also reserve the right to inspect and approve the equipment offered under the specifications of the contract. Contractors and their employees and/or subcontractors must adhere to all local, state and federal laws regarding Client Confidentiality issues.

**INSTALLATION:** Contractor will install all items acquired pursuant to this contract as follows: install types and sizes of containers as required by the locations and frequency list as specified in Exhibit A. The contractor will coordinate and develop a schedule with the HCS contract manager or designee. Install will be made in accordance with the manufacturer's recommendations. [3-3050-1]

**NON-EXCLUSIVE CONTRACT:** HCS reserves the right to engage temporary services from any other available source in the event the Contractor is not able to provide the services called for in these specifications in a timely and/or satisfactory manner for any reason, including, but not limited to strikes or work stoppage from breakdown in equipment. HCS reserves the right to charge the Contractor with costs for temporary services.

**PERMITS AND RESPONSIBILITIES:** The Contractor shall, without additional expense to the state, be responsible for obtaining any necessary license and permits, and for complying with any applicable Federal, State and local laws, codes and regulations in connection with the prosecution of the work.

**SUFFICIENT EQUIPMENT AND CAPACITY:** Contractor must have sufficient equipment and personnel to provide services required, with necessary backup equipment to cover possible break downs, scheduled maintenance activities or lacks in dumping facilities. Using Agencies reserve the right to inspect equipment and ensure it meets standards laid out in this solicitation document before or during contract implementation.

**STRIKE OR WORK STOPPAGE:** The HCS District reserve the right to engage temporary collection and disposal service from any available source and charge Contractor the cost for the temporary services in the event the Contractor is not able to provide the services called for in this specification for any reason whatever, including but not limited to strikes, or work stoppage for breakdown in equipment.

**SUMMER SCHEDULE:** Summer schedules will require an alternate service pick-up schedule. Annual summer schedules will be issued by the HCS Facilities Office, and these schedules will be effective until the new school year. The cost of the delivery during summer services will be the same as per the price in the bidding schedule.

**TRAINING AND MARKETING:** Describe all educational programs that are provided or could be provided to Kindergarten through Grade 12 students such as curriculum, in-person speaking events and activities confirming to educational programs and HCS District curriculum.

**VARIATION IN PICK-UP:** Should a pick-up be missed by the Contractor, for whatever reason, the Contractor shall return to service the missed pick-up within 24 hours. Contractors are responsible for picking up any garbage backed up around containers due to missed pick-ups. Any additional pick-ups required to manage garbage backed up due to missed pick-ups are not to be billed to the District. Contractor is to notify the District immediately if there is any disruption in services at any location and is to provide an acceptable remedy to any problems resulting from the disruption.

Should a compactor, when used, be broken and out of service, a proportional credit (% of days/month(s) out of service) shall be applied to the monthly unit rental charges.

In the event extra pick-ups are requested, Contractor shall charge the District the regular established rate per pick-up. Extra pick-up service must be provided within four (4) hours of a request for the same.

**WARRANTY**: The contractor warrants to the District that all work performed as a result of this solicitation will be performed in a professional manner consistent with industry practices.

**TIPPING FEES:** If the county landfill disposal tipping fees mandate an increase, contractor shall submit adequate justification to substantiate the price adjustment is requested and necessary.

(d) Amounts due to HCS shall bear interest at the rate of interest established by the South Carolina Comptroller General pursuant to Section 11-35-45 ("an amount not to exceed fifteen percent each year"), as amended, unless otherwise required by Section 29-6-30. (e) Any other basis for interest, including but not limited to general (pre- and post-judgment) or

specific interest statutes, including S.C. Code Ann. § 34-31-20, are expressly waived by both parties. If a court, despite this agreement and waiver, requires that interest be paid on any debt by either party other than as provided by items (c) and (d) above, the parties further agree that the applicable interest rate for any given calendar year shall be the lowest prime rate as listed in the first edition of the Wall Street Journal published for each year, applied as simple interest without compounding. (f) The District shall have all of its common law equitable and statutory rights of set-off. [07-7A055-3]

**PAYMENT WITH PROPER INVOICE**: Invoices submitted for payment for goods or services provided under this contract shall contain, as a minimum, the following information:

- Name of business concern
- Contract number or other authorization for delivery of service or property
- Complete description per individual line item
- Price and quantity of property or service actually delivered or executed.
- Shipping and payment terms.
- Name where applicable
- Title, telephone number and complete mailing address of responsible official to whom payment is to be sent; and
- Other substantiating documentation of information as required by the contract.

Invoices shall be provided to Horry County Schools at the address below. An itemized invoice shall be provided even if payment is made with a District purchase card.

During the term of the contract, if the District identifies items that have been overcharged, the contractor shall reimburse the District the difference in the overcharge(s) plus an additional ten percent of the overages. Repeated instances of overcharging the HCS's may result in the contract being terminated.

**PUBLICITY**: Contractor shall not publish any comments or quotes HCS employees or include HCS in either news releases or a published list of customers, without the prior written approval of the Procurement Specialist. [07-7A060-1]

PURCHASE ORDERS: CONTRACTOR SHALL NOT PERFORM ANY WORK PRIOR TO THE RECEIPT OF A PURCHASE ORDER FROM HORRY COUNTY SCHOOLS. The District shall order any supplies or services to be furnished under this contract by issuing a purchase order. Purchase orders may be used to elect any options available under this contract, e.g., quantity, item, delivery date, payment method, but are subject to all terms and conditions of this contract. Purchase orders may be electronic. No particular form is required. An order placed pursuant to the purchasing card provision qualifies as a purchase order. [07-7A065-1]

**RECORDS RETENTION AND RIGHT TO AUDIT:** Horry County Schools has the right to audit the books and records of the vendors they pertain to this purchase order, both independent of, and pursuant to, the District Procurement Code. Such books and records shall be maintained for six (6) years from the date of final payment under the purchase order.

The District may conduct, or have conducted, performance audits of the vendor. The District may conduct, or have conducted, audits of specific requirements of this bid as determined necessary by the District.

Pertaining to all audits, vendor shall make available to the District access to its computer files containing the history of purchase order performance and all other documents related to the audit. Additionally, any software used by the vendor shall be made available for auditing purposes at no cost to the District.

SURVIVAL OF OBLIGATIONS: The Parties' rights and obligations which, by their nature, would continue beyond the termination, cancellation, rejection, or expiration of this contract shall survive such termination, cancellation, rejection, or

expiration, including, but not limited to, the rights and obligations created by the following clauses: Indemnification - Third Party Claims, Intellectual Property Indemnification, and any provisions regarding warranty or audit. [07-7A075-1]

TAXES: Any tax the contractor may be required to collect or pay upon the sale, use or delivery of the products shall be paid by HCS, and such sums shall be due and payable to the contractor upon acceptance. Any personal property taxes levied after delivery shall be paid by HCS. It shall be solely HCS' obligation, after payment to contractor, to challenge the applicability of any tax by negotiation with, or action against, the taxing authority. Contractor agrees to refund any tax collected, which is subsequently determined not to be proper and for which a refund has been paid to contractor by the taxing authority. In the event that the contractor fails to pay, or delays in paying, to any taxing authorities, sums paid by HCS to contractor, contractor shall be liable to HCS for any loss (such as the assessment of additional interest) caused by virtue of this failure or delay. Taxes based on Contractor's net income or assets shall be the sole responsibility of the contractor. [07-7A080-1]

**TERMINATION DUE TO UNAVAILABILITY OF FUNDS:** Payment and performance obligations for succeeding fiscal periods shall be subject to the availability and appropriation of funds therefore. When funds are not appropriated or otherwise made available to support continuation of performance in a subsequent fiscal period, the contract shall be canceled. In the event of a cancellation pursuant to this paragraph, contractor will be reimbursed the resulting unamortized, reasonably incurred, nonrecurring costs. Contractor will not be reimbursed any costs amortized beyond the initial contract term. [07-7A085-1]

THIRD PARTY BENEFICIARY: This Contract is made solely and specifically among and for the benefit of the parties hereto, and their respective successors and assigns, and no other person will have any rights, interest, or claims hereunder or be entitled to any benefits under or on account of this Contract as a third-party beneficiary or otherwise. [07-7A090-1]

**WAIVER:** HCS does not waive any prior or subsequent breach of the terms of the Contract by making payments on the Contract, by failing to terminate the Contract for lack of performance, or by failing to strictly or promptly insist upon any term of the Contract. Only the Procurement Specialist has actual authority to waive any of HCS' rights under this Contract. Any waiver must be in writing. [07-7A095-1]

#### VII. TERMS AND CONDITIONS - B. SPECIAL:

ACCEPTANCE OF OFFERS 10% BELOW PRICE: If the district is offered the exact same item on the exact same terms and conditions as those provided under this contract by a vendor other than the contractor (the "alternate vendor") for a price that is at least ten percent less than the contract price, the district may purchase those items from the alternate vendor if the contractor does not agree to meet the offered price. Any acquisition pursuant to this clause must be documented by the Procurement Specialist in sufficient detail to satisfy the requirements of an external audit.

BANKRUPTCY – DISTRICT INFORMATION: (a) All District information (as defined in the clause herein entitled "Information Security - Definitions") shall belong exclusively to the District, and Contractor has no legal or equitable interest in, or claim to, such information. Contractor acknowledges and agrees that in the event Contractor enters into proceedings relating to bankruptcy, whether voluntary or involuntary, District information in its possession and/or under its control will not be considered property of its bankruptcy estate.

- (b) Contractor agrees to notify the District within forty-eight (48) hours of any determination that it makes to file for bankruptcy protection, and Contractor further agrees to turn over to the District, before such filing, all District information that is in Contractor's possession in a format that can be readily utilized by the District.
- (c) In order to protect the integrity and availability of District information, Contractor shall take reasonable measures to evaluate and monitor the financial circumstances of any subcontractor that will process, store, transmit or access District information. [07-7B007-1]

**CHANGES:** (1) Contract Modification. By a written order, at any time, and without notice to any surety, the Procurement Specialist may, subject to all appropriate adjustments, make changes within the general scope of this contract in any one or more of the following:

- (a) Drawings, designs, or specifications, if the supplies to be furnished are to be specially manufactured for HCS in accordance therewith;
- (b) Method of shipment or packing;

- (c) Place of delivery;
- (d) Description of services to be performed;
- (e) Time of performance (i.e., hours of the day, days of the week, etc.); or,
- (f) Place of performance of the services.
- (g) Product upgrades and new products that are offered by manufacturer.
- Subparagraphs (a) to (c) apply only if supplies are furnished under this contract. Subparagraphs (d) to (f) apply only if services are performed under this contract.
- (2) Adjustments of Price or Time for Performance. If any such change increases or decreases the contractor's cost of, or the time required for, performance of any part of the work under this contract, whether or not changed by the order, an adjustment shall be made in the contract price, the delivery schedule, or both, and the contract modified in writing accordingly. Any adjustment in contract price made pursuant to this clause shall be determined in accordance with the Price Adjustment Clause of this contract. Failure of the parties to agree to an adjustment shall not excuse the contractor from proceeding with the contract as changed, provided that the District promptly and duly make such provisional adjustments in payment or time for performance as may be reasonable. By proceeding with the work, the contractor shall not be deemed to have prejudiced any claim for additional compensation, or an extension of time for completion.
- (3) Time Period for Claim. Within 30 days after receipt of a written contract modification under Paragraph (1) of this clause, unless such period is extended by the Procurement Specialist in writing, the contractor shall file notice of intent to assert a claim for an adjustment. Later notification shall not bar the contractor's claim unless the District is prejudiced by the delay in notification.
- (4) Claim Barred After Final Payment. No claim by the contractor for an adjustment hereunder shall be allowed if notice is not given prior to final payment under this contract. [07-7B025-1Revised 2017 06]

**CISG:** The parties expressly agree that the UN Convention on the International Sale of Goods shall not apply to this agreement. [07-7B030-1]

**COMPLIANCE WITH LAWS:** During the term of the contract, contractor shall comply with all applicable provisions of laws, codes, ordinances, rules, regulations, and tariffs. [07-7B035-1]

**CONFERENCE – PRE-PERFORMANCE:** Unless waived by the Procurement Specialist, a pre-performance conference between the contractor, district and Procurement Specialist shall be held at a location selected by the district within five (5) days after final award, and prior to commencement of work under the contract. The responsibilities of all parties involved will be discussed to assure a meeting of the minds of all concerned. The successful contractor or his duly authorized representative shall be required to attend at contractor's expense. [07-7B040-1]

**CONTRACT LIMITATIONS:** No sales may be made pursuant to this contract for any item or service that is not expressly listed. No sales may be made pursuant to this contract after expiration of this contract. Violation of this provision may result in termination of this contract and may subject contractor to suspension or debarment. [07-7B045-1]

**CONTRACTOR'S LIABILITY INSURANCE – GENERAL(FEB 2015) (MODIFIED):**(a) Without limiting any of the obligations or liabilities of Contractor, Contractor shall procure from a company or companies lawfully authorized to do business in South Carolina and with a current A.M. Best rating of no less than A: VII, and maintain for the duration of the contract, insurance against claims for injuries to persons or damages to property which may arise from or in connection with the performance of the work and the results of that work by the contractor, his agents, representatives, employees or subcontractors.

- (b) Coverage shall be at least as broad as:
- (1) Commercial General Liability (CGL): Insurance Services Office (ISO) Form CG 00 01 12 07 covering CGL on an "occurrence" basis, including products-completed operations, personal and advertising injury, with limits no less than \$1,000,000 per occurrence. If a general aggregate limit applies, the general aggregate limit shall be twice the required occurrence limit. This contract shall be considered to be an "insured contract" as defined in the policy.

- (2) Auto Liability: ISO Form Number CA 00 01 covering any auto (Code 1), or if Contractor has no owned autos, hired, (Code 8) and non-owned autos (Code 9), with limits no less than \$1,000,000 per accident for bodily injury and property damage.
- (3) Worker's Compensation: As required by the State of South Carolina, with Statutory Limits, and Employer's Liability Insurance with limit of no less than \$1,000,000 per accident for bodily injury or disease.
- (c) Horry County Schools, and the officers, officials, employees and volunteers, must be covered as additional insureds on the CGL policy with respect to liability arising out of work or operations performed by or on behalf of the Contractor including materials, parts or equipment furnished in connection with such work or operations. General liability coverage can be provided in the form of an endorsement to the Contractor's insurance at least as broad as ISO Form CG 20 10 11 85 or if not available, through the addition of both CG 20 10 and CG 20 37 if a later edition is used.
- (d) For any claims related to this contract, the Contractor's insurance coverage shall be primary insurance as respects the District, and the officers, officials, employees and volunteers. Any insurance or self-insurance maintained by the District, or the officers, officials, employees and volunteers, shall be excess of the Contractor's insurance and shall not contribute with it.
- (e) Prior to commencement of the work, the Contractor shall furnish the District if requested with original certificates and amendatory endorsements or copies of the applicable policy language effecting coverage required by this section. However, failure to obtain the required documents prior to the work beginning shall not waive the Contractor's obligation to provide them. The District reserves the right to require complete, certified copies of all required insurance policies, including endorsements required by this section, at any time.
- (f) Should any of the above-described policies be cancelled before the expiration date thereof, notice will be delivered in accordance with the policy provisions. In addition, the Contractor shall notify the District immediately upon receiving any information that any of the coverages required by this section are or will be changed, cancelled, or replaced.
- (g) Contractor hereby grants to the District a waiver of any right to subrogation which any insurer of said Contractor may acquire against the District by virtue of the payment of any loss under such insurance. Contractor agrees to obtain any endorsement that may be necessary to affect this waiver of subrogation, but this provision applies regardless of whether or not the District has received a waiver of subrogation endorsement from the insurer.
- (h) Any deductibles or self-insured retentions must be declared to and approved by the District. The District may require the Contractor to purchase coverage with a lower deductible or retention or provide proof of ability to pay losses and related investigations, claim administration, and defense expenses within the retention.
- (i) The District reserves the right to modify these requirements, including limits, based on the nature of the risk, prior experience, insurer, coverage, or other special circumstances. [07-7B056-2]

**CONTRACTOR PERSONNEL**: The Contractor shall enforce strict discipline and good order among the Contractor's employees and other persons carrying out the Contract. The Contractor shall not permit employment of unfit persons or persons not skilled in tasks assigned to them. [07-7B060-1]

**CONTRACTOR PERSONNEL** - **OBLIGATION:** Contractors are responsible for the conduct of their employees, representatives and agents and for their subcontractors' and sub-subcontractors' employees, representative and agents. Suppliers are considered contractors, subcontractors or sub-subcontractors when the performance of their work (including deliveries) is conducted on District property. All such businesses/individuals shall comply with the following:

- 1. No drugs, alcohol, tobacco products, knives, firearms or other weapons on District property.
- 2. No fraternizing with, threats to, use of abusive or profane language or improper attire or actions while on District property or adjacent thereto.

- 3. Take all necessary precautions to ensure the safety of children and employees when performing contracted work or making/accepting deliveries on District property.
- 4. Secure SLED (State Law Enforcement Division) criminal background checks on every employee, representative and agent performing work, making deliveries or in any other way conducting business on District property. Ensure that no person having been convicted of violent crimes, crimes against children, illegal drug distribution, or other crimes of moral turpitude is assigned or performs work on District property. SLED background checks shall be maintained on file at the main office of the Contractor and made available to District personnel or the District's legal counsel immediately upon request.
- 5. Not employ or contract with, during the performance of the contract, any illegal alien workers or otherwise violate the provisions of the federal Immigration Reform and Control Act of 1986, as may be amended.
- 6. Not violate the provisions of the South Carolina Illegal Immigration Reform Act, as may be amended, beginning January 1, 2009, and abide by this Act <u>regardless of the number of employees employed</u>. Participation in E-Verify through the Dept. of Homeland Security is required by the District regardless of the number of employees you employ.
- 7. Provide picture ID badges for all persons performing work on District property and ensure they are worn at all times. The ID shall include the name of the individual, his/her picture and the name of their employer.

Contractors are to ensure that their subcontractors, sub-subcontractors, as well as suppliers who meet the "contractor, subcontractor or sub-subcontractor" definition above are advised of these requirements and comply with them. These are mandatory conditions for doing business (whether directly or indirectly) with Horry County Schools. The District, at its discretion, may perform random compliance checks. Any Contractor, subcontractor, sub-subcontractor, or supplier found not to be in compliance with these requirements shall result in termination of any existing contract or non-award of a contract.

**CONTRACTOR'S OBLIGATION – GENERAL:** The contractor shall provide and pay for all materials, tools, equipment, labor and professional and non-professional services, and shall perform all other acts and supply all other things necessary, to fully and properly perform and complete the work. The contractor must act as the prime contractor and assume full responsibility for any subcontractor's performance. The contractor will be considered the sole point of contact with regard to all situations, including payment of all charges and the meeting of all other requirements. [07-7B065-1]

**CONTRACTOR'S USE OF DISTRICT PROPERTY:** Upon termination of the contract for any reason, HCS shall have the right, upon demand, to obtain access to, and possession of, all HCS properties, including, but not limited to, current copies of all HCS application programs and necessary documentation, all data, files, intermediate materials, and supplies held by the contractor. Contractor shall not use, reproduce, distribute, display, or sell any data, material, or documentation owned exclusively by HCS without the HCS' written consent, except to the extent necessary to carry out the work. [07-7B067-1]

**DEFAULT:** (a)(1) HCS may, subject to paragraphs (c) and (d) of this clause, by written notice of default to the Contractor, terminate this contract in whole or in part if the Contractor fails to-(i) Deliver the supplies or to perform the services within the time specified in this contract or any extension; (ii) Make progress, so as to endanger performance of this contract (but see paragraph (a)(2) of this clause); or (iii) Perform any of the other material provisions of this contract (but see paragraph (a)(2) of this clause). (2) The State's right to terminate this contract under subdivisions (a)(1)(ii) and (1)(iii) of this clause, may be exercised if the Contractor does not cure such failure within 10 days (or more if authorized in writing by the Procurement Specialist) after receipt of the notice from the Procurement Specialist specifying the failure.

- (b) If HCS terminates this contract in whole or in part, it may acquire, under the terms and in the manner the Procurement Specialist considers appropriate, supplies or services similar to those terminated, and the Contractor will be liable to the District for any excess costs for those supplies or services. However, the Contractor shall continue the work not terminated.
- (c) Except for defaults of subcontractors at any tier, the Contractor shall not be liable for any excess costs if the failure to perform the contract arises from causes beyond the control and without the fault or negligence of the Contractor. Examples of such causes include (1) acts of God or of the public enemy, (2) acts of the State in either its sovereign or contractual capacity, (3) fires, (4) floods, (5) epidemics, (6) quarantine restrictions, (7) strikes, (8) freight embargoes, and (9) unusually severe weather. In each instance the failure to perform must be beyond the control and without the fault or negligence of the Contractor.

- (d) If the failure to perform is caused by the default of a subcontractor at any tier, and if the cause of the default is beyond the control of both the Contractor and subcontractor, and without the fault or negligence of either, the Contractor shall not be liable for any excess costs for failure to perform, unless the subcontracted supplies or services were obtainable from other sources in sufficient time for the Contractor to meet the required delivery schedule.
- (e) If this contract is terminated for default, HCS may require the Contractor to transfer title and deliver to the District, as directed by the Procurement Specialist, any (1) completed supplies, and (2) partially completed supplies and materials, parts, tools, dies, jigs, fixtures, plans, drawings, information, and contract rights (collectively referred to as "manufacturing materials" in this clause) that the Contractor has specifically produced or acquired for the terminated portion of this contract. Upon direction of the Procurement Specialist, the Contractor shall also protect and preserve property in its possession in which HCS has an interest.
- (f) HCS shall pay contract price for completed supplies delivered and accepted. The Contractor and Procurement Specialist shall agree on the amount of payment for manufacturing materials delivered and accepted and for the protection and preservation of the property; if the parties fail to agree, the Procurement Specialist shall set an amount subject to the Contractor's rights under the Disputes clause. Failure to agree will be a dispute under the Disputes clause. HCS may withhold from these amounts any sum the Procurement Specialist determines to be necessary to protect the District against loss because of outstanding liens or claims of former lien holders.
- (g) If, after termination, it is determined that the Contractor was not in default, or that the default was excusable, the rights and obligations of the parties shall, if the contract contains a clause providing for termination for convenience of HCS, be the same as if the termination had been issued for the convenience of HCS. If, in the foregoing circumstances, this contract does not contain a clause providing for termination for convenience of HCS, the contract shall be adjusted to compensate for such termination and the contract modified accordingly subject to the contractor's rights under the Disputes clause.
- (h) The rights and remedies of HCS in this clause are in addition to any other rights and remedies provided by law or under this contract. [07-7B075-1]

**DISPOSAL OF PACKAGING:** Contractor shall dispose of all wrappings, crating, and other disposable materials pertaining to this contract at the end of each working day and upon completion of installation. [07-7B085-1]

**ESTIMATED QUANTITY - PURCHASES FROM OTHER SOURCES** (JAN 2006): The District may bid separately any unusual requirements or large quantities of supplies covered by this contract. [07-7B090-1]

**ESTIMATED QUANTITY - UNKNOWN:** The total quantity of purchases of any individual item on the contract is not known. HCS does not guarantee that the District will buy any specified item or total amount. The omission of an estimated purchase quantity does not indicate a lack of need but rather a lack of historical information. [07-7B095-1]

**ILLEGAL IMMIGRATION:** (An overview is available at <a href="www.procurement.sc.gov">www.procurement.sc.gov</a>) By signing your offer, you certify that you will comply with the applicable requirements of Title 8, Chapter 14 of the South Carolina Code of Laws and agree to provide to the District upon request any documentation required to establish either:

- (a) that Title 8, Chapter 14 is inapplicable to you and your subcontractors or sub-subcontractors; or
- (b) that you and your subcontractors or sub-subcontractors are in compliance with Title 8, Chapter 14. Pursuant to Section 8-14-60, "A person who knowingly makes or files any false, fictitious, or fraudulent document, statement, or report pursuant to this chapter is guilty of a felony, and, upon conviction, must be fined within the discretion of the court or imprisoned for not more than five years, or both." You agree to include in any contracts with your subcontractor's language requiring your subcontractors to (a) comply with the applicable requirements of Title 8, Chapter 14, and (b) include in their contracts with the sub-subcontractors language requiring the sub-subcontractors to comply with the applicable requirements of Title 8, Chapter 14. [07-7B097-1]

INDEMNIFICATION - THIRD PARTY CLAIMS - GENERAL: Notwithstanding any limitation in this agreement, and to the fullest extent permitted by law, Contractor shall defend and hold harmless Indemnitees for and against any and all suits or claims of any character (and all related damages, settlement payments, attorneys' fees, costs, expenses, losses or liabilities) by a third

party which are attributable to bodily injury, sickness, disease or death, or to injury to or destruction of tangible property arising out of or in connection with the goods or services acquired hereunder or caused in whole or in part by any act or omission of contractor, its subcontractors, their employees, workmen, servants, agents, or anyone directly or indirectly employed by them or anyone for whose acts any of them may be liable, regardless of whether or not caused in part by an Indemnitee, and whether or not such claims are made by a third party or an Indemnitee; however, if an Indemnitee's negligent act or omission is subsequently determined to be the sole proximate cause of a suit or claim, the Indemnitee shall not be entitled to indemnification hereunder. Contractor shall be given timely written notice of any suit or claim. Contractor's obligations hereunder are in no way limited by any protection afforded under workers' compensation acts, disability benefits acts, or other employee benefit acts. This clause shall not negate, abridge, or reduce any other rights or obligations of indemnity which would otherwise exist. The obligations of this paragraph shall survive termination, cancelation, or expiration of the parties' agreement. This provision shall be construed fairly and reasonably, neither strongly for nor against either party, and without regard to any clause regarding insurance. As used in this clause, "Indemnitees" means Horry County Schools, its instrumentalities, agencies, departments, boards, and all their respective officers, agents and employees. [07-7B100-2]

**LICENSES AND PERMITS:** During the term of the contract, the Contractor shall be responsible for obtaining, and maintaining in good standing, all licenses (including professional licenses, if any), permits, inspections and related fees for each or any such licenses, permits and /or inspections required by the state, county, city or other government entity or unit to accomplish the work specified in this solicitation and the contract. [07-7B115-1]

**MATERIAL AND WORKMANSHIP:** Unless otherwise specifically provided in this contract, all equipment, material, and articles incorporated in the work covered by this contract are to be new and of the most suitable grade for the purpose intended. [07-7B120-1]

**OFFSHORE CONTRACTING PROHIBITED:** No part of the resulting contract from this solicitation may be performed offshore of the United States by persons located offshore of the United State or by means, methods, or communications that, in whole or in part, take place offshore of the United States. [07-7B122-1]

**OWNERSHIP OF DATA & MATERIALS:** All data, material and documentation prepared for HCS pursuant to this contract shall belong exclusively to HCS. [07-7B125-1]

**PRICE ADJUSTMENTS:** (1) Method of Adjustment. Any adjustment in the contract price made pursuant to a clause in this contract shall be consistent with this Contract and shall be arrived at through whichever one of the following ways is the most valid approximation of the actual cost to the Contractor (including profit, if otherwise allowed):

- (a) By agreement on a fixed price adjustment before commencement of the pertinent performance or as soon thereafter as practicable;
- (b) By unit prices specified in the Contract or subsequently agreed upon;
- (c) by the costs attributable to the event or situation covered by the relevant clause, including profit if otherwise allowed, all as specified in the Contract; or subsequently agreed upon;
- (d) in such other manner as the parties may mutually agree; or,
