

## NOTICE INVITING BIDS

The Peralta Community College District is calling for bids for the **Laney College Locker Room Interim Housing, Bid No. 20-21/09**. The Project consists The installation of 2 locker room, 3 offices, 3 classrooms and 2 restroom stockpile relocatable buildings on the existing campus tennis courts by 10<sup>th</sup> street, to serve as interim housing. The project includes but is not limited to selective demolition; electrical work including making an electrical connection to the existing distribution panel in building B; data work; civil and site improvements work; minor landscaping work. Contract Documents are available as of **March 17, 2021**, for review online at the District's website, Peralta Community College District Current Solicitations, Vendor Registry.

A mandatory pre-bid walk will be held on **April 1, 2021**, at **10am** at **Laney College Campus, 900 Fallon St. Oakland, CA 94607** ("Site Visit"). All participants are required to sign-in. Failure to attend or tardiness will render bid ineligible. The Site Visit Certification will be provided at the end of the Site Visit and must be submitted with the Bid.

The District will only receive bids submitted electronically. Bids will be received until **2:00 p.m., April 16, 2021**, [Peralta Community College District Current Solicitations | Vendor Registry](#), after which time the bids will be opened and publicly read aloud via video conference. A link to the video conference will be provided by Addendum. Any bid that is submitted after this time shall be nonresponsive and returned to the bidder. Each bidder is solely responsible for timely submission of its bid; the District is not responsible for any technological issues in a bidder's ability to timely submit its bid or portion thereof. Any claim by a bidder of error in its bid must be made in compliance with section 5100et seq. of the Public Contract Code. Prior to publicly reading aloud bids at the video conference, the District reserves the right to verify the genuineness of any bid security.

To bid on this Project, the Bidder is required to be registered as a public works contractor with the Department of Industrial Relations and to possess **one or more of the following State of California Contractor Licenses: [A – General Engineering Contractor, C36 – Plumbing Contractor, C42 – Sanitation System Contractor]**. The Bidder's license(s) must remain active and in good standing throughout the term of the Contract.
