The non-mandatory pre-bid meeting is Thursday, April 18th at 10:00 am.

The scope of work includes:

Construction of drainage improvements including but not limited to: site clearing, stormwater pipe installation, installation of curb inlets and drop inlets, roadway curbing, sidewalks, manholes, asphalt replacement and resurfacing, etc. on West Paris Avenue and Paris Avenue.

Other qualification or bid requirements include:

This project is being funded in whole or in part by the South Carolina Infrastructure Investment Program (SCIIP) as administered by the South Carolina Rural Infrastructure Authority. All state and federal requirements will apply to the contract. All contractors and subcontractors are required to be registered in the federal System for Award Management (SAM). Bidders on this work will be required to comply with the President's Executive Order No. 11246 & Order No. 11375 which prohibits discrimination in employment regarding race, creed, color, sex, or national origin. Bidders must comply with Title VI of the Civil Rights Act of 1964, the Davis-Bacon Act, the Anti-Kickback Act, the Contract Work Hours and Safety Standards Act, and 40 CFR 33.240. Bidders must also make positive efforts to use small and minority-owned businesses and to offer employment, training, and contracting opportunities in accordance with Section 3 of the Housing and Urban Development Act of 1968. Attention of bidders is particularly called to the requirements as to conditions of employment to be observed and minimum wage rates to be paid under the contract.

The owner reserves the right to waive any irregularities, or to reject any or all bids.

No bidder may withdraw his bid within (90) days after the actual date of the opening thereof.
