Bid Specifications

- 1. <u>Frozen Food Bid (SN-25-01)</u> Bid is awarded on a line by line basis, delivery availability 2-3 times weekly. All deliveries will be to PUSD Central Warehouse.
- 2. <u>Cold Food Bid (SN-25-02)</u> Bid is awarded on a line by line basis, delivery availability 2-3 times weekly. All deliveries will be to PUSD Central Warehouse.
- 3. <u>Fresh Produce Bid (SN-25-03)</u> Line items 1-88 are Winner take All" bid award. The vendor with the best prices and best item availability will be awarded all lines. Line items 89-188 will be awarded on a line by li ne basis. These line items must be a <u>direct</u> <u>ship</u> from farm to our central warehouse. Fresh Produce deliveries are expected 4 times weekly to Central Warehouse
- 4. <u>Dairy Bid (SN-25-04)</u> Bid is awarded as "Winner take All" bid award. The vendor with the best prices and best item availability will be awarded all lines. Dairy items are expected to be delivered 3-4 times weekly to all PUSD sites listed below based on storage capacity and volume.
- 5. <u>Dry Goods Bid SN-25-05</u> Bid is awarded on a line by line basis, delivery availability 2-3 times weekly. Most deliveries will be to PUSD Central Warehouse. Smart Snack Compliant Foods, Gatorade, and bottled water will ALSO require weekly deliveries to: Porterville High, Monache High, Granite Hills High
- 6. <u>Supplies Bid SN-25-06</u> Bid is awarded on a line by line basis, delivery availability 2-3 times weekly. All deliveries will be to PUSD Central Warehouse.
- 7. <u>Janitorial Bid SN-25-07</u> Bid is awarded on a line by line basis, delivery availability 2-3 times weekly. All deliveries will be to PUSD Central Warehouse.
- 8. <u>**Bid Form**</u>- Do not alter solicitation form (i.e. adding or removing rows and or columns). Alteration of solicitation form could cause non-consideration of bid
- 9. <u>Samples-</u> must be submitted at no cost to Porterville Unified for consideration when bidding alternate items and or brands. Samples must be received no later than 6/15/2024 Central Warehouse.
