
PART 1 – REVISIONS TO THE PROJECT MANUAL

The following REVISIONS shall be incorporated into the PROJECT MANUAL for the abovereferenced project:

- A. Section 00 41 00, BID FORM
 - 1. Replace Section 00 41 00 BID FORM in its entirety with revised BID FORM attached to this Addendum.
- B. Section 09 96 59, EPOXY MIC COATING SYSTEMS
 - 1. Part 3.02, revised to include Paragraph *R*, "*Prior to applying the Patching/Resurfacing or Spall Repair Patching Material, the prepared existing concrete substrate shall be tested for surface adhesion. Surface adhesion of the prepared existing concrete substrate shall be tested in accordance with ASTM C1583 at a minimum of six random locations at each site and as required by the manufacturer. Each test shall consist of a minimum of three 50mm dollies which are adhered to the wall. The nearsurface tensile strength of the substrate shall exceed 300 psi and meet the patching/resurfacing material manufacturer's requirements for adhesion of the material to the prepared surface. If pull tests average less than the required strength, then the substrate shall be re-grit blasted, removing at least 1/8" of concrete thickness and retested until it meets the specified near-surface tensile strength.*"

All other terms and conditions of the PROJECT MANUAL remain unchanged.
