I. SCOPE OF SOLICITATION

ACQUIRE SERVICES & SUPPLIES / EQUIPMENT (JAN 2006): The purpose of this solicitation is to acquire services and supplies or equipment complying with the enclosed description and/or specifications and conditions. [01-1005-1].

Horry County Schools seeks to establish a term contract for uniform rental services in accordance with all requirements stated herein.

These specifications cover services to furnish all supplies, materials, supervision, labor, travel, and equipment necessary to provide the services requested for the district.

MAXIMUM CONTRACT PERIOD – (ESTIMATED) (JAN 2006): Start date: 03/07/2021 End date: 03/06/2026.

Dates provided are estimates only. Any resulting contract will begin on the date specified in the notice of award. See clause entitled "Term of Contract – Effective Date / Initial Contract Period". [01-1040-1]

The contract resulting from this solicitation will be a one (1) year contract with four (4) additional one year renewal options. The maximum potential contract life is five years. The Superintendent may extend this contract for an additional two (2) years through **03/06/2028**.

II. INSTRUCTIONS TO OFFERORS – A. GENERAL INSTRUCTIONS:

DEFINITIONS, CAPITALIZATION, AND HEADINGS

AMENDMENT means a document issued to supplement the original solicitation document.

BOARD means the Horry County Schools Board of Education or its successor in interest.

BUSINESS means any corporation, partnership, individual, sole proprietorship, joint stock company, joint venture, or any other legal entity

BUYER means the Procurement Officer/Specialist.

CHANGE ORDER means any written alteration in specifications, delivery point, rate of delivery, period of performance, price, quantity, or other provisions of any contract accomplished by mutual agreement of the parties to the contract.

CONTRACT means all types of Horry County Schools agreements, regardless of what they may be called, for the procurement or disposal of supplies, services, equipment or construction.

HORRY COUNTY SCHOOLS (HCS) is a public school district serving Horry County, South Carolina.

PROCUREMENT OFFICER means any person acting within the scope of his/her authority and duly authorized by Horry County Schools to enter into and administer contracts and make written determinations and findings with respect thereto, as identified as such on either the Cover Page, an amendment, or an award notice.

SOLICITATION means this document, including all its parts, attachments, and any Amendments.

SUBCONTRACTOR means any person you contract with to perform or provide any part of the Work.

III. SCOPE OF WORK / SPECIFICATIONS:

INTRODUCTION:

Horry County Schools (HCS) is one of the largest school systems in the State of South Carolina and is coterminous with Horry County's land area of approximately 1,152 square miles. The present boundaries of the District were established in 1952 as a result of the consolidation of all existing school Districts in the county. The district encompasses 56 schools in the nine attendance areas of Myrtle Beach, Carolina Forest, Conway, Socastee, North Myrtle Beach, Loris, Aynor, Green Sea Floyds and St. James. With Over 45,000 students and more than 5,200 employees, Horry County Schools is the state's third largest school district and the county's largest employer.

The District is currently governed by a board of trustees, the Horry County Board of Education, consisting of members elected in single-member Districts with the Board Chairman elected countywide. The Horry County Board of Education members have decision-making authority, the power to designate management, the ability to significantly influence operations, and have primary accountability for fiscal matters.

SCOPE OF WORK:

It is the intent of Horry County Schools (HCS) to establish a term contract to secure a vendor capable of providing a uniform program for the rental, professional laundry, repair, replacement, delivery and pick-up of uniforms in accordance with all terms and conditions herein.

MINIMUM QUALIFICATIONS:

The contract will be established with the Transportation, Facilities and Facilities Maintenance Departments. Transportation consists of Supervisors, Assistant Supervisors, Bus Drivers and Mechanics. Facilities consist of inventory, horticulture, parking and facilities maintenance. Facilities Maintenance includes, but is not limited to, maintenance of chillers, boilers, roofing, plumbing, grounds maintenance, and other activities that result in above average wear and tear of uniform garments.

The District believes that the uniforms that are provided to the staff should always project the positive image of a clean and well-organized operation with a reputation for delivery quality, professional services. As such The District is desirous of entering into a uniform service agreement with a company who will meet all performance obligations at or above the quality level specified.

Contractor shall provide delivery to any site within the District, with no minimum order, no minimum charges or minimum requirements.

A vendor shall provide all types of garments specified herein, in both men's and women's uniform styles, in a full range of garment sizes and colors for each gender.

3.2 CONTRACTORS GENERAL REQUIREMENTS:

Contractor shall provide all labor and materials and equipment necessary to provide uniform rental and laundering service for various departments in accordance with all terms, conditions and specifications in this solicitation.

Contractor warrants that all work performed under this contract will be performed in a professional manner acceptable to standards of the district.

All garments shall at all times remain the property of the contractor.

Provide a contact person or supervisor with complete authority to act on behalf of the contractor in any situation to this contract. This individual shall be the main contact person for the district representative.

All offers shall comply with all State and Federal laws, ordinances and regulations governing the uniform industry to include Occupational Safety and Health Administration (OSHA) and National Fire Protection Association (NFPA). These requirements supplement these specifications and shall take precedence in case of conflict.

Contractor License to indicate contractor is an established business in the State of South Carolina. Contractor shall meet all City and County regulations in order to operate a facility required for performance under the subsequent contract.

While the general responsibilities of the Contractor are clearly defined in the solicitation document, the selected Contractor must demonstrate a flexible working relationship with HCS so that services are successfully implemented as requirements may dictate. Additional work may be requested of the successful Contractor and the District reserves the right to add, delete, revise and expand services in response to changing requirements. Such modifications will be executed using a written Change Order with negotiated adjustments to the contract.

3.3 UNIFORM MEASURING, FITTING AND ALTERATIONS:

Contractor shall provide all new uniforms at the beginning of the contract period. Initial fittings shall be made by actual physical measurements of each district personnel whom garments will be ordered. Uniforms shall be properly fitted to each individual, including any unusual or unique sizes necessary to ensure comfortable wear. Standard Sizes will be S-3XL for shirts, jackets, and polo shirts. Standard pant sizes will be up to a 50-inch waist. Scheduling will be coordinated by district representative and the Contractor within five 5 business days of commencement of resulting contract.

District will attempt to coordinate and schedule all uniformed employees on staff for assembly at one (1) location with up to four possible appointment times. Scheduling will occur sixteen (16) business days after the Award effective date of contract for Contractor to take measurements to assure proper uniform fit. Contractor shall provide new uniforms at the initiation of the resulting contract to all employees within one (1) to three (3) weeks from initial fitting date. Size alterations or exchanges shall be made at any time if different size garments are needed due to district personnel weight change or such conditions as may warrant a change to insure comfortable wear. Contractor shall provide all long pants/slacks hemmed to appropriate inseam length for each participating District employee. Appropriate inseam length will allow pants to touch the wearer's shoe, but not allow pants to drag on the floor. Appropriate inseam length for long pants will not be so short as to expose the wearer's ankles when in a natural standing position.

Contractor shall, on a continuous basis inspect uniforms. All uniforms which appear worn and do not project the positive image of a clean and well-organized professional image shall be replaced immediately.

Contractor shall, throughout the term of the contract as requested by the district, measure employees to assure proper uniform fit. Contractor shall provide alterations as requested at no cost to the district within a two (2) week period after uniform requiring alterations is turned in.

Contractor shall provide new uniforms to any new employee within two (2) week of notification from the District representative.

The District understands that both at contract startup and throughout contract period the contractor may require a reasonable amount of additional time to provide new garments for non-standard sizes (4X or larger). Contractor shall advise the District of what constitutes non-standard sizes. The District shall determine what constitutes a reasonable time frame for delivery of non-standard size uniforms.

3.4 UNIFORM LAUNDRY:

Uniforms shall be clean and free of excessive wrinkles. Contractor shall make every effort to minimize wrinkles, including compaction wrinkles. Cleaned uniforms shall be free of dirt, grime, soil, stain, grease and odors.

Garments shall be laundered to the highest industry standards with detergents, hung on hangers and returned to each employee wrinkle-free. No starch or similar product is to be used.

Workmanship shall be of first class commercial quality to produce clean, dry, uniforms of good general appearance. It shall be performed with handiwork, cleaning substances, and heat conditioning determined to promote extended serviceability of the uniforms.

All wastewater treatment and disposal shall be made in compliance with all applicable laws and regulations. There shall be no additional surcharges for wastewater treatment.

3.5 UNIFORM REPAIRS:

Contractor shall maintain all rental uniforms in a good and serviceable condition including the replacement of zippers and buttons, and sewing of rips and tears. Good and serviceable condition shall be determined by the District and said determinations shall be unconditionally accepted by the contractor. Repairs shall be made to all garments as identified through inspection during the cleaning process or by notification of district employee.

Contractor shall provide repair bags within the first two (2) weeks of the contract and as needed throughout the term of the contract. Any uniform bagged for repairs shall be returned in a repaired condition or be replaced with a new item within one week (next delivery) at no cost to the district. Uniforms delivered with rips, holes, missing buttons, etc. will be returned to contractor and no rental charge shall be paid for that item until it is returned in an acceptable condition.

3.6 UNIFORM REPLACEMENT:

The District has the right to determine whether or not uniforms are acceptable to district standards at any time during contract period. Contractor shall replace any uniforms that the district reasonably determines to be unacceptable with new garments within two weeks from date of request.

Contractor will be responsible for replacement of worn out uniforms and minor repairs.

The contractor should also replace garments that do not pass their inspection and that cannot be repaired. Any charges for these replacement uniforms must be in accordance with the lost/replacement charge policy outlined below.

All garments considered unsightly due to mending, stains, rips or excess wear shall be replaced with garments of the appropriate size that are free of visible stain, tears or rips. These alterations and/or replacements should be completed and returned within a two (2) week period. This will allow the vendor time to order the item, attach the logo patch and clean the uniforms. Failure of the Contractor to repair or replace garments to a satisfactory condition shall be cause to withhold payment of the next invoice until repair is accomplished.

There shall be no charge for the replacement of garments that have become threadbare or worn out from normal usage.

There shall be no charge for the replacement of garments that have been in rotation for more than two (2) years.

3.7 UNIFORM LOST OR DAMAGED:

Uniforms lost or destroyed by a district employee will be paid by the district and or employee to the contractor at the depreciated value for the replacement per the bidding schedule.

The Contractor shall be required to provide a count on all garments picked up on site which must be verified by a designated district representative. This summary shall be provided for all garments whether picked up or delivered. Soiled and cleaned garments are to be delivered and picked up at a designated common area only.

Garments supplied by the Contractor under this contract are the property of the Contractor. The Contractor will notify the designated district representative of any proposed lost or missing items by the next business day, close of business. If Contractor claims garment losses by a District employee, the contractor will notify designated district representative designee within five (5) business days. The District will assist with the recovery and there will be no charges for proposed lost garments until the District has been given five (5) additional business days to recover uniforms. Any uniforms recovered after the district has been charged for a loss will be subject to a full credit from the contractor. At no time will charges for lost or missing garments prohibit, delay or suspend regularly scheduled services.

The District will assume responsibility for any documented losses where the loss has been proven to occur while the garment was in the custody of the district employee. Payment for said garments shall be based on the depreciated value for the replacement per the bidding schedule.

Invoices for damaged uniforms will only be paid when it is proven that the uniform was damaged through negligence of the district employee. The nature of a "work" uniform suggests hard use and accelerated wear of the garments. Therefore, it is the position of the district that staining will occur in the normal wearing of a work uniform and replacement with a new uniform is a normal consequence. The District will not pay for this "damage" because it occurred in the normal wearing of the work uniform.

LOST/REPLACEMENT CHARGES:

Invoicing for lost or damaged garments shall be itemized or on a separate invoice submitted to the designated district representative. All fees for lost, damaged or replacement garments must be approved in advance by the district representative or designee. Approval will be indicated by initials or signature on delivery receipt that clearly states all charges to be incurred for lost/replacement fees. The receipt must be specific and detailed. General statements that charge for loss or damaged garments without details of garment type, quantity, and personnel involved, shall not be considered and will not be paid.

At the Districts discretion, lost or damaged uniforms will be replaced at cost but will in no case exceed the stated depreciated value for the replacement per the bidding schedule.

3.8 UNIFORM INSPECTION:

The uniforms provided will be subject to inspection by the district representative. Contractor may be required to correct any defective workmanship or to replace any defective materials with no further cost to HCS.

Defective workmanship shall be corrected within three (3) business days of notification of deficiency.

3.9 UNIFORM DELIVERY/PICK-UP:

Pick-up of soiled laundry and delivery of clean laundry shall be established as mutually agreed upon by the district and the contractor. At a minimum, uniforms are to be picked up once per week. Normally contractor will pick-up each week the soiled garments and returned clean garments from the previous week. Pick-up and delivery shall occur on the same day and at the same approximate time each week. Contractor shall be responsible for notifying the facility in writing at least two weeks in advance of any change in schedule due to holidays. All deliveries should be made between 8:00 am and 4:00 pm, Monday through Thursday. Laundered garments shall be returned grouped according to individual employee, on clothes hangers and professionally laundered according to industry best practice standards.

Should the contractor miss a pick-up, a credit in accordance with the bid price shall be applied to the monthly invoice. This credit shall not apply to missed pick-ups determined to be the fault of the district. Additional deliveries and pick-ups may be arranged at the district's request and invoiced at specified bid prices.

HOLIDAYS:

If a location's normal pick up/delivery day falls on a District holiday, pick up/delivery will fall to the previous or next business day. It is the contractor's responsibility to know and plan for holidays. Notice should be posted two weeks in advance as to the revised pick-up/delivery date. Refer to the District Planning Calendar link below.

NATURAL DISASTERS/EMERGENCIES:

In the even a natural disaster or other emergency prevents regular delivery of uniforms, the Contractor shall coordinate with HCS to deliver uniforms as soon as possible. The District will not be charged until delivery is resumed.

3.10 ADJUSTMENT OF SERVICES:

The District reserves the right to adjust the size, number of uniforms, frequency of delivery and pick-ups or number of locations as may be deemed necessary during the contract period. The unit price from the bid schedule shall be utilized to determine the change in contract price resulting from adjustments in service.

Upon employee termination, or if a uniform is no longer required by an employee, the District shall return the employee's uniform(s) to the Contractor within one (1) week. No charges shall be made for rental of the terminated employee once contractor has been notified by district. No charges shall be made for employees on consecutive leave in excess of two weeks once contractor has been notified by district.

3.11 UNIFORM TRACKING SYSTEM:

Electronic Uniform Tracking/Scanning System:

Contractor shall provide an electronic scanning system to provide accountability and garment reconciliation. Garments shall be equipped with an electronic tracking system. The Electronic scanning system shall have the ability to provide the district with a weekly receipt of garments picked up and delivered. Weekly reports generated by the Electronic scanning system shall display the number of garments picked up, delivered and also compare one week's numbers with that of the previous weeks. The Electronic scanning system shall have the ability to identify reasons for any uniform shortages. The weekly report shall be delivered to the district representative after the weekly uniform delivery has been made. Discrepancies with delivery and or pick-up shall be brought to the attention of the district representative. The acknowledgement of

delivery/pickup service shall be retained by both the driver and the district representative responsible for coordinating delivery/pickup on site with contractor.

Identification tag:

As part of the Uniform tracking/scanning system each garment shall be identified with a waterproof/indelible bar code identification tag and/or Radio Frequency Identification (RFID) tracking system.

3.12 UNIFORM SPECIFICATIONS BY LINE ITEM:

Initial service shall be as listed below, but shall change from time to time as the number of employees using the contract change. Change orders will be issued to add or delete employees or uniform articles as needed.

All employees shall be issued eleven (11) uniform sets, changing five (5) sets per week.

Uniforms shall be suitable to meet the needs of the district staff. The district shall make the sole determination as suitability of uniforms offered.

Contractor shall provide long or short sleeve shirts for the standard uniform, or a combination of the two styles, as may be requested by the individual HCS employee. The mix of shirts shall remain constant through-out the term of the contract.

Uniforms for females shall be designed and sized in female sizes.

TRANSPORTATION DEPARTMENT Color preferences TBD by Transportation Coordinator

➤ **BUS DRIVER/DATA CLERK Uniform** set consists of:

- (1) Short sleeve shirt, 100% microfiber polyester, snag-resistant with moisture wicking properties. Shirt will have embroidered logo emblem on the left side.
- (1) Pair pants, Cargo, flat front, twill weave, to be zippered-fly. Fabric content and finish shall be equal to or better in quality to a 65/35 poly/cotton, with no cuffs, cargo pockets for extra room.

➤ **SUPERVISOR Uniform** set consists of:

- (1) Short or Long sleeve Oxford shirt, one button cuff with sleeve placket. Back yoke with box pleat. Fabric content and finish shall be equal to or better in quality to a 57/43 poly/cotton. Pocket on left side. Shirt will have embroidered logo emblem on the left side.
- (1) Pair pants, Cargo, flat front, twill weave, to be zippered-fly. Fabric content and finish shall be equal to or better in quality to a 65/35 poly/cotton, with no cuffs, cargo pockets for extra room.

➤ **ASST. SUPERVISOR/DRIVER TRAINERS Uniform** set consists of:

- (1) Short or long sleeve wrinkle-free shirt. Fabric content and finish shall be equal to or better in quality to a 65/35 poly/cotton. Pocket on left side. Shirt will have embroidered logo emblem on the left side.
- (1) Pair pants, Cargo, flat front, twill weave, to be zippered-fly. Fabric content and finish shall be equal to or better in quality to a 65/35 poly/cotton, with no cuffs, cargo pockets for extra room.

FACILITIES MAINTENANCE DEPARTMENT (Color preferences TBD by Facilities Maintenance Coordinator)

➤ **STANDARD Uniform** set consists of:

- (1) Short or long sleeve micro pattern shirt, standard industry high quality. Fabric content and finish shall be equal to or better in quality to a 65/35 poly/cotton. Pocket on left side. Shirt will have embroidered logo emblem on the left side.
- (1) Pair pants, Cargo, flat front, twill weave, to be zippered-fly. Fabric content and finish shall be equal to or better in quality to a 65/35 poly/cotton, with no cuffs, cargo pockets for extra room.

 - (1) Long sleeve work shirt, standard industry high quality. Fabric content and finish shall be equal to or better in quality to a 100% cotton, 6 ounce durable press twill. Lined collar, two button-through front pockets with pencil slot. Shirt will have embroidered logo emblem on the left side.
 - (1) Pair cotton work pants, Cargo, flat front, twill weave. Fabric content and finish shall be equal to or better in quality to 100% durable-press cotton, 8.5 ounce with quarter tap front pockets and two hip pockets.
 - **ELECTRICIAN Uniform** set consists of:
 - (1) Long sleeve Fire Resistant (FR) shirt. Fabric content and finish shall be equal to or better in quality to a 74% Meta-Aramid, 20% Modacrylic, 5% Para-Aramid, 1% Anti-Static fabric, two button-through front pockets. Shirt will have embroidered logo emblem on the left side. Minimum rating of APTV 9.5, ARC 2, UL 2112 certified. Shirts shall meet or exceed ASTM, NFPA and OSHA standards.
 - (1) Pair pants, lightweight carpenter pant, flat front, zippered-fly. Fabric content and finish shall be equal to or better in quality to 79% Meta-Aramid, 20% Modacrylic, 1% Anti-Static fabric, no cuffs. Minimum rating of APTV 10.1, ARC 2, UL 2112 certified. Pants shall meet or exceed ASTM, NFPA and OSHA standards.

3.13 UNIFORM LOGO

Contractor shall provide a proof for custom embroidered Logo patch within (5) business days of receipt of artwork from the district. Artwork will be provided by Facilities Maintenance Department in an electronic format.

Patch with the HCS logo affixed over the left breast pocket, letters shall be white stitched, logo and patch should be same color as garment. The HCS embroidered logo shall be affixed on the left front side of the garments. The logo shall be embroidered emblem, but must be consistent for all employees. Placement must be consistent for all uniforms. The embroidered logo patch size should be the standard size for uniforms rentals, but no larger than 4 1/2 "wide and 2 1/2" in height.

There is to be no distortion of the shape of the logo. The logo must show clear cut execution and be clean, crisp and neatly made, with full tension on all threads. No broken stitches are permissible, nor may any stitches be out of proper alignment. The embroidered logo must not crumple and must appear flat and smooth on the shirts. Shrinkage must be minimal and materials must be certified washable and dry cleanable.

Cost for district logo emblems shall be **included** in the rental price for uniforms. There shall be no additional charges for supplying the emblems or attaching them permanently to the uniforms.

3.14 CONTRACTORS PERSONNEL REQUIREMENTS:

Contractor's employees shall wear conservative-style uniform shirts. Contractor shall also provide employees with identification name tags to include employee's name, company name and/or logo. Employees shall wear name tags in plain view at all times while performing the work of the contract.

Contractor's employees may not have MP3-type or other radios which may impede hearing or sight, other than earplugs or safety glasses.

Contractor shall use only skilled, competent, trained, licensed or certified personnel.

Contractor's employees should wear appropriate clothing for their protection.

3.15 CONTRACTORS PERFORMANCE REQUIREMENTS:

Provide and maintain a telephone answering system or service, which can contact and dispatch service personnel five (5) days a week, from 8:00 am to 5:00 PM EST, excluding holidays.

Maintain a reasonable supply system of uniforms not in stock to assist with either immediately or with minimal delay in providing uniforms.

Upon arrival at HCS locations to perform work, check in at HCS front desk and meet with HCS district authority.

Provide trucks and vehicles licensed and insured for use on public streets. Vehicles shall have identification to include company's name and/or logo so that it is apparent to the nature of business of the occupant of the vehicle.

3.16 INVOICES AND BILLING:

Invoice shall be submitted on a monthly basis. Each invoice shall be itemized to identify all charges and services provided and shall be individualized for each employee. Itemized listings shall be shown by employee name and quantity of uniforms. In order to process for payment, the invoice shall contain a reference invoice number and the following information:

- Name, address, and telephone number of contractor
- Authorized PO number
- Date service received
- Signature and date of HCS personnel receiving service
- Itemized list of repairs or services (parts costs or prices, and labor charges shall be listed separately)
- Quantity, Part Number (PN), Part Description (PD), less applicable discounts in accordance with the bidding schedule.
- Date Completed. Please note the equipment pick-up date if different than the completion date.
- Taxes on parts shall be listed separately (HCS pays sales tax on parts but not on labor).
- Total dollar amount of invoice

USE OF SUBCONTRACTORS:

The Contractor shall perform the work with its own employees under its immediate supervision and shall not subcontract any portion of the work unless approved in advance by the authorized representative of the HCS Coordinator of Maintenance or designee.

ASSIGNMENT, NOVATION AND CHANGE OF NAME, IDENTITY, OR STRUCTURE (FEB 2015): (a) Contractor shall not assign this contract, or its rights, obligations, or any other interest arising from this contract, or delegate any of its performance obligations, without the express written consent of the responsible Procurement Specialist. The foregoing restriction does not apply to a transfer that occurs by operation of law (e.g., bankruptcy; corporate reorganizations and consolidations, but not including partial asset sales). Notwithstanding the foregoing, contractor may assign monies receivable under the contract provided that the state shall have no obligation to make payment to an assignee until thirty days after contractor (not the assignee) has provided the responsible Procurement Specialist with (i) proof of the assignment, (ii) the identity (by contract number) of the specific state contract to which the assignment applies, and (iii) the name of the assignee and the exact address or account information to which assigned payments should be made. (b) If contractor amends, modifies, or otherwise changes its name, its identity (including its trade name), or its corporate, partnership or other structure, or its FEIN, contractor shall

provide the Procurement Specialist prompt written notice of such change. (c) Any name change, transfer, assignment, or novation is subject to the conditions and approval required by Regulation 19-445.2180, which does not restrict transfers by operation of law. [07-7A004-2]

(b) The terms and conditions of documents (1) through (5) above shall apply notwithstanding any additional or different terms and conditions in any other document, including without limitation (i) a purchase order or other instrument submitted by HCS or (ii) any invoice or other document submitted by Contractor, or (iii) any privacy policy, terms of use, or end user agreement. Except as otherwise allowed herein, the terms and conditions of all such documents shall be void and of no effect. (c) No contract, license, or other agreement containing contractual terms and conditions will be signed by HCS. Any document signed or otherwise agreed to by persons other than the Chief Procurement Officer shall be void and of no effect. [07-7A015-2]

CONTRACT VIOLATION: During the term of the contract, contractors who violate this contract will be considered in breach and subject to cancellation for cause. Contractors may be suspended or debarred from doing business with the District. Examples of vendor violations, include, but are not limited to: (1) Adding items to the contract without approval (2) Increasing contract price without approval. (3) Misrepresentation of the contract to any District entity.

DISCOUNT FOR PROMPT PAYMENT (JAN 2006): (a) Discounts for prompt payment will not be considered in the evaluation of offers. However, any offered discount will form a part of the award, and will be taken if payment is made within the discount period indicated in the offer by the Offeror. As an alternative to offering a discount for prompt payment in conjunction with the offer, Offerors awarded contracts may include discounts for prompt payment on individual invoices. DISPUTES (JAN 2006): (1) Choice-of-Forum. All disputes, claims, or controversies relating to the Agreement shall be resolved exclusively by the appropriate Chief Procurement Officer in accordance with Title 11, Chapter 35, Article 17 of the South Carolina Code of Laws, or in the absence of jurisdiction, only in the Court of Common Pleas for, or a federal court

located in, Florence County, State of South Carolina. Contractor agrees that any act by the Government regarding the Agreement is not a waiver of either the Government's sovereign immunity or the Government's immunity under the Eleventh Amendment of the United State's Constitution. As used in this paragraph, the term "Agreement" means any transaction or agreement arising out of, relating to, or contemplated by the solicitation. (2) Service of Process. Contractor consents that any papers, notices, or process necessary or proper for the initiation or continuation of any disputes, claims, or controversies relating to the Agreement; for any court action in connection therewith; or for the entry of judgment on any award made, may be served on Contractor by certified mail (return receipt requested) addressed to Contractor at the address provided as the Notice Address on Page Two or by personal service or by any other manner that is permitted by law, in or outside South Carolina. Notice by certified mail is deemed duly given upon deposit in the United States mail. [07-7A025-1]

EQUAL OPPORTUNITY (JAN 2006): Contractor is referred to and shall comply with all applicable provisions, if any, of Title 41, Part 60 of the Code of Federal Regulations, including but not limited to Sections 60-1.4, 60-4.2, 60-4.3, 60-250.5(a), and 60-741.5(a), which are hereby incorporated by reference. FALSE CLAIMS (JAN 2006): According to the S.C. FIXED PRICING REQUIRED (JAN 2006): Any pricing provided by contractor shall include all costs for performing the work associated with that price. (B) Notice to contractor shall be to the address identified on Cover Page. Notice to HCS shall be to the Procurement Specialist 's address on the Cover Page. Either party may designate a different address for notice by giving notice in accordance with this paragraph. [07-7A050-1]

OPEN TRADE (JUN 2015): During the contract term, including any renewals or extensions, Contractor will not engage in the boycott of a person or an entity based in or doing business with a jurisdiction with whom South Carolina can enjoy open trade, as defined in SC Code Section 11-35-5300. [07-7A053-1]

PAYMENT & INTEREST (FEB 2015): HCS shall pay the Contractor, after the submission of proper invoices or vouchers, the prices stipulated in this contract for supplies delivered and accepted or services rendered and accepted, less any deductions provided in this contract. Unless otherwise specified herein, including the purchase order, payment shall not be made on partial deliveries accepted by HCS. (b) Unless otherwise provided herein, including the purchase order, payment will be made by check mailed to the payment address on "Page Two." (c) Notwithstanding any other provision, payment shall be made in accordance with S.C. Code Section 11-35-45, or Chapter 6 of Title 29 (real property improvements) when applicable, which provides the Contractor's exclusive means of recovering any type of interest from the Owner. Contractor waives imposition of an interest penalty unless the invoice submitted specifies that the late penalty is applicable. Except as set forth in this paragraph, HCS shall not be liable for the payment of interest on any debt or claim arising out of or related to this contract for any reason. (d) Amounts due to HCS shall bear interest at the rate of interest established by the South Carolina Comptroller

General pursuant to Section 11-35-45 ("an amount not to exceed fifteen percent each year"), as amended, unless otherwise required by Section 29-6-30. (e) Any other basis for interest, including but not limited to general (pre- and post-judgment) or specific interest statutes, including S.C. Code Ann. § 34-31-20, are expressly waived by both parties. If a court, despite this agreement and waiver, requires that interest be paid on any debt by either party other than as provided by items (c) and (d) above, the parties further agree that the applicable interest rate for any given calendar year shall be the lowest prime rate as listed in the first edition of the Wall Street Journal published for each year, applied as simple interest without compounding. (f) The District shall have all of its common law equitable and statutory rights of set-off. [07-7A055-3]

PAYMENT WITH PROPER INVOICE: Invoices submitted for payment for goods or services provided under this contract shall contain, as a minimum, the following information:

- Name of business concern
- Contract number or other authorization for delivery of service or property
- Complete description per individual line item
- Price and quantity of property or service actually delivered or executed.
- Shipping and payment terms.
- Name where applicable
- Title, telephone number and complete mailing address of responsible official to whom payment is to be sent; and
- Other substantiating documentation of information as required by the contract.

Invoices shall be provided to Horry County Schools at the address below. An itemized invoice shall be provided even if payment is made with a District purchase card.

During the term of the contract, if the District identifies items that have been overcharged, the contractor shall reimburse the District the difference in the overcharge(s) plus an additional ten percent of the overages. Repeated instances of overcharging the HCS's may result in the contract being terminated.

PUBLICITY (JAN 2006): Contractor shall not publish any comments or quotes HCS employees, or include HCS in either news releases or a published list of customers, without the prior written approval of the Procurement Specialist. [07-7A060-1]

PURCHASE ORDERS (JAN 2006): CONTRACTOR SHALL NOT PERFORM ANY WORK PRIOR TO THE RECEIPT OF A PURCHASE ORDER FROM HORRY COUNTY SCHOOLS. The District shall order any supplies or services to be furnished under this contract by issuing a purchase order. Purchase orders may be used to elect any options available under this contract, e.g., quantity, item, delivery date, payment method, but are subject to all terms and conditions of this contract. Purchase orders may be electronic. No particular form is required. An order placed pursuant to the purchasing card provision qualifies as a purchase order. [07-7A065-1]

SURVIVAL OF OBLIGATIONS (JAN 2006): The Parties' rights and obligations which, by their nature, would continue beyond the termination, cancellation, rejection, or expiration of this contract shall survive such termination, cancellation, rejection, or expiration, including, but not limited to, the rights and obligations created by the following clauses: Indemnification - Third Party Claims, Intellectual Property Indemnification, and any provisions regarding warranty or audit. [07-7A075-1]

RECORDS RETENTION AND RIGHT TO AUDIT: Horry County Schools has the right to audit the books and records of the vendors they pertain to this purchase order, both independent of, and pursuant to, the District Procurement Code. Such books and records shall be maintained for three (3) years from the date of final payment under the purchase order.

The District may conduct, or have conducted, performance audits of the vendor. The District may conduct, or have conducted, audits of specific requirements of this bid as determined necessary by the District.

Pertaining to all audits, vendor shall make available to the District access to its computer files containing the history of purchase order performance and all other documents related to the audit. Additionally, any software used by the vendor shall be made available for auditing purposes at no cost to the District.

TAXES (JAN 2006): Any tax the contractor may be required to collect or pay upon the sale, use or delivery of the products shall be paid by HCS, and such sums shall be due and payable to the contractor upon acceptance. Any personal property taxes levied after delivery shall be paid by HCS. It shall be solely HCS' obligation, after payment to contractor, to challenge the applicability of any tax by negotiation with, or action against, the taxing authority. Contractor agrees to refund any tax collected, which is subsequently determined not to be proper and for which a refund has been paid to contractor by the taxing authority. In the event that the contractor fails to pay, or delays in paying, to any taxing authorities, sums paid by HCS to contractor, contractor shall be liable to HCS for any loss (such as the assessment of additional interest) caused by virtue of this failure or delay. Taxes based on Contractor's net income or assets shall be the sole responsibility of the contractor. [07-7A080-1]

TERMINATION DUE TO UNAVAILABILITY OF FUNDS (JAN 2006): Payment and performance obligations for succeeding fiscal periods shall be subject to the availability and appropriation of funds therefore. When funds are not appropriated or otherwise made available to support continuation of performance in a subsequent fiscal period, the contract shall be canceled. In the event of a cancellation pursuant to this paragraph, contractor will be reimbursed the resulting unamortized, reasonably incurred, nonrecurring costs. Contractor will not be reimbursed any costs amortized beyond the initial contract term. [07-7A085-1]

THIRD PARTY BENEFICIARY (JAN 2006): This Contract is made solely and specifically among and for the benefit of the parties hereto, and their respective successors and assigns, and no other person will have any rights, interest, or claims hereunder or be entitled to any benefits under or on account of this Contract as a third party beneficiary or otherwise. [07-7A090-1]

WAIVER (JAN 2006): HCS does not waive any prior or subsequent breach of the terms of the Contract by making payments on the Contract, by failing to terminate the Contract for lack of performance, or by failing to strictly or promptly insist upon any term of the Contract. Only the Procurement Specialist has actual authority to waive any of HCS' rights under this Contract. Any waiver must be in writing. [07-7A095-1]

VII. TERMS AND CONDITIONS – B. SPECIAL:

ACCEPTANCE OF OFFERS 10% BELOW PRICE: If the district is offered the exact same item on the exact same terms and conditions as those provided under this contract by a vendor other than the contractor (the "alternate vendor") for a price that is at least ten percent less than the contract price, the district may purchase those items from the alternate vendor if the contractor does not agree to meet the offered price. Any acquisition pursuant to this clause must be documented by the Procurement Specialist in sufficient detail to satisfy the requirements of an external audit.

BANKRUPTCY – DISTRICT INFORMATION (FEB 2015): (a) All District information (as defined in the clause herein entitled "Information Security - Definitions") shall belong exclusively to the District, and Contractor has no legal or equitable interest in, or claim to, such information. Contractor acknowledges and agrees that in the event Contractor enters into proceedings relating to bankruptcy, whether voluntary or involuntary, District information in its possession and/or under its control will not be considered property of its bankruptcy estate.

(b) Contractor agrees to notify the District within forty-eight (48) hours of any determination that it makes to file for bankruptcy protection, and Contractor further agrees to turn over to the District, before such filing, all District information that is in Contractor's possession in a format that can be readily utilized by the District.

(c) In order to protect the integrity and availability of District information, Contractor shall take reasonable measures to evaluate and monitor the financial circumstances of any subcontractor that will process, store, transmit or access District information. [07-7B007-1]

CHANGES (JAN 2006): (1) Contract Modification. By a written order, at any time, and without notice to any surety, the Procurement Specialist may, subject to all appropriate adjustments, make changes within the general scope of this contract in any one or more of the following:

- (a) Drawings, designs, or specifications, if the supplies to be furnished are to be specially manufactured for HCS in accordance therewith;
 - (b) Method of shipment or packing;
 - (c) Place of delivery;
 - (d) Description of services to be performed;
 - (e) Time of performance (i.e., hours of the day, days of the week, etc.); or,
 - (f) Place of performance of the services.
 - (g) Product upgrades and new products that are offered by manufacturer.
- Subparagraphs (a) to (c) apply only if supplies are furnished under this contract. Subparagraphs (d) to (f) apply only if services are performed under this contract.

(2) Adjustments of Price or Time for Performance. If any such change increases or decreases the contractor's cost of, or the time required for, performance of any part of the work under this contract, whether or not changed by the order, an adjustment shall be made in the contract price, the delivery schedule, or both, and the contract modified in writing accordingly. Any adjustment in contract price made pursuant to this clause shall be determined in accordance with the Price Adjustment Clause of this contract. Failure of the parties to agree to an adjustment shall not excuse the contractor from proceeding with the contract as changed, provided that the District promptly and duly make such provisional adjustments in payment or time for performance as may be reasonable. By proceeding with the work, the contractor shall not be deemed to have prejudiced any claim for additional compensation, or an extension of time for completion.

(3) Time Period for Claim. Within 30 days after receipt of a written contract modification under Paragraph (1) of this clause, unless such period is extended by the Procurement Specialist in writing, the contractor shall file notice of intent to assert a claim for an adjustment. Later notification shall not bar the contractor's claim unless the District is prejudiced by the delay in notification.

(4) Claim Barred After Final Payment. No claim by the contractor for an adjustment hereunder shall be allowed if notice is not given prior to final payment under this contract. [07-7B025-1 Revised 2017 06]

CISG (JAN 2006): The parties expressly agree that the UN Convention on the International Sale of Goods shall not apply to this agreement. [07-7B030-1]

COMPLIANCE WITH LAWS (JAN 2006): During the term of the contract, contractor shall comply with all applicable provisions of laws, codes, ordinances, rules, regulations, and tariffs. [07-7B035-1]

CONFERENCE – PRE-PERFORMANCE (JAN 2006): Unless waived by the Procurement Specialist, a pre-performance conference between the contractor, district and Procurement Specialist shall be held at a location selected by the district within five (5) days after final award, and prior to commencement of work under the contract. The responsibilities of all parties involved will be discussed to assure a meeting of the minds of all concerned. The successful contractor or his duly authorized representative shall be required to attend at contractor's expense. [07-7B040-1]

CONTRACT LIMITATIONS (JAN 2006): No sales may be made pursuant to this contract for any item or service that is not expressly listed. No sales may be made pursuant to this contract after expiration of this contract. Violation of this provision may result in termination of this contract and may subject contractor to suspension or debarment. [07-7B045-1]

CONTRACTOR'S LIABILITY INSURANCE – GENERAL (FEB 2015) (MODIFIED):(a) Without limiting any of the obligations or liabilities of Contractor, Contractor shall procure from a company or companies lawfully authorized to do business in South Carolina and with a current A.M. Best rating of no less than A: VII, and maintain for the duration of the contract, insurance against claims for injuries to persons or damages to property which may arise from or in connection with the performance of the work and the results of that work by the contractor, his agents, representatives, employees or subcontractors.

(b) Coverage shall be at least as broad as:(1) Commercial General Liability (CGL): Insurance Services Office (ISO) Form CG 00 01 12 07 covering CGL on an "occurrence" basis, including products-completed operations, personal and advertising injury, with limits no less than \$1,000,000 per occurrence. If a general aggregate limit applies, the general aggregate limit shall be twice the required occurrence limit. This contract shall be considered to be an "insured contract" as defined in the policy.

(2) Auto Liability: ISO Form Number CA 00 01 covering any auto (Code 1), or if Contractor has no owned autos, hired, (Code 8) and non-owned autos (Code 9), with limits no less than \$1,000,000 per accident for bodily injury and property damage.

(3) Worker's Compensation: As required by the State of South Carolina, with Statutory Limits, and Employer's Liability Insurance with limit of no less than \$1,000,000 per accident for bodily injury or disease.

(c) Horry County Schools, and the officers, officials, employees and volunteers, must be covered as additional insureds on the CGL policy with respect to liability arising out of work or operations performed by or on behalf of the Contractor including materials, parts or equipment furnished in connection with such work or operations. General liability coverage can be provided in the form of an endorsement to the Contractor's insurance at least as broad as ISO Form CG 20 10 11 85 or if not available, through the addition of both CG 20 10 and CG 20 37 if a later edition is used.

(d) For any claims related to this contract, the Contractor's insurance coverage shall be primary insurance as respects the District, and the officers, officials, employees and volunteers. Any insurance or self-insurance maintained by the District, or the officers, officials, employees and volunteers, shall be excess of the Contractor's insurance and shall not contribute with it.

(e) Prior to commencement of the work, the Contractor shall furnish the District if requested with original certificates and amendatory endorsements or copies of the applicable policy language effecting coverage required by this section. However, failure to obtain the required documents prior to the work beginning shall not waive the Contractor's obligation to provide them. The District reserves the right to require complete, certified copies of all required insurance policies, including endorsements required by this section, at any time.

(f) Should any of the above described policies be cancelled before the expiration date thereof, notice will be delivered in accordance with the policy provisions. In addition, the Contractor shall notify the District immediately upon receiving any information that any of the coverages required by this section are or will be changed, cancelled, or replaced.

(g) Contractor hereby grants to the District a waiver of any right to subrogation which any insurer of said Contractor may acquire against the District by virtue of the payment of any loss under such insurance. Contractor agrees to obtain any endorsement that may be necessary to effect this waiver of subrogation, but this provision applies regardless of whether or not the District has received a waiver of subrogation endorsement from the insurer.

(h) Any deductibles or self-insured retentions must be declared to and approved by the District. The District may require the Contractor to purchase coverage with a lower deductible or retention or provide proof of ability to pay losses and related investigations, claim administration, and defense expenses within the retention.

(i) The District reserves the right to modify these requirements, including limits, based on the nature of the risk, prior experience, insurer, coverage, or other special circumstances. [07-7B056-2]

CONTRACTOR PERSONNEL (JAN 2006): The Contractor shall enforce strict discipline and good order among the Contractor's employees and other persons carrying out the Contract. The Contractor shall not permit employment of unfit persons or persons not skilled in tasks assigned to them. [07-7B060-1]

CONTRACTOR PERSONNEL – OBLIGATION: Contractors are responsible for the conduct of their employees, representatives and agents and for their subcontractors' and sub-subcontractors' employees, representative and agents. Suppliers are considered contractors, subcontractors or sub-subcontractors when the performance of their work (including deliveries) is conducted on District property. All such businesses/individuals shall comply with the following:

1. No drugs, alcohol, tobacco products, knives, firearms or other weapons on District property.
2. No fraternizing with, threats to, use of abusive or profane language or improper attire or actions while on District property or adjacent thereto.
3. Take all necessary precautions to ensure the safety of children and employees when performing contracted work or making/accepting deliveries on District property.
4. Secure SLED (State Law Enforcement Division) criminal background checks on every employee, representative and agent performing work, making deliveries or in any other way conducting business on District property. Ensure that no person having been convicted of violent crimes, crimes against children, illegal drug distribution, or other crimes of moral turpitude is assigned or performs work on District property. SLED background checks shall be maintained on file at the main office of the Contractor and made available to District personnel or the District's legal counsel immediately upon request.
5. Not employ or contract with, during the performance of the contract, any illegal alien workers or otherwise violate the provisions of the federal Immigration Reform and Control Act of 1986, as may be amended.
6. Not violate the provisions of the South Carolina Illegal Immigration Reform Act, as may be amended, beginning January 1, 2009, and abide by this Act regardless of the number of employees employed. Participation in E-Verify through the Dept. of Homeland Security is required by the District regardless of the number of employees you employ.
7. Provide picture ID badges for all persons performing work on District property and ensure they are worn at all times. The ID shall include the name of the individual, his/her picture and the name of their employer.

Contractors are to ensure that their subcontractors, sub-subcontractors, as well as suppliers who meet the "contractor, subcontractor or sub-subcontractor" definition above are advised of these requirements and comply with them. These are mandatory conditions for doing business (whether directly or indirectly) with Horry County Schools. The District, at its discretion, may perform random compliance checks. Any Contractor, subcontractor, sub-subcontractor, or supplier found not to be in compliance with these requirements shall result in termination of any existing contract or non-award of a contract.

CONTRACTOR'S OBLIGATION – GENERAL (JAN 2006): The contractor shall provide and pay for all materials, tools, equipment, labor and professional and non-professional services, and shall perform all other acts and supply all other things necessary, to fully and properly perform and complete the work. The contractor must act as the prime contractor and assume full responsibility for any subcontractor's performance. The contractor will be considered the sole point of contact with regard to all situations, including payment of all charges and the meeting of all other requirements. [07-7B065-1]

CONTRACTOR'S USE OF DISTRICT PROPERTY (JAN 2006): Upon termination of the contract for any reason, HCS shall have the right, upon demand, to obtain access to, and possession of, all HCS properties, including, but not limited to, current copies of all HCS application programs and necessary documentation, all data, files, intermediate materials and supplies held by the contractor. Contractor shall not use, reproduce, distribute, display, or sell any

data, material, or documentation owned exclusively by HCS without the HCS' written consent, except to the extent necessary to carry out the work. [07-7B067-1]

DEFAULT (JAN 2006): (a)(1) HCS may, subject to paragraphs (c) and (d) of this clause, by written notice of default to the Contractor, terminate this contract in whole or in part if the Contractor fails to-(i) Deliver the supplies or to perform the services within the time specified in this contract or any extension; (ii) Make progress, so as to endanger performance of this contract (but see paragraph (a)(2) of this clause); or (iii) Perform any of the other material provisions of this contract (but see paragraph (a)(2) of this clause). (2) The State's right to terminate this contract under subdivisions (a)(1)(ii) and (1)(iii) of this clause, may be exercised if the Contractor does not cure such failure within 10 days (or more if authorized in writing by the Procurement Specialist) after receipt of the notice from the Procurement Specialist specifying the failure.

(b) If HCS terminates this contract in whole or in part, it may acquire, under the terms and in the manner the Procurement Specialist considers appropriate, supplies or services similar to those terminated, and the Contractor will be liable to the District for any excess costs for those supplies or services. However, the Contractor shall continue the work not terminated.

(c) Except for defaults of subcontractors at any tier, the Contractor shall not be liable for any excess costs if the failure to perform the contract arises from causes beyond the control and without the fault or negligence of the Contractor. Examples of such causes include (1) acts of God or of the public enemy, (2) acts of the State in either its sovereign or contractual capacity, (3) fires, (4) floods, (5) epidemics, (6) quarantine restrictions, (7) strikes, (8) freight embargoes, and (9) unusually severe weather. In each instance the failure to perform must be beyond the control and without the fault or negligence of the Contractor.

(d) If the failure to perform is caused by the default of a subcontractor at any tier, and if the cause of the default is beyond the control of both the Contractor and subcontractor, and without the fault or negligence of either, the Contractor shall not be liable for any excess costs for failure to perform, unless the subcontracted supplies or services were obtainable from other sources in sufficient time for the Contractor to meet the required delivery schedule.

(e) If this contract is terminated for default, HCS may require the Contractor to transfer title and deliver to the District, as directed by the Procurement Specialist, any (1) completed supplies, and (2) partially completed supplies and materials, parts, tools, dies, jigs, fixtures, plans, drawings, information, and contract rights (collectively referred to as "manufacturing materials" in this clause) that the Contractor has specifically produced or acquired for the terminated portion of this contract. Upon direction of the Procurement Specialist, the Contractor shall also protect and preserve property in its possession in which HCS has an interest.

(f) HCS shall pay contract price for completed supplies delivered and accepted. The Contractor and Procurement Specialist shall agree on the amount of payment for manufacturing materials delivered and accepted and for the protection and preservation of the property; if the parties fail to agree, the Procurement Specialist shall set an amount subject to the Contractor's rights under the Disputes clause. Failure to agree will be a dispute under the Disputes clause. HCS may withhold from these amounts any sum the Procurement Specialist determines to be necessary to protect the District against loss because of outstanding liens or claims of former lien holders.

(g) If, after termination, it is determined that the Contractor was not in default, or that the default was excusable, the rights and obligations of the parties shall, if the contract contains a clause providing for termination for convenience of HCS, be the same as if the termination had been issued for the convenience of HCS. If, in the foregoing circumstances, this contract does not contain a clause providing for termination for convenience of HCS, the contract shall be adjusted to compensate for such termination and the contract modified accordingly subject to the contractor's rights under the Disputes clause.

(h) The rights and remedies of HCS in this clause are in addition to any other rights and remedies provided by law or under this contract. [07-7B075-1]

DISPOSAL OF PACKAGING (JAN 2006): Contractor shall dispose of all wrappings, crating, and other disposable materials pertaining to this contract at the end of each working day and upon completion of installation. [07-7B085-1]

ESTIMATED QUANTITY - UNKNOWN: The total quantity of purchases of any individual item on the contract is not known. HCS does not guarantee that the District will buy any specified item or total amount. The omission of an estimated purchase quantity does not indicate a lack of need but rather a lack of historical information. [07-7B095-1]

ILLEGAL IMMIGRATION (NOV 2008): (An overview is available at www.procurement.sc.gov) By signing your offer, you certify that you will comply with the applicable requirements of Title 8, Chapter 14 of the South Carolina Code of Laws and agree to provide to the District upon request any documentation required to establish either:

(a) that Title 8, Chapter 14 is inapplicable to you and your subcontractors or sub-subcontractors; or

(b) that you and your subcontractors or sub-subcontractors are in compliance with Title 8, Chapter 14. Pursuant to Section 8-14-60, "A person who knowingly makes or files any false, fictitious, or fraudulent document, statement, or report pursuant to this chapter is guilty of a felony, and, upon conviction, must be fined within the discretion of the court or imprisoned for not more than five years, or both." You agree to include in any contracts with your subcontractors language requiring your subcontractors to (a) comply with the applicable requirements of Title 8, Chapter 14, and (b) include in their contracts with the sub-subcontractors language requiring the sub-subcontractors to comply with the applicable requirements of Title 8, Chapter 14. [07-7B097-1]

INDEMNIFICATION - THIRD PARTY CLAIMS – GENERAL (NOV 2011): Notwithstanding any limitation in this agreement, and to the fullest extent permitted by law, Contractor shall defend and hold harmless Indemnitees for and against any and all suits or claims of any character (and all related damages, settlement payments, attorneys' fees, costs, expenses, losses or liabilities) by a third party which are attributable to bodily injury, sickness, disease or death, or to injury to or destruction of tangible property arising out of or in connection with the goods or services acquired hereunder or caused in whole or in part by any act or omission of contractor, its subcontractors, their employees, workmen, servants, agents, or anyone directly or indirectly employed by them or anyone for whose acts any of them may be liable, regardless of whether or not caused in part by an Indemnitee, and whether or not such claims are made by a third party or an Indemnitee; however, if an Indemnitee's negligent act or omission is subsequently determined to be the sole proximate cause of a suit or claim, the Indemnitee shall not be entitled to indemnification hereunder. Contractor shall be given timely written notice of any suit or claim. Contractor's obligations hereunder are in no way limited by any protection afforded under workers' compensation acts, disability benefits acts, or other employee benefit acts. This clause shall not negate, abridge, or reduce any other rights or obligations of indemnity which would otherwise exist. The obligations of this paragraph shall survive termination, cancelation, or expiration of the parties' agreement. This provision shall be construed fairly and reasonably, neither strongly for nor against either party, and without regard to any clause regarding insurance. As used in this clause, "Indemnitees" means Horry County Schools, its instrumentalities, agencies, departments, boards, and all their respective officers, agents and employees. [07-7B100-2]

LICENSES AND PERMITS (JAN 2006): During the term of the contract, the Contractor shall be responsible for obtaining, and maintaining in good standing, all licenses (including professional licenses, if any), permits, inspections and related fees for each or any such licenses, permits and /or inspections required by the state, county, city or other government entity or unit to accomplish the work specified in this solicitation and the contract. [07-7B115-1]

MATERIAL AND WORKMANSHIP (JAN 2006): Unless otherwise specifically provided in this contract, all equipment, material, and articles incorporated in the work covered by this contract are to be new and of the most suitable grade for the purpose intended. [07-7B120-1]

PRICE ADJUSTMENTS (JAN 2006): (1) Method of Adjustment. Any adjustment in the contract price made pursuant to a clause in this contract shall be consistent with this Contract and shall be arrived at through whichever one of the
