A. SCOPE OF SERVICES

Anderson County Government, Tennessee, invites qualified vendors to submit responses to its Request for Proposal (RFP) to furnish the Anderson County Life and Disability Benefits. All applicable State, Federal laws, rules, and regulations are to be fully observed by the successful bidder.

B. CONTRACT

It is the full intent, assuming that satisfactory proposals are received, to award three (3) year contract.

C. <u>TERMINATION/CANCELLATION</u>

Anderson County reserves the right to cancel the contract upon ninety days written notice for reasons of non-performance within the terms and conditions of this request for proposal or conditions beyond control, such as inadequate funding.

D. ACCEPTANCE / REJECTION OF PROPOSAL

Award

- a. The contract will be awarded to the qualified offerer whose offer, conforming to the conditions and requirements of this request for proposal will be more advantageous to Anderson County. The committee's evaluation of criteria, cost, and other factors will be taken into consideration.
- b. Anderson County reserves the right to reject any or all offers.

- The two Classes of employees on the census for STD and LTD are regular full-time employees and EMS workers (those that are scheduled 52 hours/week regular schedule) because of the consistent overtime pay.
- Our Commissioners and Elected Officials listed on the census are annual salaries do not really apply to the Disability because they are true salaried

employees, and will receive full pay throughout their term no matter what happens to them unless they resign.

- The minimum numbers of hours an employee must work to be eligible for LTD benefits is 30 hours per work. Only benefit eligible employees are listed on the census that work 30+ hours per week are listed, with the exception of Commissioners.
- EMT's and Paramedics are considered EMS employees in regards to Class 2 on the LTD.
- We will receive bids through a broker and would prefer the compensation be built into the rates as commission (however, we want those commission rates to be reflected in the bid and identified as to what those rates are).

- 1.1 PROTEST: Any vendor wishing to protest the award shall notify in writing the Anderson County Purchasing Agent. No protest will be accepted, except those protests made in writing and received within (10) ten calendar days of the award.
