Question 1)

I received the new scope of work today and wanted to clarify the warranty. You are not calling for an NDL warranty anymore, are you? It seems like you only need the manufacturer's 20 yr material warranty and a two year contractor warranty, but I didn't want to assume.

Reply:

Item No. 10 in the scope of Services should be corrected to read as follows: Furnish membrane manufacturer's twenty (20) year No Dollar Limit (NDL) warranty. Manufacturer's warranty will be limited to a 155-MPH maximum wind speed.

Question 2) Are you still requiring a cover board? It is not necessary per the manufacturer's specs.

Reply:

This project was designated as "Design/Build" to rely on the contractor's expertise in matching the available products to the County's best advantage. The contractor should include any products and materials that are required by the manufacturer in meeting the warranty prerequisites. If a cover board is not required by the manufacturer, it will not be necessary.
