REQUEST FOR QUALIFICATIONS FOR ARCHITECTURAL SERVICES

The Franklin County Fiscal Court, 321 W. Main Street Frankfort, Kentucky, is soliciting qualifications from architects for services relating to the planning, design, plan preparation, and permitting related services for the renovation of an existing structure located at 231 East Main Street in Frankfort, Kentucky. The building is being renovated for use as a possible homeless shelter and administrative offices.

Professional services will include, but are not limited to, architectural services to accomplish the following:

- Acquiring needed permits, authorizations and approval for the design

The Statement of Qualifications, not to exceed 30 pages, must be submitted electronically to the Franklin County Fiscal Court at the following web address https://TINYURL.COM/FCFCRFP no later than 2:00 p.m. local time on November 2, 2020. At 2:15 p.m. local time, on November 2, 2020, the Statement of Qualifications will be publicly opened and the name of each firm read aloud. This public opening of the submittals will be live streamed on the Franklin County KY Facebook page at Facebook.com/fcfcky. All submittals shall be clearly marked "Architectural Services-231 E. Main Street". A submittal of statement of qualifications received after the specified date and time will not be considered.

The statement of qualifications should include a description of the firm's capabilities and experience in the field of architecture relating to mixed use or shelter facilities (20 points), the firm's location (20 points), and ability to provide responsive service to the Franklin County Fiscal Court (20 points). Firms responding to the request will be ranked according to the written information submitted. The Franklin County Fiscal Court will enter into negotiations with the highest ranked qualifying firm to execute an architectural services agreement. If the parties are unable to negotiate a satisfactory agreement, the second ranked firm will be promptly notified.

Franklin County Fiscal Court is an Equal Opportunity Employer. No person, firm or corporation shall be excluded from participation in or subject to discrimination in providing these services on the basis of race, color, sex, religion, national origin, disability, age or sexual orientation.
