Bids are opened and read aloud to the public at the Robertson County Finance Office, 523 S. Brown Street, Springfield, TN 37172 immediately after the bid receipt deadline. Each vendor may submit more than one bid provided each bid meets the stated specifications. Each bid must be submitted in a separate sealed envelope with the appropriate notation on the outside. All bids must be signed by an authorized agent and submitted on the prescribed forms. Submission of bids by telegraph, telephone, or other electronic means is strictly prohibited. Any brand name called for the bid specifications is provided as a reference only. Alternate brand name items offered for bid must be equivalent as to function, basic design, type and quality of material, method of construction, and any required dimensions. Bidder must attach a letter of exception to specifications.

Police Equipment:

All equipment listed below must be "New" equipment from a reputable manufacturer (no generics). "Refurbished" or "Used" equipment will not be allowed for installation per this equipment specification list.

Optional Graphics

All Robertson County Sheriff's Office reflective markings to include front hood, driver's side, passenger side and rear of vehicle per attached photos and specifications to fit Utility vehicle. All decals must match enclosed diagrams and photographs. Hood decals shall be centered on the vehicle. Sheriff's stars (hood and each side) should be cut out to show a white border between the star and stripes. The "Sheriff" lettering along the side of the vehicle should be outlined in the same fashion. (2025 Specs not released at this time).

Light Bar Options

> Option 1

44" low profile, linear LED light bar. Combines effective warning with tactical benefits such as left-flood, right flood, or full flood capability. Integrated Signal Master directional capability. All LEDs must be Blue and White. Light bar should be programmed to flash blue and white LEDs while flashing. The light bar should be programmed with a dimmable function when flashing along with solid blue patrol setting (Complete with 5-year manufactures warranty)

> Option 2

48" low profile, linear LED light bar. Combines effective warning with tactical benefits such as left-flood, right flood, or full flood 360-degree scene lighting capability. Integrated rear arrow controls. All LEDs must be Blue and White. Light bar should be programmed to flash blue and white LEDs while flashing. The light bar should be programmed with an auto dimmable function when flashing along with solid blue patrol setting (Complete with 5-year manufactures warranty)

Control System Options

 - Programmable siren/light controller with remote-mount amplifier. Easy installation. Incorporates FS Convergence Network technology to provide

a high level of customizable configuration. Plug and play installation and programming software for easy configuration via laptop computer. Compatible with Ford Interceptor Switch Module. 17 backlit push-buttons and a 4-position slide switch. Push buttons turn brighter when pushed and can be programmed. Siren/light controller must be programmed and wired directly to all lights and light bar. Must include a visual reference system that allows the user to see what directional pattern is selected while looking at the control head. Must offer the following siren tones: wail, yelp, hi/low, ultra hi/ low, air horn, rumbler and hetro). Must also function as a PA, radio broadcast and air horn. Must include a horn ring transfer capability, allowing the user to push the steering wheel horn button to change from one siren tone to the next. Programmed with gun lock with unlabeled key. Added Rumbler/Howler speaker addition for low frequency siren.

Programmable matrix programming. USB programmability. 100w dual tones with 200w versions. Backlit pushbuttons with slide position switch. Must offer the following siren tones: wail, yelp, hi/low, ultra hi/low, air horn, rumbler and hetro) or similar. Must also function as a PA, radio broadcast and air horn. Must include a horn ring transfer capability, allowing the user to push the steering wheel horn button to change from one siren tone to the next. Programmed with gun lock with unlabeled key. Added Rumbler/Howler speaker addition for low frequency siren.

100w (minimum) weather resistant external speaker mounted on to front push bumper (listed below).

Push Bumper with Blue LED lights installed on push bumper frame and wrap around kit that extends across and around the front of the vehicle, TIR3 or higher type LEDS. (6 Blue LED lights 4 forward, 1 on each side)

Cage behind Front Driver and Passenger Seats with 2 pc lower extensions behind driver and passenger seats, roll bar, sliding glass panel with expanded metal mesh insert or partition and floor pan.

Outboard Seat Belt set (reverse seatbelts for transportation of prisoners).

Install rear passenger window interior guard bars on both rear driver's side and passenger side windows.

Plastic Rear Transport Seat with matching floor pans and rear partition to fit above listed cage. (Rear Partition must separate rear passenger seat compartment from rear cargo area using a poly window rear cargo barrier to prevent access of detainees from being able to reach equipment located in rear cargo area or escape.)

Center Console with arm-rest and cup holders – installed so not to interfere with the insertion or removal of shotgun or patrol rifle in center mounted gun lock (listed below). Must also accommodate all equipment (radio, and control center for lights/siren).

Tactical vehicle gun mount with locks for Shotgun and Ar-15 style patrol rifle, mounted between front driver's seat and passenger seat behind center consol. Gun mount needs to have "handcuff key" and remote electronic lock push button, which can be activated by officer. Remote electronic button needs to be concealed and not visible by detainees in rear seat.

Adjustable computer mounts with a mounting bracket (center console) made from highstrength composite and powder-coated steel. Mount must include laptop adjustable support arm to secure laptop screen. Must accommodate laptops that are 11"-14" in screen size. Mounts should be fastened to the center console.

Minimum "1200" watt power inverter directly wired to vehicles battery with 100 AMP Circuit Breaker. (Inverter must have 2 standard 110 plugs.)

Additional 3-hole 12v lighter type plug power outlet to accommodate other devices. Outlet must be secured to vehicle or center console.

Duty Flashlight – LED style with side and rear push button on-off switch (Medium Size), complete with charger mounted to vehicle or to center console.

Driver's side LED spotlight with rotational handle and arm (if not installed at the factory).

Vehicle Anti-Theft System installed, pedal or push-button activation of shift lever.

Radar Unit- complete with front and rear antennae, display unit, and remote control. Must feature: automatic same direction tracking, intelligent fastest speed tracking, 3 window multi-colored LED display, read-thru lock, cordless infrared remote, compensated true audio doppler, digital antennae communications, narrow beam width, waterproof Ka Band antenna, smart detachable display unit. Operating Frequency 33.4 GHz- 36.0 GHz (Ka Band). Triple 3-digit Light Emitting Diode for target, lock, and patrol speeds. Must be accurate to +1, +/- 2 while stationary, +/- 2 while moving. Automatic self-test every 10 minutes while transmitting.

Mobile ASTRO P25 Digital Radio, 35 watts or greater **Installation equipment and install needed (antenna, connections, and power supply). No radio is needed. (Motorola APX6500e – operating on current TACN Digital Trunked radio network). The antenna must be mounted in the center of the roof, rearward of the light bar using a small antenna. The radio system must have an external speaker mounted within the front passenger compartment with the microphone. The radio system should be wired to the external PA / Speaker system to allow an officer to monitor the radio from the exterior of his patrol unit. Installation team should be a certified Motorola Solutions partner.

Front License Plate mount installed.

Ceiling mounted interior dome light with red and white lighting functionality.

(6) LED Lights (Blue) with installation brackets for upper rear hatch mount area under spoiler.

(2) LED Lights (Blue/White) 6"x4" flush mount on each side of license plate area. (1 on each side of plate. <u>Rear (White) reverse/back-up light functionality</u>. (Not as pictured)

(2) LED's (Blue) to mount on bottom of rear hatch for warning when hatch is open with grommets.

<u>Camera installation only of Kustom cameras.</u> <u>Cameras will be purchased separate</u> by the Robertson County Sheriff's Office and delivered for installation.

All equipment that is listed above shall be of a reputable brand/manufacturer, fully installed, and in complete operation according to manufacturers and customers' specifications. This bid should include all wiring harnesses, installation charges, and any other items or equipment needed to completely mount the above listed equipment in a vehicle in complete operating condition. Installers are to consult with the Robertson County Sheriff's Office Fleet Manager for additional specifications on the above listed equipment.
