OBJECTIVE:

In determining the lowest responsible bidder, Progressive Energy Group and Kendall County will consider the overall proposal, the best contract pricing with the least contingencies, the company's knowledge of the business, as well as the company's ability to meet the County's service requirements.

Progressive Energy Group and Kendall County Personnel will review written proposals and intend to make its selection based on these proposal documents. Kendall County, at its discretion, may choose to consider a multi-year contract option.

Please submit a written proposal for a contract term beginning with the June 2019 meter readings for a period of 12, 18, 24, 30, 36, and 48 months. Kendall County is requesting "All Inclusive" fixed pricing. Included in this RFP document is the Kendall County Electric Supplier Proposal Form (attached) that your company must complete, in order for the submitted bid to be accepted. Please return this completed form with your proposal.

PROPOSAL REQUIREMENTS:

- 1. "All Inclusive" Fixed Pricing beginning June 2019 for the following:
 - a. Contract Term Length 12, 18, 24, 30, 36, and 48 months
 - b. Number of Accounts 10
 - c. "All Inclusive" pricing includes energy, capacity, ancillary, transmission, and line loss charges
 - d. Consolidated Monthly Invoicing
 - e. Annual kWh volume = 5,342,335
 - f. Submitted pricing is inclusive of all supply fees and commissions

ADDITIONAL PROPOSAL REQUIREMENTS

- 1. A redline contract copy in Microsoft Word(preferred) for Kendall County State's Attorney's Office's review.
- 2. Sample Copy of Monthly Invoice
- 3. A 45-day invoice payment term, and payment plan in compliance with the Illinois Local government Prompt Payment Act, 50 ILCS 505/1, et seq.
- 4. Credit Approval for Quantities and Terms Requested in RFP.





- 5. Kendall County expects the selected supplier to work through Progressive Energy Group, acting on Kendall County's behalf, in relation to the resulting agreement.
- 6. Any agreement resulting from this RFP, must comply with the laws, rules, and regulations of the State of Illinois and the Federal government. No resulting agreement shall penalize Kendall County for complying with the law, including, but not limited to, 55 ILCS 5/6-1005, which prohibits a county from incurring expenses for which it has not appropriated funds.

EVALUATION PROCESS

Step 1: All proposals will be reviewed and evaluated by Progressive Energy Group and Kendall County personnel. The proposals will be evaluated based on the criteria listed below.

- (A) The best pricing proposal.
- (B) Status as a qualified supplier.
- (C) 3 References as required by Kendall County.
- (C) Compliance with all PROPOSAL REQUIREMENTS and the PROPOSAL FORM.
- Step 2: Contract negotiations will commence with the lowest responsible bidder. Firms not selected will be notified of the selection outcome.
- Step 3: If negotiations with the lowest responsible bidder fail to produce an agreeable contract, Kendall County reserves the right to enter negotiations with the next lowest responsible bidder, and to continue down the line of lowest responsible bidders until an agreeable contract is reached.
- Step 4: The contract will be executed between the selected Retail Electric Supplier and Kendall County.
