### **1.0 INTRODUCTION**

#### 1.1 Purpose of Procurement

**3.1** The Lumpkin County Board of Commissioners is requesting proposals from qualified and licensed professionals to provide operation and management services for its Pinetree Recreation Center. The County welcomes proposals for both possible scopes as well as proposals from firms that may only want to propose one scope or the other. Proposing only one scope does not remove you from consideration. The detailed scopes of work can be found in **Section 2.0**.

### **1.2** Proposal Certification

Pursuant to the provisions of the Official Code of Georgia Annotated § 50-5- 67(a), Lumpkin County certifies that the use of competitive sealed proposals will be practical or advantageous to the County in completing the acquisition described in this document.

The owner shall have the right to waive any informality, irregularity, or insufficiency in the proposal procedure and in any proposal or proposals received, and to accept the proposal which, in the Owner's sole judgment, is in the Owner's own best interest. The Owner shall have the right to accept any proposal.

### 1.4 Restrictions on Communications

From the issue date of this RFP until a vendor is selected and the award is announced, contractors are not allowed to communicate about this project with any County staff or elected officials except: 1) through the Purchasing Agent named herein, 2) at the Pre-Proposal Meeting (if applicable to project), or 3) as provided by existing work agreement(s). The County reserves the right to reject the submittal of any vendor violating this provision.

#### 1.5 Pre-Proposal Conference

A pre-proposal meeting will be held on Thursday, November 9, 2023 at 11:00 AM at the Lumpkin County Administration Building located at 99 Courthouse Hill, Dahlonega, GA 30533 in the First Floor Conference Room. A visit to the site will immediately follow the end of the pre-proposal meeting.

#### 1.6 Questions & Addenda

No response to inquiries, other than written, will be binding upon the County. Lumpkin County reserves the right to issue written addenda to any inquiries that alter the scope of the RFP. Addenda shall be posted to the county website, <u>www.lumpkincounty.gov</u>, under the Bids & Solicitations tab no later than 5:00 PM, November 15, 2023. A signed copy of any addenda shall accompany submitted proposals. **Contractors are advised to check the website for addenda before submitting their proposals.** 

#### 1.7 Contract Term

The initial contract term between the County and the contractor shall be from January 1, 2024 to December 31, 2024 and will be eligible for up to four (4) annual renewals.

Lumpkin County reserves the right to terminate the contract, with 30 days written notice, for any violations in the terms of this agreement or unreconciled issues arising as a result of this agreement. Vendor agrees to provide 30 days written notice and complete any ongoing activities if Vendor chooses to opt out of an agreement with the County.

### 1.9 Exception to RFP

Each contractor shall be deemed to agree to comply with all terms, conditions, specifications, and requirements of this RFP. An "exception" is defined as the Proposer's inability or unwillingness to meet a term, condition, specification, or requirement in the manner specified in the proposal. All exceptions taken <u>must</u> be

identified and explained in writing in your RFP and must specifically reference the relevant section(s) of this RFP. If the Proposer provides an alternate solution when taking an exception to the requirement, the benefits of this alternative solution and impact, if any, on any part of the remainder of the Proposer's solution must be explained in detail.

The County welcomes innovative suggestions and recommendations from Proposers that will ensure a 100% successful service approach.

### 2.0 SCOPE OF WORK

The Lumpkin County Board of Commissioners is requesting proposals from qualified and licensed professionals to provide operation and management services for its Pinetree Recreation Center. The submission must, at a minimum, include a proposal for one or both of the possible scopes. **The TWO possible scopes** are: (1) managing the facility, together with all of the amenities, described in this RFP or, (2) managing the facility, together with all portions of only aquatic operations.

### SCOPE OF WORK #1

The Scope of Work for Total Pinetree Way Recreation Center Management includes, but it not limited to:

- 1. Provide all necessary trained and certified staff, including lifeguards and programming for the operation and management of the aquatic facility, as well as maintaining the proper certifications required, including either a Certified Pool Operator (CPO) or Aquatic Facility Operator (AFO). The expected commitment is to operate the aquatic center 7 days a week for a minimum of 8 hours per day. Vendor will be responsible for management of personnel, including employment, providing certifications/re-certifications, ongoing training, performance reviews, employee discipline, and terminations.
- 2. Formation and implementation of day-to-day operating programs, business plans, budgets, and marketing/advertising plans.
- 3. In coordination with the County, program development and management, including lessons, leagues, rentals, group programs, events, and open activities. The expected commitment is for a full offering of programs and services in all areas of the center, outdoor aquatic facility, two gymnasiums, outdoor pickleball courts, and meeting rooms.
- 4. Regulate and maintain a positive controlled environment and provide for the enforcement of pool rules and regulations in accordance with applicable EPA and other agency laws. Be familiar with all local and state health department guidelines for pools and concessions to ensure facility is furnished with all required safety equipment and adhering to all local and state policies.
- 5. Must provide a non-DOT drug and alcohol policy that includes random drug testing.
- 6. Assist in the development of fee schedules for items including, but not limited to, facility membership, class fees, and facility rentals.
- 7. Use and operate the County provided accounting software and point of sale system for the input of collections and accounting of all revenue

required by Lumpkin County.

- 8. Preparation of weekly, monthly, and annual financial operating statements in formats required by Lumpkin County.
- 9. Daily custodial care of the entire facility with a particular emphasis on cleanliness and facility maintenance of the aquatic areas, systems, equipment, filters, and surrounding areas.
- 10. Test safety equipment and water quality and vacuum the pool on a daily basis.
- 11. Assist with identification, implementation and expense associated with any capital improvements or capital equipment.
- 12. Supply and ensure an adequate inventory of first aid supplies and pool chemicals adequate to the size and operation of the facility.
- 13. Provide written reports on equipment and pool safety checks, water quality tests, the life expectancy of equipment, and inventory of supplies as required by the County.
- 14. Manage customer service complaints or inquiries and distribute surveys according to County protocol.
- 15. Ensure all staff is provided with professional and identifiable uniforms that they are required to wear during their entire shift.
- 16. Provide after-hours emergency contacts for the on-site manager and supervisor.
- 17. Ensure times are scheduled to accommodate all Lumpkin County Parks and Recreation functions and programs.
- **18**. A designee of Lumpkin County Board of Commissioners shall be included in the selection process of the facility/aquatics general manager.
- **19**. Provide concessionaire services during all programming. Daily, weekly, monthly scheduling of staff including Management, supervisors, lifeguards, maintenance, concessions staff, programmers, recreation staff.
- 20. Develop, implement, and train staff in facility Emergency Action Plans including but not limited to including general procedures for land rescues, water rescues, missing persons, and inclement weather guidelines.
- 21. Develop zones of coverage for lifeguards and lifeguard rotation plan, as well as accident/incident and fecal management guidelines and reporting.
- 22. Develop staff policies & procedures manual with assistance of Lumpkin County staff.

### SCOPE OF WORK #2

The Scope of Work for Managing the Aquatic operations of the Pinetree Way Recreation Center Management includes, but it not limited to:

- 1. Provide all necessary trained and certified staff, including lifeguards and programming for the operation and management of the aquatic facility, as well as maintaining the proper certifications required, including either a Certified Pool Operator (CPO) or Aquatic Facility Operator (AFO). The expected commitment is to operate the aquatic center 7 days a week for a minimum of 8 hours per day. Vendor will be responsible for management of personnel, including employment, training, and terminations.
- 2. Formation and implementation of day-to-day operating programs, business plans, budgets, and marketing/advertising plans.
- 3. In coordination with the County, program development and management,

including lessons, leagues, rentals, group programs, events, and open activities. The expected commitment is for a full offering of programs and services in all areas of the center.

- 4. Regulate and maintain a positive controlled environment and provide for the enforcement of pool rules and regulations in accordance with applicable EPA and other agency laws.
- 5. Must provide a non-DOT drug and alcohol policy that includes random drug testing.
- 6. Use and operate the County provided accounting software and point of sale system for the input of collections and accounting of all revenue required by Lumpkin County.

- 18. Daily, weekly, monthly scheduling of staff including Management, supervisors, lifeguards, maintenance, concessions staff, programmers, recreation staff.
- 19. Develop, implement, and train staff in facility Emergency Action Plans including but not limited to including general procedures for land rescues, water rescues, missing persons, and inclement weather guidelines.
- 20. Develop zones of coverage for lifeguards and lifeguard rotation plan, as well as accident/incident and fecal management guidelines and reporting.
- 21. Develop staff policies & procedures manual with assistance of Lumpkin County staff.

Services Provided by the County

- 1. The facility grounds and building maintenance will be performed by the County.
- 2. County staff will formulate a revenue and expense budget and facility fee schedule in conjunction with the Management Firm.

- 3. Security for the facility will include indoor and outdoor cameras.
- 4. Furnish water, telephone, and electricity and will be responsible for the payment of all utilities.
- 5. Retain the right to inspect pools, buildings, fixtures, improvements, furnishings, machinery, or equipment at any time.
- 6. If the County elects to proceed with a contract for aquatic operations management only, concession operations will be conducted by the County.

### TECHNICAL SPECIFICATIONS- To be included with Qualifications Proposal

- 1. Must demonstrate 5+ years of experience in managing an aquatic facility of comparable or greater size and budget. Show experience in planning, organizing, and implementing instructional classes, exercise and fitness programs. Include information on recent management of a minimum of one municipal aquatic facility.
- 2. Provide examples of successful and cutting-edge marketing and business plans. Please explain the marketing plan you could potentially use for this facility.
- 3. Provide documentation that shows a proven financial success and sustainability of operations.
- 4. Provide evidence of insurance in accordance with County requirements.
- 5. All employees are required to have First Aid, CPR, and AED Training and Certifications. All lifeguards are required to hold at minimum, a current, nationally recognized Lifeguard certification (preferably American Red Cross), First Aid, CPR, AED, Oxygen, and Water Park Lifeguard Certifications. Successful Offeror should specify which nationally recognized Lifeguard certification will be utilized. All swim lesson instructors are required to have an American Red Cross Water Safety Instructor Certification or a suitable equivalent. If using another program besides American Red Cross, please provide the curriculum/syllabus of training with your proposal.
- 6. The respondent will provide a suggested timeline for staffing the facility including recruiting, hiring, and training timelines with a projected open date of May 1, 2024.
- 7. Evidence of knowledge of current aquatic industry standards of care related to water chemistry and disease prevention procedures; lifeguard best practices; use of adjunct equipment (i.e., rescue equipment, automatic external defibrillator units, and emergency oxygen).
- 8. Evidence of knowledge of current risk management best practices, community- based programming, and event management.
- 9. Experience in successfully implementing aquatic risk management procedures that include, at a minimum, facility operational audits, lifeguard performance audits, and vigilance awareness validation, and guidelines/plans for continuous in-service training of the lifeguards.
- 10. The Successful Offeror will be responsible for hiring the appropriate number of qualified personnel (who will be employed exclusively for the performance of the said contract) to conduct the daily operation and management of the facility and will comply with all federal, state, and local laws related to minimum age, social security, nondiscrimination, Americans with Disabilities Act (ADA), unemployment compensation

and Workers' Compensation. All personnel employed by the Successful Offeror shall be paid in accordance with Federal and State Minimum Wage Law. The Successful Offeror shall be responsible for the payment of all employment taxes, social security taxes and background checks related to the employment of the said personnel. Personnel employed by the Contractor shall be required to pass a criminal background check and a sexual offender background check. Evidence of each employee's successful passing of all background screenings will be required to be provided to the County prior to any employee working at the facility. Any employee not meeting this requirement will not be permitted to work at the facility.

- 11. The County shall have the right to request a replacement of any of the Contractor's employees whose conduct, character, or performance is not in the best interest of the County. The Contractor agrees to make the replacement of said employees within five (5) calendar days.
- 12. The selected firm will be required to perform all aquatic facility management services, as well as financial, accounting practices, and procedures to accomplish the County's goals and expectations for the operations of the Pinetree Recreation Center. The firm will work with the County to develop a scope of services that meets the County's expectations and operations budget.
- 13. The management company shall outline its policy for facility maintenance i.e vacuuming of the pools; pool bathrooms; areas surrounding the pool etc. Management company shall also outline janitorial services and care of facility's interior public spaces.
- 14. The management company shall notify County staff immediately of any needed repairs. County staff are responsible for providing corrective action whether done internally or by an outside contractor to accomplish the repair.

#### 3.0 MANDATORY PROPOSAL REQUIREMENTS

- **3.2 Overview:** The proposer shall provide detailed information so as to demonstrate their understanding of the services requested as laid out in the Technical Specifications. The County welcomes proposals for both possible scopes as well as proposals from firms that may only want to propose one scope or the other. Proposing only one scope does not remove you from consideration.
- 3.2 Documents: Proposers will submit one (1) original and three (3) copies of the proposal. Lumpkin County, Georgia is not interested in elaborate brochures. All documents will be typewritten on standard 8 ½" x 11" white paper and bound in two volumes (Volume 1-Qualifications Proposal and Volume II Cost Proposal). Exceptions would be schematics, exhibits, photographs, or other information necessary to facilitate the County's ability to accurately evaluate the proposal.
- **3.3 Submission:** The Proposer shall package and seal its proposals so that they will not be damaged in mailing. <u>Volumes I and II are to be packaged and sealed separately</u>. Proposers are reminded that under Georgia law, all opened documents fall under the open records act and are subject to inspection by the public. Proposers are reminded that documents and information in the possession of Lumpkin County will be treated as confidential/proprietary information only to the extent permitted by the Georgia Open Records Act and will be exempt from disclosure to a third party only to the extent permitted by the Georgia Open Records Act. Should you believe that your Proposal

contains any trade secrets, you must submit an affidavit, along with the Proposal, that states that specific portions of the Proposal contain trade secrets as defined by Georgia law (Article 27 of Chapter 1 of Title 10 of the Official Code of Georgia). Furthermore, the **affidavit must be detailed, citing specifically (citing paragraphs, articles, provisions, pages, etc.)** the portions of the Proposal containing any trade secrets. Accordingly, proprietary information and/or data cannot be withheld from public inspection. Proposals and supporting documents will be submitted in accordance with the Evaluation and Proposal Submission Section.

Proposals must be tabbed as follows and must include, in the applicable tab, the information/documents specified. Proposals that do not adhere to the following format or include the required information/documents may be considered incomplete and therefore non-responsive.

The proposal shall be styled at the discretion of the submitter. However, at a minimum it must address these areas:

- 1. General Consultant Qualifications:
  - a. An overview of the entity
  - b. Location of corporate office
  - c. Location and office address that will service the project if different than corporate office
  - d. Organizational structure
  - e. Total number of employees
- 2. Project Management Plan & Key Personnel
  - a. Provide resumes of your professional staff, including present ownership and key management members that will work directly with the County on the project. In addition to resumes, please provide work history and accreditations/credentials.
  - b. Provide your definition of a community center and the role that the community center will play for those that it serves. Detail the expectations that you consider to be significant to the local community.
  - c. Provide a list of expected activities to be undertaken and brief description of each as it relates to your management approach in providing operation and management services to this project. This list should include, but not be limited to, scheduling, progress reporting, quality control, safety information, etc. Please include an overview of the mix of spaces and other critical programmatic areas including a plan for pre-opening and a timeline of critical milestones and a description of roles and responsibilities. Please identify which scope of work you

are addressing or if you are addressing both.

- d. Provide a marketing plan consisting of an explanation of the overall philosophy on how the organization would advise as to how best market the facility.
  - i. Provide an overview of marketing and promotional concepts that will further the goals of the County as a premier venue and maximize the economic impact to the region.
  - ii. Describe the approach to booking, scheduling, promoting, advertising, and marketing events.
  - iii. Describe the approach in marketing and booking local programs.
  - iv. Identify any collaborations, alliances, key relationships, and other marketing opportunities that the firm will establish between other facilities managed by the firm and how these can benefit the facility.
- e. Provide details of your current workload and your ability to provide dedicated and necessary resources to this project.
- f. Provide documentation from insurance provider/surety agency stating that respondent has ability to be insured and will add the City as an additional insured.
- 3. Related Project Experience:
  - a. List of Operation and Management Service experience the firm has had in the last five (5) years or is currently managing, for a municipality, county, or other public entity. The entity must have extensive and current experience in managing, owning, and/or operating numerous recreational facilities. Firms without recreational management or operational experience will not be considered.
  - b. List of three currently operated facilities.
- 4. References
  - a. Please provide at least three (3) references from other accounts where market analysis and feasibility services were offered and the operation is now open and operating (name, position, address, and current contact information).

### **VOLUME II – COST PROPOSAL and REQUIRED COUNTY DOCUMENTS**

### COST PROPOSAL

Each Proposer is required to submit a cost proposal as part of its response. The County is requesting a price for SCOPE of WORK #1 "Total Recreation Facility Management" as well as the price for SCOPE of WORK #2 "Aquatic Operations Management" at the Recreation Center. Firms do not have to submit for both scopes of work if you would like to be considered for one or the other. Submitting for only one scope would not necessarily remove you from consideration. The cost proposal will be evaluated and scored in accordance with scoring criteria.

- 1. Proposed Compensation
  - a. Please provide an outline of a potential fee structure for services if selected. Due to the preliminary nature of this RFP and the information provided, it is understood that any proposed compensation structure will be subject to review of the detailed financial information for the facility. The intent of this request is to

obtain a preliminary understanding of the potential compensation structure that may be required in a new management agreement for the facility.

#### 4.0 PROPOSAL EVALUATION FACTORS

It is the County's intent to evaluate the proposals based on technical merit and price. It is the intent of the County to choose the Proposer whose proposal provides the highest value to the County. The County reserves the right to waive any irregularities, reject any and/or all proposals, in whole or in part, when, in the County's opinion, such rejection is in the best interests of the County. The County reserves the right to seek additional/supplemental representation on specific issues as needed.

#### 4.1 Technical Evaluation Method

Each proposal will be reviewed by a team of qualified individuals. Their proposal review and evaluation will be subjective; however, the weighting values are established to minimize that subjectivity. The following delineates the value attributed to each section.

Based on the total score of the Technical and Cost proposals, the Board of Commissioners may choose Proposers with whom to negotiate the final project methodology/scope, fees, and schedules with a view toward entering into a contractual agreement.

**NOTE**: The BOC reserves the right to accept a proposal, as submitted, and enter directly into a contractual agreement with that selected Proposer. Accordingly, it is imperative that all Proposers present their best technical and cost offers in their initial submission.

There will be two prices; one for total recreation center management and one for aquatic operations management only. If you choose to omit one of these, it will not necessarily cause a rejection of your submission. The County is not yet certain which method is the most feasible.

#### 5.0 **RFP** Amendments

The County reserves the right to amend the RFP prior to the proposal due date. All addenda and additional information will be posted to the County's website www.lumpkincounty.gov under Bids & Solicitations project RFP 2023-011

PINETREE RECREATION CENTER MANAGEMENT & OPERATIONS, prior to 5:00 pm, EST on November 28, 2023. It is the Proposer's responsibility to check the website for addenda before submitting a proposal. All signed addenda shall be included with the proposal.

#### 5.1 Agreement and Project Forms

The agreement form shall be the Owner's agreement form. The Owner's payment, waiver of lien, and change order form(s) shall be used.

#### 5.2 **RFP Withdrawal**

A submitted RFP may be withdrawn prior to the due date by a signed written request to the Purchasing Agent.

#### 5.3 Costs for Preparing RFP

The cost for developing the RFP is the sole responsibility of the contractor. The County will not provide reimbursement for such cost.

#### 5.4 **Conflict of Interest**

If a Proposer has any existing client relationship that involves Lumpkin County, the Proposer must disclose each relationship.

#### 5.5 Contractor Selection

Lumpkin County anticipates making a single award; however, it reserves the right to make multiple awards should it deem in the best interest of the County. It is anticipated that such an award, if any, will be accomplished within sixty (60) days (unless otherwise agreed upon by the Proposer(s) and the County) from the proposal opening.

### 5.6 Negotiations and Apparent Winner

Prior to award, the apparent winning proposer will be required to enter into discussions with the County to resolve any contractual differences. These discussions are to be finalized within two (2) weeks of notification unless extending the time period is advantageous to the County. Failure to resolve differences will lead to rejection of the contractor's RFP.

The County reserves the right to negotiate modifications and costs with the successful Proposer, provided that no such modifications affect the specifications set forth herein. The contractor shall commence work only after the transmittal of a fully executed contract and a Notice to Proceed document is received from the County.

#### 5.7 Taxes

Lumpkin County is exempt from sales taxes; however, the contractor shall pay all taxes required as stated by law. Lumpkin County cannot exempt others from tax.

#### 5.8 Compliance with Laws

The contractor will comply with all State and Federal laws, rules, and regulations.

#### 5.9 Non-Collusive Bidding

Contractor shall not prevent or attempt to prevent competition in bidding or proposals by any means whatsoever. Contractor shall not prevent or endeavor to prevent anyone from making a bid or proposal by any means whatsoever, nor shall Contractor cause or induce another to withdraw a bid or proposal for the work. § 36-91-21.

If the contractor is a partnership, all of the partners and any officer, agent, or other person who may have represented or acted for them in bidding for or procuring the contract shall also make the oath. If the contractor is a corporation, all officers, agents, or other persons who may have acted for or represented the corporation in bidding for or procuring the contract shall make the oath. If such oath is false, the contract shall be void, and all sums paid by the governmental entity on the contract may be recovered by appropriate action.

#### 5.10 Cancellation

If either party shall refuse, fail, or be unable to perform or observe any of the terms or conditions of the contract for any reason, then the party claiming such failure shall give the other party a written notice of such breach. If within thirty (30) days from such notice, the failure has not been corrected, the injured party may cancel the contract effective thirty (30) days after notice of cancellation.

Lumpkin County reserves the right to terminate the contract immediately in the event that the contractor discontinues or abandons operations, is adjudged bankrupt or is reorganized under any bankruptcy law or fails to keep in force any required insurance policies or bonds.

Failure of the successful Proposer to comply with any section or part of the contract will be considered grounds for immediate termination of the contract by the County without penalty to Lumpkin County. Lumpkin County shall pay for services rendered up to the point of termination.

Notwithstanding anything to the contrary contained in the contract between the County and the successful contractor, the County may, without prejudice to any other rights it may have, terminate the contract for convenience and without cause, by giving thirty (30) days written notice to the successful Proposer.

If the termination clause is used by the County, the successful contractor will be paid by the County for all scheduled work completed satisfactorily by the successful contractor up to the termination date set forth in the written termination notice.

#### 5.11 Conditions of Materials

It is understood and agreed that materials delivered shall be new, of latest design, and in first quality condition.

#### 5.12 Rejection of Submissions/Cancellation of Request for Proposal

Lumpkin County reserves the right to reject any or all RFPs, to waive any irregularity or informality in an RFP, and to accept or reject any item or combination of items, when to do so would be to the advantage of Lumpkin County. It is also within the rights of Lumpkin County to reject RFPs that do not contain all elements and information requested in this document. Lumpkin County reserves the right to cancel this request for proposal at any time. Lumpkin County will not be liable for any cost/losses incurred by the contractors throughout this process.

#### 5.13 Non-discrimination

Lumpkin County does not discriminate on the basis of race, religion, color, sex, national origin, age, or disability.

#### 5.14 Insurance

The contractor shall be responsible for his/her work and every part thereof and for all materials, tools, equipment, appliances, and properties of any and all description used in connection with this project. The contractor assumes all risks of direct and indirect damage or injury to the property of persons used or employed on or in connection with the work contracted for and of all damage or injury to any person or property wherever located, resulting from any action, omission, commission, or operation under the contract, or in connection in any way whatsoever with the contracted work. The contractor shall, during the continuance of all work under the contract, provide the following:

- 1. Maintain statutory Worker's Compensation and Employer's Liability insurance in an amount not less than \$1,000,000.00 to protect the contractor from any liability or damages for any injuries (including death and disability) to any of its employees, volunteers, or sub-contractors, including any and all liability or damage which may arise by virtue or any statute or law in force within the State of Georgia, or which may be herein after enacted.
- 2. The Proposer agrees to maintain Comprehensive General Liability Insurance in an amount of not less than \$1,000,000.00 per occurrence to protect the contractor, it's subcontractors, and the interest of the County against any and all injuries to third parties, including bodily injury and personal injury, wherever located, resulting from any action or operation under the contract or in connection with the contracted work. The General Liability Insurance shall also include the Broad Form Property Damage Liability endorsement, in addition to coverage for explosion, collapse, and underground hazards where required.
- 3. The contractor agrees to maintain Automobile Liability Insurance in an amount of not less than \$500,000 per occurrence. Such insurance shall include coverage for owned, hired, and non-owned automobiles.
- 4. The contractor further agrees to protect, defend, indemnify, and hold harmless Lumpkin County, its commissioners, officers, agents, and employees from and against any and all liability incurred whatsoever as a result of the work performed pursuant to the terms of this proposal.
- 5. The contractor shall notify the County in writing sixty (60) days prior to change in insurance or cancellation date. The failure of the contractor to deliver a new certificate shall result in suspension of all payments until the new certificate is furnished. Additionally, contract work may be suspended until the new certificate is furnished to the County.

- 6. Insurance coverage required in these specifications shall be in force throughout the contract term. Should the contractor fail to provide acceptable evidence of current insurance within five (5) days of written notice at any time during the contract term, the owner shall have the absolute right to terminate the contract without any further obligation to the contractor. Furthermore, the contractor shall be responsible for the cost of procuring the uncompleted portion of the contract at the time of termination.
- 7. Contractual and other liability insurance provided under the contract shall not contain a supervision, inspection, or engineering services exclusion that would preclude the County from supervising and/or inspecting the project as to the end result. The contractor shall assume all on the job responsibilities as to the control of persons under its direct employment and of the sub-contractors and any persons employed by the sub-contractors.
- 8. The contractor and all sub-contractors shall comply with the Occupational Safety and Health Act of 1970 and amendments as it may apply to this contract.
- 9. If the contractor does not meet the insurance requirements of the specifications, alternate insurance coverage satisfactory to the County may be considered. The contractor shall be responsible for the costs of any and all alternate insurance coverage so obtained.

#### 5.15 **Project Coordination**

The contractor shall employ and assign only qualified and competent personnel to perform any service or task involved in this project. The contractor shall designate one such person as a Project Manager, and the Project Manager shall be deemed to be the contractor's authorized representative, who shall be authorized to receive and accept any and all communication from the County.

The contractor hereby agrees to replace any personnel of sub-contractor, at no cost or penalty to the County, if the County reasonably determines that the performance or any sub-contractor or personnel is unsatisfactory.

#### 5.16 Accuracy of Work

The contractor shall be responsible for the accuracy of work performed and shall promptly correct its errors and omissions without additional compensation. Acceptance of the work by the County will not relieve the contractor of the responsibility for subsequent correction of errors, the clarification of any ambiguities, or the costs associated with any additional work caused by negligent acts, errors, or omissions by the contractor or latent defects in the products sold by the contractor.

At any time during the execution of this project or during any phase of work performed by others based on data secured by the contractor under this agreement, the contractor shall confer with the County for the purpose of interpreting the information supplied by the contractor and to correct any errors or omissions. The above consultations, clarifications, and/or corrections shall be made without added compensation to the contractor.

The contractor shall give immediate attention to these changes so there will be minimum delay to others, the contractor shall be responsible for errors and omissions and hold harmless the County and its agents as provided in the agreement.

#### 5.17 News Release by Contractor

As a matter of policy, the County does not endorse the products or services of a contractor. News releases concerning any resultant contract from this solicitation shall not be made by a contractor without the proper written approval of the County. All proposed news releases shall be routed to the Lumpkin County Purchasing Agent for review and approval.

#### 5.18 Severability

It is understood and agreed by the parties hereto that if any part, term, or provision of this contract is held illegal or in conflict with any law of the State where made or having jurisdiction over any of the parties hereto, the validity of the remaining portions or provisions shall not be affected, and the rights and obligations of the parties shall be construed and enforced as if the contract did not contain the particular part term or provisions held to be invalid.

The County and the contractor agree to resolve through negotiation or mediation prior to filing any cause of action. The venue for any litigation arising from this contract shall be Lumpkin County, Georgia.

The County reserves the right to cancel the contract and discontinue the services with a thirty (30) day written notice as a result of the failure of the contractor to provide acceptable work and services as delineated in the response to this document or if determined that services can be better provided by in-house or other sources.

### 5.19 Drug Free Workplace

#### **Purpose of Form**

An individual or entity (Form W-9 requester) who is required to file an information return with the IRS must obtain your correct taxpayer identification number (TIN) which may be your social security number (SSN), individual taxpayer identification number (ITIN), adoption taxpayer identification number (ATIN), or employer identification number (EIN), to report on an information return the amount paid to you, or other amount reportable on an information return. Examples of information returns include, but are not limited to, the following:

- Form 1099-INT (interest earned or paid)
- Form 1099-DIV (dividends, including those from stocks or mutual funds)
- Form 1099-MISC (various types of income, prizes, awards, or gross proceeds)

Further, in certain cases where a Form W-9 has not been received, the rules under section 1446 require a partnership to presume that a partner is a foreign person, and pay the section 1446 withholding tax. Therefore, if you are a U.S. person that is a partner in a partnership to establish your U.S. status and avoid section 1446 withholding on your share of partnership income.

In the cases below, the following person must give Form W-9 to the partnership for purposes of establishing its U.S. status and avoiding withholding on its allocable share of net income from the partnership conducting a trade or business in the United States:

• In the case of a disregarded entity with a U.S. owner, the U.S. owner of the disregarded entity and not the entity;

- In the case of a grantor trust with a U.S. grantor or other U.S. owner, generally, the U.S. grantor or other U.S. owner of the grantor trust and not the trust; and

Nonresident alien who becomes a resident alien. Generally, only a nonresident alien individual may use the terms of a tax treaty to reduce or eliminate U.S. tax on certain types of income. However, most tax treaties contain a provision known as a "saving clause." Exceptions specified in the saving clause may permit an exemption from tax to continue for certain types of income even after the payee has otherwise become a U.S. resident alien for tax purposes.

5. Sufficient facts to justify the exemption from tax under the terms of the treaty article.

**Example.** Article 20 of the U.S.-China income tax treaty allows an exemption from tax for scholarship income received by a Chinese student temporarily present in the United States. Under U.S. law, this student will become a resident alien for tax purposes if his or her stay in the United States exceeds 5 calendar years. However, paragraph 2 of the first Protocol to the U.S.-China treaty (dated April 30, 1984) allows the provisions of Article 20 to continue to apply even after the Chinese student becomes a resident alien of the United States. A Chinese student who qualifies for this exception (under paragraph 2 of the first protocol) and is relying on this exception to claim an exemption from tax on his or her scholarship information described above to support that exemption.

If you are a nonresident alien or a foreign entity, give the requester the appropriate completed Form W-8 or Form 8233.

#### **Backup Withholding**

What is backup withholding? Persons making certain payments to you must under certain conditions withhold and pay to the IRS 28% of such payments. This is called "backup withholding." Payments that may be subject to backup withholding include interest, tax-exempt interest, dividends, broker and barter exchange transactions, rents, royalties, nonemployee pay, payments made in settlement of payment card and third party network transactions, and certain payments from fishing boat operators. Real estate transactions are not subject to backup withholding.

You will not be subject to backup withholding on payments you receive if you give the requester your correct TIN, make the proper certifications, and report all your taxable interest and dividends on your tax return.

#### Payments you receive will be subject to backup withholding if:

1. You do not furnish your TIN to the requester,

Enter your city, state, and ZIP code.

#### Part I. Taxpayer Identification Number (TIN)

Enter your TIN in the appropriate box. If you are a resident alien and you do not have and are not eligible to get an SSN, your TIN is your IRS individual taxpayer identification number (ITIN). Enter it in the social security number box. If you do not have an ITIN, see *How to get a TIN* below.

If you are a sole proprietor and you have an EIN, you may enter either your SSN or EIN. However, the IRS prefers that you use your SSN.

If you are a single-member LLC that is disregarded as an entity separate from its owner (see *Limited Liability Company (LLC)* on this page), enter the owner's SSN (or EIN, if the owner has one). Do not enter the disregarded entity's EIN. If the LLC is classified as a corporation or partnership, enter the entity's EIN.

Note. See the chart on page 4 for further clarification of name and TIN combinations.

How to get a TIN. If you do not have a TIN, apply for one immediately. To apply for an SSN, get Form SS-5, Application for a Social Security Card, from your local SSA office or get this form online at *www.ssa.gov*. You may also get this form by calling 1-800-772-1213. Use Form W-7, Application for IRS Individual Taxpayer Identification Number, to apply for an ITIN, or Form SS-4, Application for Employer Identification Number, to apply for an EIN. You can apply for an EIN online by accessing the IRS website at *www.irs.gov/businesses* and clicking on Employer Identification Number (EIN) under Starting a Business. You can get Forms W-7 and SS-4 from the IRS by visiting IRS.gov or by calling 1-800-TAX-FORM (1-800-829-3676).

If you are asked to complete Form W-9 but do not have a TIN, apply for a TIN and write "Applied For" in the space for the TIN, sign and date the form, and give it to the requester. For interest and dividend payments, and certain payments made with respect to readily tradable instruments, generally you will have 60 days to get a TIN and give it to the requester before you are subject to backup withholding on payments. The 60-day rule does not apply to other types of payments. You will be subject to backup withholding on all such payments until you provide your TIN to the requester.

Note. Entering "Applied For" means that you have already applied for a TIN or that you intend to apply for one soon.

**Caution:** A disregarded U.S. entity that has a foreign owner must use the appropriate Form W-8.

#### Part II. Certification

To establish to the withholding agent that you are a U.S. person, or resident alien, sign Form W-9. You may be requested to sign by the withholding agent even if items 1, 4, or 5 below indicate otherwise.

For a joint account, only the person whose TIN is shown in Part I should sign (when required). In the case of a disregarded entity, the person identified on line 1 must sign. Exempt payees, see *Exempt payee code* earlier.

Signature requirements. Complete the certification as indicated in items 1 through 5 below.

1. Interest, dividend, and barter exchange accounts opened before 1984 and broker accounts considered active during 1983. You must give your correct TIN, but you do not have to sign the certification.

2. Interest, dividend, broker, and barter exchange accounts opened after 1983 and broker accounts considered inactive during 1983. You must sign the certification or backup withholding will apply. If you are subject to backup withholding and you are merely providing your correct TIN to the requester, you must cross out item 2 in the certification before signing the form.

3. Real estate transactions. You must sign the certification. You may cross out item 2 of the certification.

4. Other payments. You must give your correct TIN, but you do not have to sign the certification unless you have been notified that you have previously given an incorrect TIN. "Other payments" include payments made in the course of the requester's trade or business for rents, royalties, goods (other than bills for merchandise), medical and health care services (including payments to corporations), payments to a nonemployee for services, payments made in settlement of payment card and third party network transactions, payments to certain fishing boat crew members and fishermen, and gross proceeds paid to attorneys (including payments to corporations).

5. Mortgage interest paid by you, acquisition or abandonment of secured property, cancellation of debt, qualified tuition program payments (under section 529), IRA, Coverdell ESA, Archer MSA or HSA contributions or distributions, and pension distributions. You must give your correct TIN, but you do not have to sign the certification.

You must show your individual name and you may also enter your business or DBA name on the "Business name/disregarded entity" name line. You may use either your SSN or EIN (ifyou have one), but the IRS encourages you to use your SSN.

<sup>4</sup> List first and circle the name of the trust, estate, or pension trust. (Do not furnish the TIN of the personal representative or trustee unless the legal entity itself is not designated in the account title.) Also see *Special rules for partnerships* on page 2. **Note.** Grantor also must provide a Form W-9 to trustee of trust.

Note. If no name is circled when more than one name is listed, the number will be considered to be that of the first name listed.

#### Secure Your Tax Records from Identity Theft

Identity theft occurs when someone uses your personal information such as your name, SSN, or other identifying information, without your permission, to commit fraud or other crimes. An identity thief may use your SSN to get a job or may file a tax return using your SSN to receive a refund.

To reduce your risk:

- Protect your SSN,
- Ensure your employer is protecting your SSN, and
- Be careful when choosing a tax preparer.

If your tax records are affected by identity theft and you receive a notice from the IRS, respond right away to the name and phone number printed on the IRS notice or letter.

If your tax records are not currently affected by identity theft but you think you are at risk due to a lost or stolen purse or wallet, questionable credit card activity or credit report, contact the IRS Identity Theft Hotline at 1-800-908-4490 or submit Form 14039.

Victims of identity theft who are experiencing economic harm or a system problem, or are seeking help in resolving tax problems that have not been resolved through normal channels, may be eligible for Taxpayer Advocate Service (TAS) assistance. You can reach TAS by calling the TAS toll-free case intake line at 1-877-777-4778 or TTY/TDD 1-800-829-4059.

Protect yourself from suspicious emails or phishing schemes. Phishing is the creation and use of email and websites designed to mimic legitimate business emails and websites. The most common act is sending an email to a user falsely claiming to be an established legitimate enterprise in an attempt to scam the user into surrendering private information that will be used for identity theft.

The IRS does not initiate contacts with taxpayers via emails. Also, the IRS does not request personal detailed information through email or ask taxpayers for the PIN numbers, passwords, or similar secret access information for their credit card, bank, or other financial accounts.

If you receive an unsolicited email claiming to be from the IRS, forward this message to *phishing@irs.gov*. You may also report misuse of the IRS name, logo, or other IRS property to the Treasury Inspector General for TaxAdministration (TIGTA) at 1-800-366-4484. You can forward suspicious emails to the Federal Trade Commission at: *spam@uce.gov* or contact them at *www.ftc.gov/idtheft* or 1-877-IDTHEFT (1-877-438-4338).

#### **Privacy Act Notice**

Section 6109 of the Internal Revenue Code requires you to provide your correct TIN to persons (including federal agencies) who are required to file information returns with the IRS to report interest, dividends, or certain other income paid to you; mortgage interest you paid; the acquisition or abandonment of secured property; the cancellation of debt; or contributions you made to an IRA, Archer MSA, or HSA. The person collecting this form uses the information on the form to file information returns with the IRS, reporting the above information. Routine uses of this information include giving it to the Department of Justice for civil and criminal litigation and to cities, states, the District of Columbia, and U.S. commonwealths and possessions for use in administering their laws. The information also may be disclosed to other countries under a treaty, to federal and state agencies to enforce civil and criminal laws, or to federal law enforcement and intelligence agencies to file a tax return. Under section 3406, payers must generally withhold a percentage of taxable interest, dividend, and certain other payments to a payee who does not give a TIN to the payer. Certain penalties may also apply for providing false or fraudent information.
