SPECIFIC REQUIREMENTS

- 1. Franklin County will purchase culvert materials throughout the year in varying quantities and of varying materials such as Metal, Polyvinyl Chloride, Reinforced Concrete and Polyethylene pipe as needed. The pricing sheet included in the solicitation has listed items requested.
- Unit Prices shall include all costs associated with loading, hauling and unloading at locations within Franklin County. Three known locations for delivery shall be 1360 Riverview Dr. Union Mo 63084, 4987 Highway ZZ, Gerald Mo 63037 & 3401 HWY 50 Beaufort, MO. 63013. Other locations will be requested on an as needed basis with Franklin County.
- 3. Materials must meet specifications as described in Section 1020, 1026, 1027 and 1047 respectively, latest version of the Missouri Standard Specifications for Highway Construction. Also see Attachment 2.
- 4. Awarded contractor must maintain qualification with MoDOT and be on the MoDOT Qualified List.
- 5. Culverts must be received within 1 calendar month of order. Liquidated damages of \$100.00 per working day will be applied for shipments received after that time period. Liquidated damages to be assessed and approved through the Franklin County Purchasing Department.
- 6. Franklin County, at its own expense, reserves the right to sample any material, for the purpose of having an independent laboratory test of the material for conformance to specifications. Product that does not meet specifications will cause all of the shipments to be returned at the bidder's expense.
- 7. Connecting bands shall have continuous angle iron brackets on both sides of the band opening. All connecting bands shall be 24 inches wide. Connecting bands and hardware for pipe diameters 12 inches to 24 inches, shall be invoiced at the same price as 1 ½ foot of the pipe size it is adjoining. Connecting bands and hardware for pipe diameters 30 inches to 120 inches shall be invoiced at the same price as 2 foot of the pipe size it is adjoining.
- 8. Vendors may elect to submit revised pricing, due to extreme market fluctuations during the agreement period, by providing the Purchasing Department, with revised pricing by emailing purchasing@franklinmo.gov, on or before the last Tuesday of each month. It is the vendor's responsibility to monitor and meet this submission deadline. Franklin County, Mo. may request documentation of market price indexes or other factor impacting the need for any requested price changes. The acceptance of any revised pricing submitted is subject to the mutual agreement of both parties. Revisions submitted before the last Tuesday of the month will, after acceptance, go into effect

the first day of the following month. (For example: Revised pricing submitted before Tuesday, October 26, 2021, if accepted, would go into effect on Tuesday, November 2, 2021.) Revised pricing will remain firm and in effect for the remainder of the agreement period or until changed by a future revision. If an agreement on revised pricing cannot be reached by both parties, Franklin County, MO. reserves the right to rebid for the supply of these materials at any time during the agreement period.

9. Contract Period: The contract period shall be for one year January 1, 2024 thru December 31, 2024. This Contract will have the option to renew on a year by year basis, up to three years in total. The County also reserves the right to terminate and/or cancel the contract in writing prior via a formal contract amendment issued by the Purchasing Department.

The contents of this section include mandatory requirements that will be required of the successful bidder and subsequent contractor. The offeror is requested to provide responses to the requirements/desired attributes in this section pursuant to the directions identified herein. The offeror's response, whether responding to a mandatory requirement or a desired attribute, shall be binding in the event the bid is accepted by Franklin County. The offeror must provide all costs necessary to meet the mandatory requirements and the fulfillment of any desirable attributes in the appropriate section titled Pricing.

INSURANCE REQUIREMENTS

- 1. The Contractor shall furnish County with a certificate of insurance indicating proof of the following insurance from company's license in the State of Missouri:
 - A. Worker's Compensation and Employers' Liability: Worker's Compensation Statutory in compliance with the Compensation law of the Sate and Employers' Liability Insurance with a limit no less than \$1,000,000.00 each accident.

B. Comprehensive or Commercial General Liability with a minimum limit of \$1,000,000.00 per occurrence, \$3,000,000.00 aggregate combined Single Limit for Bodily Injury and Property Damage Liability. This insurance shall include, but not be limited to, the following coverage.

- 1. Premises Operations
- 2. Products and Completed Operations
- 3. Broad Form Property Damage
- 4. Contractual
- 5. Personal Injury

C. Automobile Liability with a minimum limit of \$1,000,000.00 per occurrence, \$3,000,000.00 aggregate Combined Single Limit for Bodily Injury and Property Damage Liability. This insurance shall include coverage for all the following:

- 1. Owned Automobiles
- 2. Hired Automobiles
- 3. Non-Owned Automobiles

D. The certificate shall list the Certificate Holder and Address as follows: Franklin County, 400 E Locust Street, Room 206, Union, Mo 63084. The services provided to Franklin County shall be listed under "Description of Operations."

E. Such insurance shall include under the General Liability and Automobile Liability policies Franklin County, its employees, elected officials, representatives, and members of its board and/or commissioners as "Additional Insured's".

2. The Agreement of Insurance shall provide for notice to the County of amendment or cancellation of insurance policies 30 days before such amendment or cancellation is to take effect.

ADDITIONAL REQUIREMENTS

1. E-Verify

Completion of Affidavit of Work Authorization and provide acceptable documentation of enrollment in the program.

2. Employment of Unauthorized Aliens Prohibited

a.) Vendor agrees to comply with Missouri Revised Statute Section 285.530.1 in that it shall not knowingly employ, hire for employment, or continue to employ an unauthorized alien to perform work within the State of Missouri.

b.) As a condition for the award of this contract, the Vendor shall, by sown affidavit and provision of documentation, affirm its enrollment and participation in a federal work authorization program with respect to the employees working in connection with the contracted services. The Vendor shall also sign an affidavit affirming that it does not knowingly employ any person who is an unauthorized alien in connection with the contracted services.

c.) Vendor shall require each subcontractor to affirmatively state in its contract with Vendor that the subcontractor shall not knowingly employ, hire for employment or continue to employ an unauthorized alien to perform work within the State of Missouri and shall not henceforth do so. SECTION 724 PIPE CULVERTS

724.1 Description. This work shall consist of providing pipe or pipe arch of the diameter or shape designated, laid upon a firm bed and backfilled as specified. Where appropriate this specification will also apply to pipe arches.

724.1.1 The contract will specify either the type of pipe or the group of permissible types of pipe. If a group of permissible types is specified, the contractor may use any of the types listed within the specified group and size range as follows:

^a Metal Pipe used for storm sewer applications shall be Type IA or Type IR.

^b Pipe used for storm sewers under the influence of a pavement section or future anticipated influence of a pavement section which has a 3,500 ADT or greater shall be Group A pipe. Pipe used in other storm sewer applications shall be Group B. No other substitutions will be allowed.

724.1.2 If the contract specifies pipe culverts by group and the contractor elects to furnish metal pipe, the culvert shall be constructed in accordance with <u>Sec 725</u>. If the contractor elects to furnish vitrified elay or reinforced concrete pipe, the culvert shall be constructed in accordance with <u>Sec 726</u>. If the contractor elects to furnish thermoplastic culvert pipe, the culvert shall be constructed in accordance with <u>Sec 730</u>.

724.1.3 When Group A, Group B and Group C pipe are specified, two pipe diameters will be shown on the plans at those locations. The first dimension will indicate the diameter of pipe that shall be provided if the contractor elects to provide pipe for that location with a corrugated interior wall, and the second dimension provided in parenthesis will indicate the diameter of pipe that shall be provided if the contractor elects to provide pipe for that location with a corrugated interior wall, and the second dimension provided in parenthesis will indicate the diameter of pipe that shall be provided if the contractor elects to provide pipe for that location with a smooth interior wall. Helical rib (Type IA) pipe may be considered to have varying hydraulic coefficients and may be substituted in accordance with FIIWA HD-5 hydraulic design of highway culverts considering the corrugation configuration at the joints. The specified diameters may be the same or different and will be dependent upon the design features for that pipe location. Regardless of which diameter of pipe is selected for a given location, the pipe flow line shall be maintained at the elevations shown on the plans.

724.1.4 The contractor may elect to furnish pipe one size larger than specified so long as the minimum fill heights are met. No additional compensation shall be given for the larger diameter pipe or any related items necessary to construct the larger pipe.
