The Covina Valley Unified School District ("District") is requesting a statement of qualifications (SOQ) from qualified firms to establish a pool of firms to provide Environmental Site Assessment Services.

This is not a formal request for bids, nor an offer by the District to contract with any party responding to this RFQ. The District reserves the right to reject any and all responses. Respondents shall not, directly, or indirectly, communicate with any employee, officer, Board of Trustees member, agent, or representative of the District regarding the RFQ for Environmental Site Assessment Services except for the District contact persons noted below. The RFQ Response of a Respondent who has engaged in any action or activity inconsistent with or in violation of the foregoing is subject to rejection for non-responsiveness.

2. <u>DESCRIPTION OF SERVICES AND GENERAL INFORMATION</u>

A. Number of Firm(s) Anticipated to be Selected

The District intends to select several firms as part of a Pool of qualified Firms to provide Environmental Site Assessment Services. The District may select a range of Firms of various sizes (small, medium, large) or other characteristics. The Pool shall be valid for a period of five years or until another RFQ/RFP process is completed, whichever is longer.

B. Scope of Services Required

The District is requesting Statements of Qualifications (SoQs) through a Request for Qualifications (RFQ) process for Environmental Site Assessment Services for existing and future projects. The District may utilize SoQ Responses to this RFQ for services needed for future capital projects and/or maintenance program projects and/or other special projects that may include, but are not limited to: modernization, expansion, new construction, reconstruction, alteration, rehabilitation, repair, relocation, reconfiguration, upgrades, planning, DSA closeout, and other projects as may be identified, planned, modified, or prioritized/reprioritized, during the term of the agreement entered into pursuant to this RFO.

The District is seeking firms with experience with California Public School Districts and the Department of Toxic Substance Control.

The Firm shall provide Environmental Site Assessment Services which may involve multiple disciplines or single disciplines, including but not limited to identifying known or suspected environmental soil conditions associated with historical and current operations, developing recommendations for further actions, identifying conditions having the potential to impact the timely implementation of development projects, developing work plans to manage hazardous substance impacts, exported and imported soil testing, and other related services, as may be required for various projects.

Contracted Firms may be required to provide, as requested by the District, Environmental Site Assessment Services including but not limited to any or all the following:

1.) Research, Testing of Site Soils, Report Preparation, and Remediation Oversight

- i. The Firm shall perform any or all of the following and related tasks required, as requested by the District.
 - Conduct independent risk assessment for existing site areas or other parcels based on a PK-12 use which may include preschool, day care, grades K-high school age students, staff, community members, and construction workers. The purpose of the assessment will be to identify specific areas or sites as defined and evaluate the presence of hazardous materials and the associated feasibility and cost of remediation.
 - Conduct a site reconnaissance led by an environmental professional to assess the property or properties and prepare a full Phase I Report as needed. This shall include, but may not be limited to, a reasonable

observation of the property and structures, the periphery of the property, the interior common areas of structures, and a representative sample of occupant spaces. Items such as current and past uses of the property and adjoining properties; obvious geologic, hydrologic, and topographic conditions; structures; roads; potential hazardous substances and petroleum products; storage tanks; odors; pools of liquid; drums; containers; surface waters; suspected fill materials; stained soil or other potential/suspected contamination. Conduct research and observations of radon potential, mold issues, oil and gas exploration activities, and methane zone determination, if indicted.

- Conduct historical Phase I Environmental Site Assessments (ESA) in accordance with current American Society of Testing Materials (ASTM) standards for Environmental Site Assessments (E-1527-05), including any recent changes or modifications to the ASTM standards, and the EPA All Appropriate Inquiry (AAI) Standard (see attached EPA document for information regarding AAI); and prepare full Phase I reports as needed and provide recommendations for any further actions.
- Conduct complete Phase II Environmental Site Investigations, including soil and groundwater investigations, and prepare reports and recommendations.
- Conduct environmental sampling, including project management of tasks completed, notify Underground Services Alert (USA) of the pending field activities a minimum of 72 hours prior to the commencement of field activities, Sub-Soil Sampling, Sub-Slab Soil Vapor Sampling, Arsenic Sampling, PAH Sampling, other sampling/studies as may be indicated or required, and Report Preparation including Health Risk Assessment (HRA) of the existing data for the site(s)/property(s).
- Evaluate and provide a magnitude of cost estimate for remediation of the sites for unrestricted land use.
- Gather historical sources, including building department records, historical aerial photographs, local street directories, fire insurance maps, USGS 7.5 Minute Topographical Maps, and other credible sources of past uses or occupancies, review as available.
- Conduct Interviews with past and present owners, occupants, neighbors, and/or other persons who are familiar with the property in person, by telephone, or in writing regarding the history, operations, management, waste management practices, and other environmental considerations for the subject property as those persons are available and open to an interview.
- Regulatory interviews of State and local government officials in person, by telephone, or in writing to obtain information on permits and compliance history, and information indicating recognized

environmental conditions in connection with the site(s)/property(s).

- Conduct radius map search of state and federal databases according to the current ASTM and AAI standard.
- Conduct Phase III Remedial Operations and Monitoring including maintenance and monitoring of soil and groundwater remedial equipment.
- Evaluate proposed Work Plans, Regulatory Orders, Closure Plans and other significant documents for completeness, correctness, effectiveness, feasibility of achieving stated objectives, and potential deficiencies. Provide recommendations regarding appropriate modifications, alternatives, and potential liabilities.

2.) Testing of Import/Export Soil

i. The Firm shall test soil intended for import or export per the notes below, and may be requested to perform additional tests, if needed.

General Import/Export Notes:

- The District's geotechnical / soils consultant shall ensure that import soils are suitable (from a geotechnical /soils standpoint) for usage as import before the cost and effort of environmental sampling is incurred.
- 2) Environmental sampling of import/export soil should be completed in general accordance with the Department of Toxic Substances Control (DTSC) Information Advisory Clean Imported Fill Material guidelines, dated October 2001, or most recent version.
- 3) Import/export soil sampling should be completed under the direction of a State of California licensed Professional Geologist or Engineer experienced with similar work.
- 4) All environmental import/export soil sampling should be completed, and results approved by District and their environmental consultant, before any soil is moved to or from a district property.

Project Specific Notes:

The following information must be specified when requesting import sampling for a specific project:

- A) The volume of import needed/export soil to be removed (in cubic yards)
- B) The intended usage and location of the potential import (in school yard? beneath school building? at district maintenance yard?, etc.)
- C) The location of the import source (address or other specific description) in order to review historical use of this location
- D) Whether the source of import/export is in a stockpile or in-place (i.e., in-ground)
- E) The number of soil samples collected should be based on the above-

- mentioned DTSC guidelines.
- F) Samples should be collected in a manner which is representative of the body of potential import/export soils (i.e., from various depths and types of soil for in-place soil)
- G) Sampling of soils should be completed using appropriate containers and sample volumes for the analytical methods to be used.
- H) Sampling methods may include use of hand trowels, hand augers, backhoes, etc., depending upon the depth and occurrence (i.e., in place or stockpiled) of the potential import/export soils. All sampling equipment should be cleaned with an Alconox solution and double rinsed (potable tap and then deionized water) prior to use at each sampling location.
- The potential import/export soils which are sampled should be identified and demarcated so that they can be found and removed if laboratory analytical results are approved.
- J) Sample compositing may or may not be acceptable depending upon the homogeneity of the import source, but compositing for VOC, SVOC, Title 22 Metal, Pesticide or Herbicide analyses is generally not acceptable.
- K) The analytical methods for testing of soil samples should be determined per the judgement of the licensed geologist or engineer, and in general accordance with above-mentioned DTSC guidelines. Possible analytical tests include:

As the need may arise, the District may require and may utilize any other services the firm is qualified to provide.

The successful firm will work well in a collaborative environment.

C. Contract

The form of Agreement under this RFQ is subject to final review, revision, and approval by the District's legal counsel and Board. The District's standard Agreement is posted on the District's website as part of this RFQ. The District's agreement is its standard Agreement approved by legal counsel. If a Submitter has concerns about the agreement, the Submitter may include a redline version of the Agreement with any comments or suggested language changes with their submittal, if the submitter feels this is necessary. The District shall not be required to review any submitted redline Agreement. Submitters should assume that any requested changes will not be considered, unless the District determines that such changes would be in the best interest of the District. If a redlined Agreement is included in the submittal, it will not count toward the page limit.

The District may enter into contracts with selected Firms on a per project or on a master contract basis with subsequent project assignment, as the District may determine is in its best interest. Selection for inclusion in the Pool does not guarantee that the Firm will be assigned a project nor that a contract will be entered into with the District.

D. Background of the District

For more than a century, Covina-Valley Unified School District (District) has served the

communities of Covina, West Covina, Glendora, San Dimas, and Irwindale. Covina-Valley schools provide the personalized service and caring culture of a small school district, where teachers and administrators know their students by name.

Each year, District graduates earn in excess of \$1 million in scholarships. Due to the high academic standing of Covina-Valley students, more than half of all graduates meet or exceed the admission requirements for the California State and University of California systems.

The District provides a strong basic education underscoring reading, writing, language arts, math, science, social science, and technology which is aligned with the California Department of Education standards. Moreover, each campus offers leadership, curricular, and athletics/sports opportunities. A broad array of support services is available to children, adults, and families.

An extensive arts program begins in elementary school, providing students with a wellrounded education. District athletic teams garner California Interscholastic Federation (CIF) Championships and are consistently ranked among the best in the region.

F. <u>ADDITIONAL SUBMITTAL INSTRUCTIONS AND GENERAL INFORMATION:</u>

- 1. Submission of SoQs by facsimile or e-mail is not acceptable. The Submitter is entirely responsible for the means of delivering the SoQ to the appropriate office on time. Delays due to internal routing of misdirected proposals or due to verbal directions given by District staff shall be the responsibility of the Submitter. Thus, each SoQ must be completed and delivered in sufficient time to avoid disqualification for lateness due to difficulties in delivery. **LATE SUBMITTALS WILL NOT BE ACCEPTED.**
- 2. Submitters are required to disclose any relationships with the District and execute the non-collusion affidavit included with this RFO.
- 3. The original SoQ shall be submitted and <u>signed in blue ink</u>, by an authorized individual or officer of the firm submitting the SoQ.
- 4. The Board of Education of the District reserves the right to accept or reject any or all SoQ submittals and may waive any minor deviation or irregularity in any submittal. The District's waiver of any minor defect shall in no way modify the RFQ documents or excuse the Submitter from compliance with every other provision of this RFQ. The Board of Education of the District reserves the right to negotiate with any or all responsible submitters.
- 5. Submitters shall be responsible for any and all costs and expenses that they may incur in preparing the SoQ. The District shall have no obligation whatsoever for costs of SoQ preparation, interview (if applicable), fee negotiation or any other costs associated with this RFO or any SoQ submitted in response to this RFO.
- 6. Modifications of SoQs submitted by a Submitter after the submittal deadline will not be considered unless the District requested the modifications.
- 7. Each SoQ shall be reviewed to verify that the Submitter has met the minimum requirements of the RFQ. Submitters must follow the required format specified in this RFQ in order to facilitate District review.
- 8. The District reserves the right to cancel this RFQ at any time.

- 9. Selection under this RFO, if applicable, does not guarantee that a contract will be awarded to the Submitter or that any projects will be assigned to the Proposer. The District may elect to not proceed with a project at its discretion. The District may also issue future solicitations that may augment or supersede this solicitation.

6. **INSURANCE REQUIREMENTS:**

Submitters shall maintain in force, during the full term of the contract, insurance described below, unless it is determined by the District to be not applicable.

- A. The Submitter shall carry Workers' Compensation and Employers Liability Insurance in accordance with the laws of the State of California. However, such amount shall not be less than one million dollars (\$1,000,000).
- B. The Submitter shall carry Comprehensive general and auto liability insurance with limits of not less than one million dollars (\$1,000,000) combined single limit, bodily injury, and property damage liability per occurrence, including:
 - 1) Owned, non-owned and hired vehicles:
 - 2) Blanket contractual:
 - 3) Broad form property damage;
 - 4) Products/completed operations; and
 - 5) Personal injury.
- C. The Submitter shall carry Professional Liability insurance, including contractual liability, with limits of one million dollars (\$1,000,000), per occurrence. Such insurance shall be maintained during the term of the Agreement and renewed for a period of at least five (5) years thereafter and/or at rates consistent with the time of execution of the Agreement adjusted for inflation. Failure to maintain professional liability insurance is a material breach of the Agreement and grounds for immediate termination.
- D. Each policy of insurance required in b. above shall name District and its officers, agents, and employees as additional insureds; shall state that, with respect to the operations of Submitter hereunder, such policy is primary, and any insurance carried by District is excess and non-contributory with such primary insurance; shall state that not less than thirty (30) days' written notice shall be given to District prior to cancellation; and, shall waive all

rights of subrogation. Submitter shall notify District in the event of material change in, or failure to renew, each policy. Prior to commencing work, Submitter shall deliver to District certificates of insurance as evidence of compliance with the requirements herein. In the event Submitter fails to secure or maintain any policy of insurance required hereby, District may, at its sole discretion, secure such policy of insurance in the name of and for the account of Submitter, and in such event, Submitter shall reimburse District upon demand for the cost thereof.

E. If Submitter subcontracts any portion of Submitter's duties, Submitter shall require any such subcontractor to purchase and maintain insurance coverage for the types of insurance referenced, in amounts which are appropriate with respect to that subcontractor's part of work which shall in no event be less than five hundred thousand dollars (\$500,000) per occurrence.
