PROJECT OVERVIEW

The City of Conroe hereby solicits quotes for sand blasting paint from park benches at locations in Downtown Conroe.

SCOPE OF WORK/ SPECIFICATIONS

Scope of Work

The City of Conroe is seeking sand blasting and/or dustless blasting services to remove paint from 11 Concrete Art Benches located in Downtown Conroe in order for them to be rehabilitated.

Background:

Internal attempts were made to pressure wash the paint off however progress was slow and disruptive to the nearby businesses and pedestrians. It is our opinion more specialized equipment is needed to effectively and efficiently remove the paint. The painted benches include multiple layers of a variety a paint types. Some benches contain tiles and metallic elements in addition to paint which will need to be preserved.

Considerations:

- Due to these benches being utilized for artwork care is needed to not damage the concrete base or elements of the bench meant to be preserved (tiles etc.).
- Due to future art planned on the benches it is important the surface of the benches be completely free of all paint
- Due to the location of the benches on sidewalks in Downtown Conroe care is needed to not damage personal property or significantly disrupt local businesses and pedestrians. Flexibility in scheduling the service may be required.

TERMS, CONDITIONS AND CLAUSES

- 1.0 <u>Owner</u> The City reserves the right to award parts of bids, reject any or all bids and to waive technical irregularities in the bids. The award will be made to the bidder who provides the goods and services at the best value for the City.
- 2.0 **Questions and Inquires** -Bidder's desiring further information or interpretation must request such information in the questions section of Vendor Registry.

- 4.0 <u>Information Clarification</u> All questions shall be asked through Vendor Registry. Should a Bidder discover a discrepancy or an omission in the plans or specifications, he should at once notify the Purchasing Department so that an addendum can be issued. <u>No explanation or interpretation other than an addendum issued by the City will be considered official or binding.</u>
