

CITY OF WAYCROSS REQUEST FOR PROPOSAL MOWING 3 CITY CEMETERIES FY20-09 August 6, 2019

GENERAL

The City of Waycross will be accepting sealed proposals from Lawn Care Contractors for the mowing of 3 city owned cemeteries. Proposals will be accepted until, **2:00 p.m.**, **Wednesday**, **August 28**, **2019**. Envelope must be sealed and marked Bid # FY20-09 Mowing .Proposals may be mailed to the City of Waycross Purchasing Department, PO Drawer 99 Waycross, GA 31502 or hand delivered to City of Waycross, Purchasing Department, 417 Pendleton Street. The City of Waycross does not accept late, faxed or emailed bids.

There will be a mandatory pre-bid meeting at Oakland Cemetery Offices located off Alice Street at 9:00 a.m., Monday, August 19, 2019 to familiarize yourself with the scope of work to be completed.

SCOPE OF WORK TO BE DONE AT EACH LOCATION

Oakland Cemetery – Plant Avenue – Approximately 47 acres. Mowed 2 time during the month. Weed eat around each grave space and head stones.

Lott Cemetery - Tebeau Street – Approximately 5 acres Mowed 2 times each month Weed eat around each grave space and head stones.

Hazzard Hill Cemetery – Central Avenue – Approximately 17 acres Mowed 2 time each month/ Weed eat around each grave space and head stones.

STANDARD INSTRUCTIONS:

- 1. Upon award Certificate of Insurances and Workers Comp Insurance forms must be submitted. Contractor will be held responsible for any damage done to grave sites.
- 2. Completed E-Verify to be submitted with proposal
- **3.** Include 5 business references that you have completed similar work with. Include names and phone numbers.
- 4. Brief synopsis of your business; number of years in business, number of employee, list of equipment that you will be using.
- **5.** Request for Quote sheet has been included and must be completed and returned with bid. Pricing shall be for 1 complete mowing/weed eating of each location.
- **6.** Mowing is required between the months of April November (may fluctuate due to weather) on an as needed basis.
- 7. The time period of this contract shall be September 2019 November 2020.
