2. Question: Can the City confirm if they have an approved budget and what the approved budget amount is?

Answer: The City team is currently in the process of presenting the FY2024-2025 budget to the City Council. Final budget approval will not take place until June 18, 2024. \$350,000 has been requested in the FY2024-2025 budget, subject to Council approval.

Answer: Yes

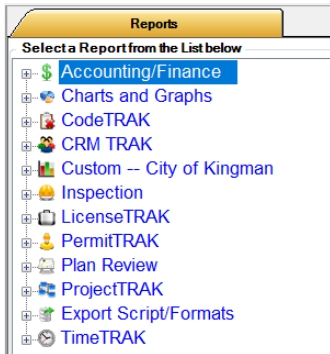
9. Question: How many documents and what is the total storage size of document in OpenText that require migration to a new document management solution?

Answer: The current software currently has 305 standard and custom reports. The City may not need as many reports with a new system, depending on what information the standard reports offer; many of the current Trakit reports are custom.



11. Question: The RFP asks for integration with BlueBeam, but also in requirement #7 identifies the need for "such as BlueBeam or similar". Does the City have a preference for continuing use of BlueBeam integrated with the new solution or are you open to a new solution?

Answer: While integration is always preferred, it is not required for BlueBeam. The City prefers to continue using BlueBeam and is not seeking to replace that product at this time.
