# RESPONSES TO PROPOSER QUESTIONS

**16. Question: How many mobile users (licensed, not public) will access the system, usually this is your inspectors.**

Answer: For mobile only users (not including all primary licensed users) we estimate we will need a minimum of 14 users.

**17. Question: P. 13, question 28 refers to unlimited custom reports. Is this referring to training so you can use the system to run unlimited custom reports or are you asking us to create an unlimited amount of custom reports every year? Do you currently have a list of reports that you'd like or a reporting system that you use now?**

Answer: This refers to the system having the ability to create unlimited custom reports as well as providing training on how to run custom reports. It also refers to providing ongoing support when City staff encounters issues with creating reports. We currently have 305 reports but we do not foresee needing all of them. We will compile and provide a list of required reports to the selected proposer upon project kick-off.

**18. Question: All historical data including information must be migrated to the new system as part of implementation. A SQL backup (.bak file) will be provided from the existing database.**

- **How many tables are included in the SQL database?**

Answer: 459 tables

Answer: No, we currently use Crystal Reports.

**21. Question: Land management system capable of interfacing with GIS and/or the County Assessor's office. The land management system must be able to manage/track the following:**

- **How often is the City GIS updated from the County Assessor's office data? Ownership information etc.**
- **Are there forms that you would like to integrate to the County Assessor's GIS vs the City owned instance? And vice versa? Where some forms won't need to be connected to the County but affirmative to the City?**

Answer:

- Updated weekly – manual download – working on a script which will enable increasing that.
- We download what we need from the County to our city GIS and republish our services to our software. As to Forms, there should be none that would need to go to the County.

**22. Question: Describe the interface, if any, between the proposed system and Email.**

- **Is the city in a MS 365 environment?**

Answer: No, we currently use MS Office 2019 and MS Exchange 2010.

**23. Question: How many reports does the City anticipate needing?**

**Answer: The current software currently has 305 standard and custom reports. The City may not need as many reports with a new system, depending on what information the standard reports offer; many of the current Trakit reports are custom.**
