AGRI-CIVIC CENTER WETLAND NUMBER 3 FILL PAD INVITATION TO BID

Sealed BIDS will be received by Okeechobee County Board of County Commissioners at the <u>Okeechobee County Historic Courthouse</u>, 304 NW 2nd Street, Room 123, Okeechobee, FL 34972 until 3:00 p.m. on <u>March 17</u>, 2017. They will be publicly opened by the County Clerk or designee and read aloud. Any BIDS received after the time specified will not be accepted.

The BIDS shall include but not be limited to: The removal of organics, preparation and filling of the designated area within wetland number 3 at the Okeechobee County Agri-Civic Center.

The northeast portion of wetland 3 has been permitted by the South Florida Water Management District (SFWMD) to be filled. The SFWMD permit will be provided for posting to the successful bidder prior to work being initiated. The County has surveyed and installed field stakes identifying the proposed area of fill. A map is attached showing the limits of fill within the wetland. See Invitation to Bid Form for complete bid requirements.

Each Contractor who has made a written request, to the physical or e-mail address noted above, will be furnished with one (1) electronic copy in PDF Format of the Bid Documents via email at no cost. <u>Only Bid Documents obtained from the Owner are acceptable for bidding.</u>

A Pre-Bid Site Inspection will be held on March 6, 2017 only at 9:00 am at the Agri-Civic Center located at 4601 Highway 710, Okeechobee, Florida. The purpose of the pre-bid vendor inspection is to receive questions from respondents on any issues considered germane to the requirements of the project.

Each bid must be accompanied by an acceptable Bid Security in the form of a Bid Bond, or Certified Check, made payable to "Okeechobee County Board of County Commissioners", in the amount of not less than five percent (5%) of the total Bid Amount as a guarantee that the Bidder, if awarded the Contract, will execute and file acceptable performance and payment bonds equal to 100% of the contract price and acceptable Insurance per requirements list in Bid Documents within ten (10) calendar days after written notice of the award of contract. No bidder may withdraw their bid for a period of ninety (90) days after the date set for opening of bids.

If the Contract Sum is more than \$100,000, the Contractor shall furnish a Performance Bond on Standard Form 25 in an amount equal to one hundred percent (100%) of the Contract Sum as security for the faithful performance of this Contract. If the Contract amount is increased, the Owner may require a corresponding increase in the amount of the bond. The Owner may also secure additional protection by directing the Contractor to add a penal amount to the existing bond or to obtain an additional bond.

The Contractor shall furnish a Payment Bond on Standard Form 25-A in amount equal to one hundred percent (100%) of the Contract sum.

Okeechobee County accepts no responsibility for any expense related to preparation or delivery of proposals. The Owner reserves the right to reject any or all Bids accept Bids in any order or combination, accept or reject portions of Bids, make modifications to the work after bidding, and waive any formality in the Bids if they deem it in their best interest to do so.

The Bidder will provide additional information including, but not limited to, a list of similar projects constructed within the past five (5) years, client references and an audited or certified financial statement, or other financial references deemed appropriate to Contract Award.

Unless specifically prohibited by law or regulation, said bid includes an assignability clause that allows for the assignment of all or part of the specified deliverable items.

Okeechobee County has a local vendor preference which is contained within the County's current procurement policy. Definitions, allowances and exemptions can be found in this policy. You are encouraged to review the latest version to ensure compliance with and exceptions to the local vendor preference policy. The County's vendor preference policy can be found on the County's web site at http://www.co.okeechobee.fl.us/government under the heading "County Procurement Policy."

Bidders will confine their bids to the project in its entirety. Partial bids will not be accepted.

Each bidder will submit with this bid evidence that the bidder is licensed to perform the work and services or qualified by examination to be so licensed. Bidder will also provide proof of Insurance as required by the County and shown in the Bid Documents.

If in the opinion of the bidder, inconsistencies appear to exist in the specifications, it is the bidder's responsibility to seek clarification from Okeechobee County Capital Improvements. Additionally, it is incumbent upon all bidders to conduct a personal investigation as to requirements of the County.

The Board of County Commissioners has the right to accept or reject any or all bids. Bids must be sealed and the outside of the envelope MUST be marked: "BID – OKEECHOBEE AGRI-CIVIC CENTER WETLAND NUMBER 3 FILL PAD - COUNTY PROJECT NO. 2017-07.
