#### **Clarification of Contract Documents & Specifications:**

The following are responses to questions received from potential bidders:

#### Questions

Question #1: Will you be adding Special Provision 109B "Asphalt Adjustment" to the project proposal?

Response: No.

Question #2: Does the City of Knoxville want Trackless Tack (Blacklidge) as required in most City Contacts?

<u>Response:</u> The pay item for tack coat has been changed on the attached bid form to Item No. 403-02.01, Trackless Tack Coat. While the City specifies TTT-1 for its resurfacing contract, any approved emulsified trackless tack from TDOT's QPL (Qualified Products List) will be accepted for this project.

Question #3: Regarding the short fence on top of the Standard Concrete Classic Parapet Rail; this material is not covered by the TDOT Standard Drawing STD-11-2. Please provide specifications and details for the short fence.

<u>Response:</u> Per Addendum 2: The type of rail will be the type of rail in the TDOT standard drawing S-BRP-1 Bike/Pedestrian Safety Rail. It will be paid for under the cost of item number 620-05.02 as footnoted on Sheet 2. The rail shall be powder coated black.
