“E” Street Right-of-Way Landscaping Solicitation

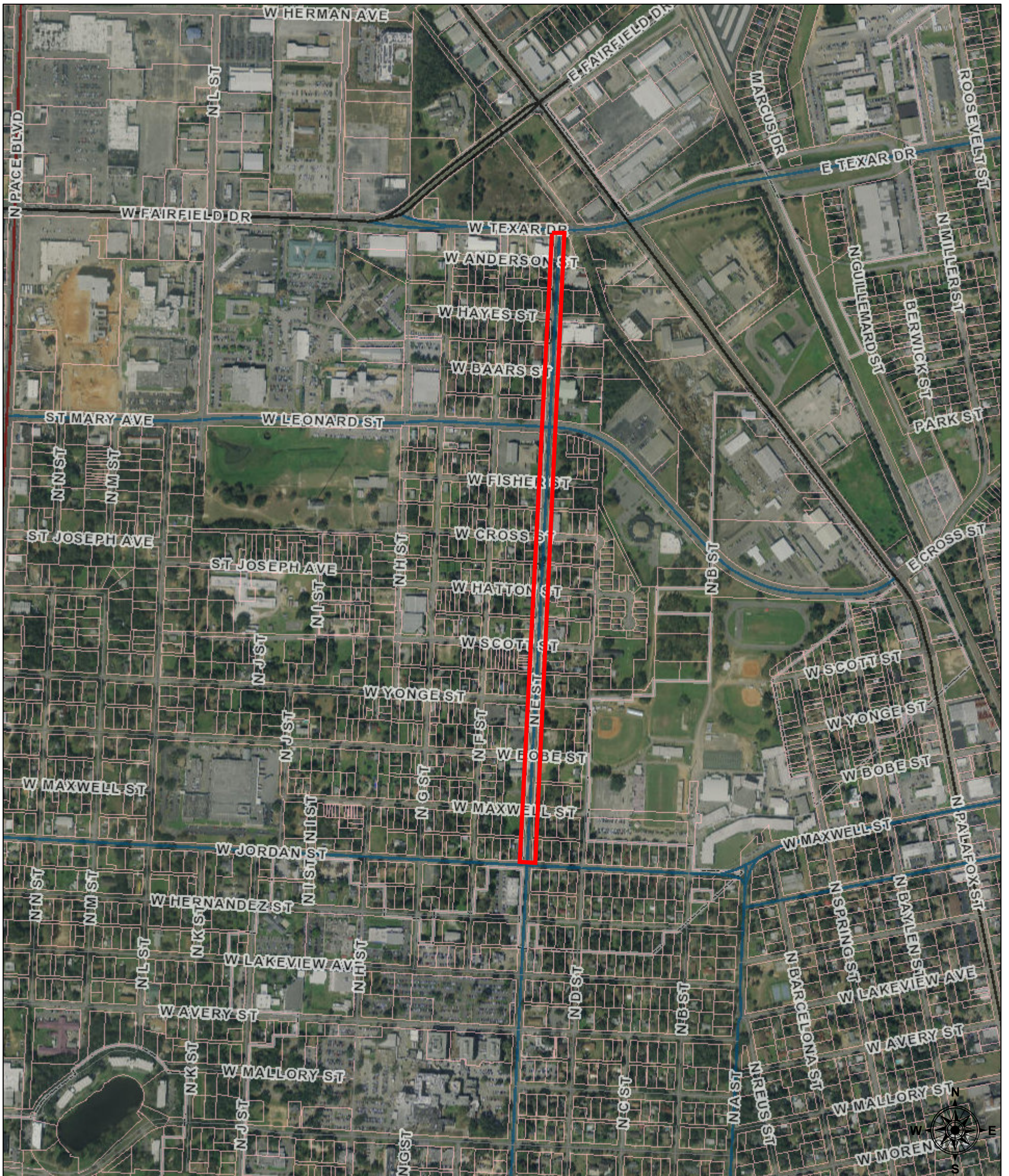
Escambia County (the County) is seeking solicitations for landscaping work to be done in the right-of-way (ROW) on a portion of “E” street, starting at the intersection of E street and Texar Drive and continuing South on E street to the intersection of E street and Jordan street (see attached map). The County is seeking quotes to establish a grass type ground cover within each landscaped ROW adjacent to E street on both east and west sides of the street. Contractor must be insured and meet *Escambia County contractor insurance requirements*. Must be prepared to provide local references of similar work. For all questions, please contact Escambia County Project Manager Megan Polk, 850-595-1829. Deadline for quote submittal is **5:00 P.M. Tuesday, January 18, 2022**. The County reserves the right to reject any and/or all bids.

- Provide quote with your company letterhead:
 - **Include quote for Centipede grass**
 - **Include quote for Pensacola Bahia grass**
- All areas to be grassed (**Texar Drive to Jordan Street**)
 - West Side of E Street (pervious area) **≈ 13,000 sq. ft. (approx.)**
average width **≈ 4.5 - 5 feet**
 - East Side of E Street (pervious area) **≈ 21,060 sq. ft. (approx.)**
average width **≈ 9 feet**
 - **Total Square Feet : 34,060 sq.ft (approx.)**
- Areas need to be tilled to accept sod
- Remove landscape cloth/weed barrier
- Trees and shrubs to remain
- Contractor to provide water truck for 4 weeks
 - Include price for add-on for additional weeks if needed
- Contractor will coordinate temporary traffic control
- Establishment Period: **Spring (March) 2022**

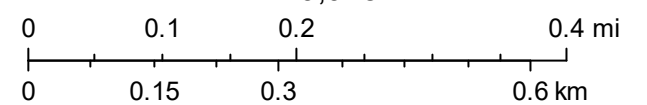
If your firm/company is awarded the bid, the following items must be submitted within five business days in order to issue a Purchase Order:

- Current W9 (less than one year old)
- Worker’s Compensation as required by State Law OR exemption form. (\$1,000,000 coverage)
- Professional Liability (\$1,000,000 coverage)
- Automobile Liability (\$1,000,000 coverage), listing Escambia County as Certificate Holder and additional insured.
 - Auto Liability Certificates must state the following under the Additional Interest:
